pality, four candidates are contesting for the post of mayor, 16 for women councillor and 37 for ward coun-

cillor. The number of voters in the municipality is 27,644.

On Saturday evening, BNP's acting Secretary General Mirza Fakhrul Islam Alamgir addressed a roadside meeting at Pashchim crossroad point in Gobindaganj municipality and sought votes for the BNP nominated mayoral

aspirant.

Townspeople demand capital punishment of killers

Townspeople formed a human chain near Kurigram Central Shaheed Minar and brought out a procession yesterday, demanding capital punishment to the killers of school student Alif Ahmed Swapan.

Later, they submitted memoranda to the deputy commissioner and the superintendent of police, Kurigram.

Son of Sultan Ahmed of Sardar Para in Kurigram town, Alif Ahmed Swapan, 14, was a Class VIII student of Kurigram Collectorate School and College.

Police recovered his decomposed body on Thursday evening from a septic tank in one Morsheda Begum's house at Hanagarh Para in the town. She is a senior staff nurse of Kurigram Sadar Hospital.

Police and locals said Alif and Rifat, son of Morsheda Begum and a student of Kurigram River View High

At around 10:00am on Monday, Alif told his mother that he was going to Rifat's house, and had been

missing since then.

Police and local sources said, nobody was in the church when the incident took place. Subash Daring, a Garo

resident of Fulcherra area, said around 2:00am, they woke up and found the church burning. Later they tried to douse the blaze. Local Christian people

use the semi-pucca tinroofed church house for prayers only on Sunday and on other days they use it as

school for children. The fire gutted all furni-

ture and other valuables of the church, said Mahbubur Rahman, officer-in-charge of Srimangal Police Station. Police are investigating the matter, said the OC.

He claimed that the loss caused by the fire could go

up to Tk 3 lakh. Bishop Bejoy N. D' Cruze OMI, head of the Sylhet Diocese in the Sylhet

Division, who also received death threat on December 22 along with father Subrata, said it could be done by the groups who threatened them. Police said the fire seems to have originated from an

electric short circuit of the solar panel.

But Bishop Cruze said,

around six hundred people in that area are using solar power and such accident never happened before.

"So I doubt it was an act of sabotage," he said. On December 22 Bishop
