The Counter Terrorism and Transnational Crime unit is expected to start work next month, as the government has already completed all formalities regarding its forma-

Police officials working on militancy and counter terrorism in the DMP and the Detective Branch (DB) of police in particular would be incorporated into the unit.

"The unit will work to combat cyber crimes, terror financing and mobile banking related crimes," Monirul Islam, joint commissioner of DB, told The Daily Star yesterday.

Members from Special Weapons And Tactics (SWAT), bomb disposal unit, and the dog squad would also be included in the unit to be led by a police official with the rank of a deputy inspector general (DIG).

The unit would also have an additional DIG, four deputy commissioners, 10 additional deputy commissioners, and 20 assistant commissioners.

The rest would be inspectors, subinspectors, assistant sub-inspectors and constables.

Atigur Rahman, DIG at the police

headquarters, said they had gotten 7,000 newly recruited policemen for the DMP and the unit would be manned by some of the new police-

The unit would collect information and data on militants and transnational criminals at home and abroad, monitor their activities, and arrest them, police sources said.

They said officials with specialties and foreign training on counter-

terrorism would be posted in the unit "We'll ask the authorities not to transfer officials with specialties in counter-terrorism elsewhere, and that they be allowed to work in the unit at least for three to five years," Monirul

transplantation, an effective but experimental diabetes treatment.

Using the technique pancreatic islets - clusters of insulin-producing cells from the pancreas - are injected into a recipient's liver.

Ahead of the operation the cells are kept frozen to preserve them, but the freezing process can damage the cells because it produces sharp ice crystals.

Now researchers from the Okinawa Institute of Technology and Science Graduate University (OIST) are suggesting using a hydrogel capsule made with alginate, a natural polymer extracted from seaweed, to avoid potential cell damage during freezing.

The capsule's structure includes non-freezable bound water which protects the cells from ice damage.

Further, the technique could reduce the risk of the transplanted tissue being rejected by the host as the capsule membrane prevents direct contact with the host's cells, while still allowing small molecules to pass across it.

The project is being led by Professor Amy Shen, and working in collaboration with the University of Washington and Wuhan University of Technology.

It said prejudice to or interference with the due course of any judicial proceeding, interference or obstruction of the administration of justice in any other manner, interference with the court's officers, parties and witnesses, abuse of process of the court and disobedience of an order of the court are among the categories of contempt of court.

"The first category is scandalising the court or a judge. The second is the interference with the administration of justice. The third is disobedience of an order of the court," said the SC.

"Another category is writings which are calculated to obstruct or interfere with the due course of justice which is also contempt. Any insinuation to a judge which undermines the authority of the court is another type of contempt," the top court said in the 182page judgment.

"Another type of contempt is scurrilous abuse of a judge or court or attacks on the personal character of a judge," it said.

About sanction of law with regard to curtailing of the freedom of the press, the SC said, "The law must fall squarely within one or more heads of restrictions specified in article 39 namely, (a) security of the state, (b) friendly relations with foreign states, (c) public order, (d) decency or morality, (e) contempt of court, and (f) defamation or incitement to an offence.

In Kuakata municipality of Patuakhali, some 20 to 25 Jubo League men snatched ballot papers and seals, stamped and stuffed those in favour of AL candidate Abdul Barek Mollah at Panchupara Government Primary School polling station around 9:30am, witnesses said.

"I had nothing to do. I was a victim of the situation," said Presiding Officer Morshed Alam.

On duty policemen did not take any action, witnesses added.

As supporters of BNP mayor candidate tried to prevent the Jubo League men from stuffing ballot papers, a chase and counter-chase took place between them.

Police fired 25 shots in the air to

bring the situation under control.

The conflict has forced more than four million people to flee the country, but until this year, an overwhelming majority of them were spread among Syria's neighbours.

While Jordan, Lebanon and Turkey continue to host massive numbers of Syrians displaced by war, the UN figures show that beginning in the spring increasingly large numbers of Syrians resolved to reach Europe.

In June, more than 50,000 people crossed the sea, a number that shot up to over 150,000 by September, culminating in a record 218,000 crossings in October.

After Syrians, Afghans were the second largest group at 21 percent of arrivals this year, followed by Iraqis at eight percent and Eritreans at four.

Other migrants originated in Pakistan, Nigeria, Somalia, Sudan, Gambia and Mali, but in relatively small numbers. The UN has warned that there may be

especially if efforts to end the conflict in Syria continue to falter. Meanwhile, rising anti-migrant

rhetoric continues in parts of Europe, with Czech President Milos Zeman called the current wave of refugees "an organised invasion" in remarks at the weekend.
