## 2 Jamuna Group firms accused of forgery

The National Board of Revenue (NBR) has filed cases against two firms associated with Jamuna Group for forgery, according to a press release.

The firms are Amcaba Ltd and Jara

Accessories Industries Ltd, said the NBR in a press statement signed by Senior Information Officer Syed A Momen. The Customs Bond

Commissionerate Dhaka filed the cases with Ramna police on December 31.

The revenue authority's move came after it had filed a General Diary (GD) with the same police station against Jamuna Group Chairman Nurul Islam Babul and Helal Uddin, senior reporter of the daily Jugantor, the newspaper owned by the group, on allegation of publishing "false and fabricated" reports on the NBR chief.

In the GD filed in early December, revenue related anomalies of various firms associated with Jamuna Group were mentioned, said the press release.

The NBR said these two firms submitted fake Proceed Realisation Certificates (PRCs) as proof of shipments of products, raw materials, which were imported duty-free under bonded warehouse privilege.

The NBR said it had found the anomalies as part of its efforts to curb duty evasion and find sources with higher revenue potentials.

The owner of the two firms is the daughter-in-law of Jamuna Group's Chairman Md Nurul Islam, according to NBR.

It said Jamuna Group's sister concern Amcaba Ltd had earlier submitted a Tk-31.54 crore worth PRC on a pad of Bangladesh Commerce Bank. During examinations, the bank informed in writing that the PRC was

The NBR said the owner of Amcaba was the managing director of Dada Trading, another sister concern of Jamuna Group. Another director of Dada Trading is Shariat Tasreen, the release said, adding that Shariat is the daughter of Nurul Islam.

The release further said Amcaba Ltd's owner Sheikh Abdul Wadud is his daughter-in-law.

The NBR also said the Customs Bond Commissionerate filed a First Information Report against Jara Accessories and Amcaba Ltd for forgery under the Customs Act, Special Powers Act and Money Laundering Act with Ramna police.

Contacted, Masiur Rahman, officer-in-charge of Ramna police, said NBR had filed regular cases.

"We have forwarded the cases to the Anti-Corruption Commission because of their connection to corruption and forgery," he added.

The article focused on the murders of some Bangali bloggers who supported gender equality, human rights

and civil liberty. At the heart of the piece is online activist Asif Mohiuddin, who had to flee Bangladesh after his freethinking,

atheist views and secular blogging put him in severe danger. He was brutally attacked outside

the IT company building he worked at, with an eight-inch kitchen knife that missed his spinal cord by half a centimetre.

The article also revealed that a

dozen young madrasa students, who were involved in the attack on Mohiuddin and other secular bloggers, openly admitted to their crimes and divulged information on an extremist group whose specific intent was to murder secular bloggers.

Niloy Nil, another blogger, was killed in August by a machete-wielding gang who broke into his apartment in the country's capital city.

At least four other bloggers have been killed in the country last year for writing critically about Islamist militancy.

# Afghan forces free 59 prisoners from Taliban jail in south

AFP, Kabul

Afghan special forces freed 59 prisoners from a Taliban jail in Helmand, officials said on Saturday, as government troops redouble their efforts to drive back the insurgents who have seized large parts of the volatile southern province.

Islamist militants have launched a series of attacks in the capital, Kabul, in recent weeks and a tough fight is underway in key districts in the south, just as attempts have been made to revive a stalled peace process.

Afghan Defence Ministry spokesman Dawlat Waziri said 37 of the captives freed from the jail, which was just to the north of the Helmand provincial capital of Lashkar Gah, were soldiers. Another seven were policemen and the rest civilians. The operation to free the prisoners

the Taliban has seized several district centres in Helmand, a major centre of opium cultivation and one of its traditional strongholds. Waziri dismissed suggestions that Helmand could fall to the Taliban entirely but said government forces

followed months of fighting in which

faced a serious battle against insurgents who have grown in strength since foreign troops ended most combat operations a year ago. "We have to accept that there is a

fight going on in Afghanistan," he told reporters in Kabul.

The Helmand operation unfolded late on Friday night, just as a Taliban suicide bomber attacked a French restaurant in Kabul popular with foreigners and government officials, killing two people and wounding 18.

The Taliban claimed in a statement that "dozens of foreigners" had been killed or wounded, although the Islamist group often exaggerates casualty figures in attacks on foreign or government targets. That attack, and an all-night battle

at a Spanish embassy guest house in Kabul last month, highlighted the Taliban's strategy of seeking highprofile targets in the capital while at the same time stepping up its campaign to seize district centres in provinces such as Helmand.

### Belgium releases three held over New Year attack plot

Belgian investigators released three people on Friday after questioning them over an alleged plot to attack the capital on New Year's Eve which forced the cancellation of the city's annual fireworks display.

Police had detained six people after searches at seven locations in and near Brussels on Thursday. They also seized computers, mobile phones and equipment for airsoft, a sport like paintball using guns that shoot plastic pellets.

Authorities believe some militants practise airsoft in secluded areas as training for potential attacks.

Three of the six were released later on Thursday. Prosecutors had requested that the other three be held for a further 24 hours. The prosecutors office said on Friday that these remaining three had also been released after questioning. In the same investigation, two

Belgian nationals detained earlier this week and named as 30-year-old Said S. and 27-year-old Mohammed K., are being held on suspicion of planning a terrorist attack, prosecutors said. A court on Thursday extended their custody for a month.

Both are members of the Kamikaze Riders, a Brussels-based group that carries out motor bike stunts which can be seen in online videos. Most of the

that it appointed Synerflux Sdn Bhd, which will be the "sole and exclusive entity" to develop, maintain and manage a fully online system known as Bangladeshi Workers Management System (BWMS). The company will have offices both

in Bangladesh and Malaysia, and supervise workers' registration and eligibility, and delivery of visas. Synerflux Sdn Bhd, which is owned by former Malaysian home minister

Azmi Khalid and Bangladesh-origin Malaysian resident Aminul Islam, came under criticism after the news broke. Bangladesh Association of International Recruiting Agencies (Baira), which has been opposing the

appointment of Synerflux, requested

the government not to allow the Malaysian company. "The appointment of Synerflux is part of a syndicate that will control and monopolise labour recruitment and breed irregularities in the market. So, we requested the government not to allow the company," Baira President Muhammad Abul Basher told The

Daily Star recently. The issue of labour recruitment in Malaysia is very important as labour relations between the two countries have always been marred with corruption and exploitation.

Following reports of abuse in 2007-08, Kuala Lumpur had halted recruitment in early 2009. In late 2012, it began a state-level recruitment, but since then only about 10,000 have been recruited in plantation sector in Malaysia, home to some 6,00,000 Bangladeshis.

Industry insiders said powerful syndicates made sure that the G2G

(government to government) recruitment system failed.

In June last year, Malaysia declared it would go for recruitment through private agencies and allow employments in all sectors -- constructions,

industries, services and plantations. Since then, controversial Malaysian companies -- Bestinet and Real Time Networking -- lobbied Bangladesh and Malaysian governments to get the job of online recruitment of Bangladeshi workers. Both the companies are linked to Malaysian ruling party leaders, according to sources there.

Real Time Networking that was shortlisted earlier, Malaysian government selected Synerflux. The draft MoU was supposed to be approved by Bangladesh cabinet on

November 9, but was deferred follow-

ing requests by Malaysia. Malaysia then proposed that Synerflux would oversee the recruitment process. The labour wing of Bangladesh mission recommended ensuring an equal role of the two governments for selecting agencies, setting one-year limit for each agent in labour recruit-

forming a joint monitoring team on labour recruitment. Contacted, Expatriates' Welfare Minister Nurul Islam said they would discuss the matter with the Malaysian government before signing the MoU.

The BNP last year planned to stage a "black-flag" rally in front of its Nayapaltan central office on January 5. However, it could not hold the programme as law enforcement agencies confined its chief Khaleda at her Gulshan office since January 3 and locked the Nayapaltan office. On the future plan of BNP, a central

leader of the party said, "Before the municipality polls, we actually had started from zero. Now we got back our strength and we want to make best use out of the situation to reorganise the party and force the government to hold an early election."
