NBR sets BCB deadline

The National Board of Revenue (NBR) has asked the Bangladesh Cricket Board (BCB) to take necessary measures to ensure that the taxes on payment of

foreign players in the Bangladesh Premier League (BPL) are paid by January 11.

The tax authority's directive came through a third letter sent to the BCB chief executive officer last week. The letter was sent after the BCB reportedly didn't respond to the NBR's previous requests to help the taxmen realise taxes on payment of around sixty foreign individuals, including both cricketers and

coaches, who took part in the third edition of the BPL in favour of six franchises. According to the officials, NBR first sent a letter to

BCB on November 22 last year, day after the inauguration of the tournament, seeking the game's governing body's cooperation to get copies of contracts and as well as other relevant documents regarding the foreign players. The taxmen also sought details on payable money and other expenses of the tournament.

As the NBR did not get any response from the BCB, they sent a second letter on December 3, asking the cricket authority to deduct 30 percent taxes on the security money deposited by the six franchises prior to the start of the tournament.

When contacted, NBR chairman Md Nojibur Rahman said: "We expect their cooperation. It is their national responsibility to help mobilise

revenue for the state. The tax that is due must be collected and we want their support in this regard. We hope there won't be any issues regarding the revenue collection."

A special team was also formed by NBR in this regard. Sources said that NBR has so far received only Tk 40 lakh as income tax from payment to artists who performed in the BPL's inauguration ceremony.

Besides the tax issue, questions were also raised regarding the payment procedure followed by the franchises for the overseas players. According to a senior official, the Bangladesh Bank (BB) has so far given permission to pay nearly 2.5 lakh dollars to nine overseas players of two franchises.

However, BCB president Nazmul Hasan Papon prior to the end of the BPL had claimed that a majority of the payments of the foreign players were already completed.

Upon being questioned with regards to the latest developments, Papon said that the board will look into the matter.

"Tax must be paid. I was abroad for the last few days, so at first I have to check everything. That's also a reason why I am not aware that such issues have been talked about in the media. If there is a tax issue, it will be solved.

"It's the duty of the franchises to do everything in line with the country's law but as we are the hosts of the tournament we should look into the matter. It was a fantastic tournament and there's no way that we will allow its image to get tarnished," Papon told the Daily Star over phone last night.

The BPL's third edition ended on December 15.

Maruful tones down expectations

stated that his only target was to win the SAFF title before eventually bemoaning the 'lack of ability' of the players, said that people should base their expectations according to the ability of the team.

"We went to the SAFF with a big target but finished nowhere near that target. You have to build your expectations as per as the ability of the players. We have to realise our ability first," Maruful said during a practice session at the BUET Ground in the morning before the contingent flew to Jessore in the afternoon.

The Bangladesh team returned from Trivandrum in two phases on December 31 and January 1, and were allowed leave till yesterday morning. The team is supposed to undergo a few more practice sessions in Jessore over the next three days before taking on Sri Lanka in the opening fixture of the eight-team tournament on Friday.

Maruful said he would only be Personally I would like to overcome Mamunul Islam, who had stated his able to earmark a specific target after running at least a couple of sessions more, but nevertheless felt that since the team will be playing at home, they should ideally reach the final like the last edition.

"There are still some mental and physical barriers at the moment, which I hope the players can overcome in the next two days.

Cricketers meet BCB boss over DPL

A number of Bangladesh national cricketers, including Mashrafe Bin Mortaza and Mushfiqur Rahim, had an unofficial meeting with BCB president Nazmul Hassan Papon yesterday in which issues regarding the players' transfer of the upcoming Dhaka Premier League (DPL) and the cricketers' national contracts were discussed.

The DPL, Bangladesh's premier 50-over domestic contest, is scheduled to begin on March 24 and the BCB is likely to employ the 'player-by-choice' method for the players' transfer. It's a method that a number of national players and List-A cricketers are reportedly aren't happy about.

Traditionally, the DPL allowed for negotiations between clubs and cricketers and players always had the opportunity to select their desired club. However, as per the player-by-choice system, the cricketers will be assigned a fixed price and each of the players on a rotating basis.

Speaking to The Daily Star yesterday, Papon said that the board will try to find an amicable way to settle the issue.

"The CCDM (the organising committee of the DPL) did propose the player-bychoice system for the DPL and we will discuss the pros and cons of the system in the next board meeting.

"The main worry of the players is that series into a T20I one.

they might get signed up by a club in which they may not get the required cricketing practice, since the level of competition differs from one club to the other. But we also have to understand is that the system ensures a good amount of money for a majority of the cricketers, even though the income of a few leading cricketers does go on to decrease a bit," said Papon.

"I have asked the players to provide me with their opinions and we will discuss this in the board meeting," he added.

The board meeting is also set to offer new contracts to the national players and Papon said that there was an 'informal discussion' regarding that issue yesterday. The BCB's cricket operations committee, a few days ago, had in fact recommended the board to increase the salaries of the national players.

HC stays fine on Arambagh

The High Court yesterday stayed a decision of the Bangladesh Football Federation (BFF) imposing Tk 30 lakh monetary fine on Arambagh Krira Sangha for three months. The court also issued a rule upon the BFF to explain within two weeks as to why its decision should not be declared illegal.

The HC bench of Justice Zubayer Rahman Chowdhury and Justice Mohammad Khashruzzaman came up with the order and rule after hearing a writ petition filed by Azaz Md Jahangir, general secretary of Arambagh Krira Sangha, challenging the BFF decision.

Petitioner's lawyer AKM Nurul Alam told The Daily Star that during a Bangladesh Championship match between Arambagh and Police AC at Birshrestha Shaheed Mostafa Kamal Stadium in Kamalapur on December 22, some

outsiders vandalised the BFF office. In the letter issued on December

31, the BFF ordered the club to pay the fine by January 5, or else, the club would be suspended for one year, the letter warned, he said. Nurul Alam also said his client

filed the writ petition as the club was not responsible for vandalism. The club has not yet paid the money to BFF.

The HC's stay order, however, means that Arambagh will be eligible to play against Youngmen's Fakirerpul Club today.

BFF tight-lipped on transgression

A day after 12 players of the Bangladesh national football team took part in an 'unauthorised match,' the team flew to Jessore for the Bangabandhu Gold Cup with 'blessings' from the high-ups of the game's governing body.

The players were in a relaxed mood during the day as they underwent a practice session at the BUET Ground under head coach Maruful Haque. Later the players and the coaching staff held a meeting with the executive committee members of the Bangladesh Football Federation (BFF) including its president Kazi Salahuddin.

It has been learnt that the BFF boss told the team to forget about the past and give their best at the Bangabandhu Gold Cup, which would provide them with the right platform to regain their confidence.

However, it has been learnt that the issue of the players turning up for a match for hire in Narayanganj, which projected their moral decay as well as an utter disregard towards the guidelines set for a professional footballer, was not raised in the meeting.

The BFF high-ups were tight-lipped about the incident as they were more concerned about rebuilding the shattered image of the team through a good performance in the Bangabandhu Gold Cup.

It has been learnt from an insider that the incident, which took place a day after the 23 players were officially called up for camp, will be discussed after a while.

It may be mentioned here that due to a similar offence, national team forwards Mithun Chowdhury and Zahid Hasan Emily, both of whom participated in Sunday's match, were handed domestic bans in 2011. Meanwhile, attacking midfielder Hemanta Vincent Biswas, who was also among the 12 national team players playing in Sunday's match, was handed a suspended sentence of one year for a similar transgression in October last year, with the sentence stating that a similar offence within six months would see him being suspended from all football activities for one year.

Changes in BCCI proposed

A panel appointed by India's Supreme Court on Monday proposed sweeping changes to the country's scandal-hit cricket board and said gambling should be made legal.

The panel headed by former chief justice Rajendra Mal Lodha was appointed after a string of corruption scandals at the Board of Control for Cricket in India (BCCI).

Its report, seen by AFP, recommends barring politicians from the sport's governing body and introducing

time limits on holding office. It also suggests legalising betting after the popular Twenty20 tournament run by the BCCI, the Indian Premier League (IPL), was rocked by allegations of corruption, match-fixing and crooked umpires.

The recommendations would bar ministers and government officials as well as anyone over 70 from holding office and would impose a three-year maximum term.

The panel also suggests a separate executive body for the IPL and the appointment of an independent ombuds-
