Do not agitate halting classes

PM asks public university teachers, criticises them for indefinite strike over 'pay disparity'

Prime Minister Sheikh Hasina yesterday criticised public university teachers for going on an indefinite work stoppage and asked them not to wage a movement at the expense of students' education.

"Dignity cannot be achieved through halting classes and examinations of students. Such a move does not go with teachers," she said.

"Students will not accept it if you continue protests against the new pay scale, boycotting classes ... You have to keep education at public universities operational," she said.


Stressing the high status of teachers, she said, "If there is a problem, we will look into it."

Hasina, also chief of the ruling Awami League, was addressing a rally at Suhrawardy Udyan in the capital, marking Bangabandhu's Homecoming Day. She also expressed her disappointment about the teachers' demand for

the same status as secretaries. "If you want status equal to secretaries, just resign and become a secretary

by sitting examinations through the PSC. Then there will be no problem," she pointed out.

Jurists ponder what to do

The chief justice's remark that the country's executive branch wants to take away all power from the judiciary has left senior jurists pondering what they should do now.

Chief Justice Surendra Kumar Sinha made the comment while inaugurating a week-long book fair on the premises of Supreme Court Bar Association on Saturday.

He said lawyers became vocal whenever such things happened previously. "Now if the judiciary faces attacks from all quarters -- lawyers, the executive branch and justice-seekers -- who will protect it?" he questioned.

87pc households use mobile

BBS survey finds 3.14cr households own at least one cellphone but only 4.8pc use internet

More than 87 percent households in Bangladesh own mobile phones, indicating the rapid expansion of digital connectivity the present government has brought forth, according to a government survey.

Besides, 3.14 crore households have at least one mobile phone, shows the survey conducted in 2013 and published last week by Bangladesh Bureau of Statistics.

It also says 4.8 percent households

have access to internet.

This is for the first time a government agency has done such a survey. The BBS findings on internet access

have drawn the ire of experts and policymakers, who say the data don't reflect the reality given the digital transformation that took place in the country in the last two years.

They say the 2013 data are outdated for sectors such as information communication and telecommunication services.

The massive survey, involving a

sample of 36,268 households with 130,714 individuals aged above five, found that only 5.6 percent households have computers.

The survey, "ICT Use and Access by Individuals and Households in Bangladesh 2013", says 13.9 percent households have radio and 3.1 percent house units have landline phone connections.

According to the study, 94.1 percent households in urban areas and 85.2 percent in rural areas are connected

For 91 days from January 5 to April 5 last year, there was hardly a single day when innocent people were not burnt to death or injured in arson attacks on public transports. Some lost their loved ones, others their lone bread earners during the longest spell of horror allegedly carried out by the BNP-led coalition, protesting the January 5, 2014, elections. At least 95 people were killed and about 1,500 injured. Most of them were ordinary citizens. Another 45 got killed in "shootouts" with law enforcers.

One year on, the overall picture has changed but the ordeals of those injured and the families of those killed have not. The Daily Star visited over a dozen such families. Today's story is about how three families lost their lone bread winners in an instant.

Impossible to forget

Families of Cox's Bazar victims living on people's mercy

Hopes of better days beckoned Abu Taher's

family. The day labourer from Chakaria of Cox's Bazar sold a small piece of land, mortgaged his homestead and borrowed some money from relatives to go to Qatar. It was all for making a living for his four-member family. And Taher was all set to make it happen.

But everything changed in an instant. Taher along with two other men from Chakaria was on his way to Dhaka to catch a flight to Qatar. In the midway, their bus was firebombed by suspected blockade pickets in the wee hours of February 2 last year. All three died instantly.

The two others are Rashedul Islam Badshah and Mohammad Yusuf, who were to catch the same flight with Taher.

"All our hopes and dreams are shattered. We're sunk in heavy debts now," said Nurjahan Begum, the 32-year-old widow of Taher.
