This is the second time the government is raising the fares in four years.

Terming the hike logical, Railway Secretary Feroz Salah Uddin said train fares had not been raised timely in the past in accordance with the hikes of fuel prices and the salaries and benefits of railway employees.

"We are not thinking about making profits. Our target is to minimise the losses," he told The Daily Star, adding that they would propose the government for minimum fare hikes every year, instead of increasing it after a longgap.

Apart from reducing the losses, he claimed that the hike would also help improve services.

After about 20 years, fares of both passenger and freight were raised by 50 percent in October, 2012, to improve services and reduce railway's loss, which was Tk 800 crore a year then.

But the losses kept on piling up due to high fuel prices, mismanagement, passengers travelling without tickets, and corruption in the railway.

The losses would increase further due to recruitment of several thousand employees and the implementation of a new pay-scale for government officials and employees.

Talking to this newspaper, many passengers condemned the move.

Israt Jahan, who regularly travels between Dhaka and Chittagong, said overall train services had not improved as promised by the authorities while

hiking the fare in 2012.

She believes passengers would not get the benefit of planned fare hike unless services were improved with adequate number of modern trains and their operation on time.

Experts and some former railway officials said fare hike should not be the only way to increase revenue and that authorities should open new avenues of income. They said the railway could easily

earn a lot just by operating freight trains on different routes, especially the Dhaka-Chittagong port. This opportunity was not being availed as the railway lacked adequate lines, trains, engines, and wagons, they added.

Currently, 339 passenger trains and 30 freight trains operate on 38 routes across the country.

They suggested that the authorities stop passengers from travelling without tickets, and prevent system loss and ticket scalping.

A number of railway development projects were underway but their implementation pace was slow for which rail services did not improve, they

The railway secretary said they were buying new carriages, wagons and locomotives to improve overall services.

In the JS body meeting, the parliamentary watchdog recommended setting up a specialised university on rail communications and setting up railway engineering department in government

takes just a few minutes," said Amir Hossain, an NGO worker.

On December 29, DNCC Mayor Annisul Huq officially declared the road from Shyamoli to Aminbazar free from illegal parking. Since then, the situation has improved drastically.

Visiting the area on Sunday, this correspondent found the road almost clear. No bus, truck, or pick-ups were seen parked on the road. There were some warning signs on the road: "stopping here is completely prohib-

Long distance buses were seen inside the terminal.

However, some Manikganj-bound buses were seen stopping for a while near the underpass to take passengers.

A few city buses were also seen hurriedly dropping off and picking passengers in front of Gabtoli Bus Terminal. However, on the other side of the road, many city buses were seen waiting for passengers in a haphazard manner and competing with each other to take passengers.

Although transport leaders complied with the mayor's initiative, they on December 29 demanded separate terminals for buses and trucks.

Talking to The Daily Star, Mayor Annisul Huq said the process would take several years to implement, as the matter is still at the policymaking level.

The DNCC mayor has so far freed several areas in the capital from illegal parking. The areas are: Gabtoli-Aminbazar, Uttara-Abdullahpur, Pallabi bus stand, Tejgaon Industrial Area and Tejgaon Truck Stand, Mohammadpur, Mohakhali Bus Stand and Karwan Bazar.

However, the eviction drives were not very smooth. Annisul faced obstruction from transport workers while conducting drives. A clash between transport workers and police erupted while the mayor himself was leading a drive to free the busy road in front of Tejgaon Truck Terminal from illegal parking on November 30.

The obstructions, however, could not deter the DNCC mayor from achieving his goal of creating a better liveable Dhaka. He had successfully cleared the road from illegal parking.

To bring the metropolitan bus service under discipline and to ease commuter's suffering, Annisul said he plans to bring down the number of city bus companies to five.

In reply to a question, he said they were planning to bring 3,000 new city buses, including 1,000 airconditioned buses, soon. "These buses would operate on five routes in

37 public universities with about 12,400 teachers and 2.4 lakh students.

"We will not back away from our movement. Our movement will go on and we will continue discussions to solve the crisis," Farid Uddin told The strike on Monday, protesting the Daily Star after the meeting.

Nahid said they had an open and fruitful discussion with the teachers and that he expected a solution before long.

"We are moving towards a solution to the crisis. I hope it would be possible to solve the problem through discussions," the minister told this correspondent.

Federation Secretary General Prof ASM Maksud Kamal said the minister wanted to know the implications of removing selection grade and time scale from the 8th pay scale, and they explained those to him.

"He [the minister] wanted to know our proposals to solve the crisis. We replied that we have nothing new to say. He told us that he agreed with our demands," he said.

The federation began the indefinite "government inaction" in addressing their demand for removing the "pay disparity" with bureaucrats.

Teachers have been protesting the 8th pay scale since May last year, pressing for a four-point demand, including a separate pay scale for public university teachers.

The other demands are parity between senior professors and senior secretaries, and between professors and secretaries in salaries and allowances; upgradation of teachers' status

in the warrant of precedence, and equalisation of the provisions for cars and foreign and government scholarships and allowances between teachers and bureaucrats. Things took a turn for the worse,

without mentioning the selection grade and time scale. Frustrated, the teachers staged protests at their universities. On January 7, they gave an ultimatum for

the government to meet their demands by January 10. As no such move came, they started an indefinite work stoppage

30 Bangladeshi victims go to European court

Some 30 aggrieved Bangladeshis, who were shot and injured on a strawberry farm in Greece in 2013, filed a case with the European Court of Human Rights in Brussels last week over Greece's alleged violation of human rights.

Tarikul Islam, minister and head of chancery at the Bangladesh Mission in Greece, yesterday confirmed this to The Daily Star over the phone.

"We have received information that some aggrieved Bangladeshis filed a case with the European Court of Human Rights to seek justice for the alleged violation of their rights. We will soon clarify our stance on this," he said.

Zainul Abedin, president of All European Bangladesh Association, yesterday told the BBC Bangla Service that the Bangladeshis had filed the case as a Greek court acquitted the accused people and had not delivered any order regarding compensation for the victims.

Meanwhile, the Greek Council for Refugees (GCR) said the migrants, who worked in strawberry plantations in Nea Manolada, submitted the complaint over violation of the Article 4 of the European Convention on Human Rights, which outlaws forced labour and slavery.

"It is the first time such a case has been filed against Greece, and the first time that the large-scale phenomenon of forced labour is to be addressed at a European level," reports Moscow-based news agency Sputnik International, quoting a GCR press release.

"... Four international human rights organisations and an academic institution have announced their plan to support the lawsuit. The Greek authorities are invited on January 20, 2016, to comment on the breach of obligations

under Article 4," it added. Around 200 migrants, mostly from Bangladesh and Pakistan, worked in the plantations. They protested against a six-month long delay in wages and went on a strike against the owner of

the firm in April 2013. The farm owner, Nicolas Vagela Kos, threatened that he would not pay the arrears if the demonstrators did not go back to work. But the agitating Bangladeshis refused to do so until

their arrears were paid. Then two staff of the farm opened fire on the workers, leaving 32

Bangladeshis injured. On information, the Greek police rushed to spot and arrested the culprits. Four of them were sentenced to different terms.

In July 2014, two of the plantation's employees were sentenced to 14 years and seven months' and eight years and seven months' imprisonment for illegal use of firearms and inflicting bodily harm. However, the indicted were later allowed to pay monetary fines instead of serving the terms, adds

Sputnik International. Around 25,000 to 30,000 Bangladeshis are working in different sectors, especially in farming and garment, in Greece, according to the Bangladesh Mission in Greece.
