# NHA evicts residents of New Colony 'flouting HC stay'

A section of the residents of New Colony in the capital's Lalmatia alleged that they had been evicted unlawfully and left homeless by the National Housing Authority (NHA) yesterday, violating a stay order of the High Court, and demolished their buildings.

The residents claimed they have stay order against any demolition and there was a date of hearing in court on January 18 which was shifted to January 21 but NHA did not follow

the order.

They said NHA along with law enforcing agencies started demolishing buildings 9, 13 and 15 around 10:00am. A group of musclemen also took part in the drive.

Residents said the authority did not give them time to evacuate.

## FAILURE TO SUBMIT WEALTH INFO ACC indicts Tarique's mother-in-law

The Anti-Corruption Commission (ACC) yesterday pressed charge against Syeda Iqbalmand Banu, mother-in-law of BNP Senior Vice Chairman Tarique Rahman, in a case against her filed for not submitting her wealth statement.

ACC Deputy Director Abdus Satter Sarker and also the investigation officer of the case submitted the charge sheet to the Chief Metropolitan Magistrate's Court of Dhaka, showing six people as prosecution witnesses.

The IO showed Banu fugitive and appealed to the court to issue an arrest warrant against her.

On January 30 of 2014, ACC Deputy Director RK Majumdar filed the case with Ramna police as she failed to submit her wealth statement within the stipulated time. According to the prosecution, the ACC issued a notice to

Banu on October 20, 2011 asking her to submit the statements of her moveable and immoveable assets within seven workdays. But Banu did not submit any statement to the ACC

although her caretaker Zakir Hossain received the notice on January 25, 2012.

Later on January 30 in 2012, the High Court stayed ACC's notice for four months. But on May 3, 2012, the Supreme Court stayed the HC's order.

On September 2007, the graft watchdog filed another case with the Kafrul Police Station against Tarique, his wife Dr Zubaida Rahman and Igbalmand Banu for concealing wealth information. Later, the HC stayed the proceedings of the case.

victim Faruk Hossain Kamal's sister and fixed January 26 for cross-examination. In her statement, Parveen said the accused picked up Kamal from their home in the capital's Kafrul area and demanded Tk 50,000 as ransom. When refused, the trio tortured Kamal in police custody.

Later, he was shown arrested in an extortion case and produced before a Dhaka court with a five-day remand plea. The court, instead, sent him to jail due to health condition.

Kamal was admitted to a jail hospital and later shifted to Dhaka Medical College Hospital where he died a week later, said Parveen in her statement.

#### HC questions Menon-led Vigarunnisa governing body's legality

The High Court yesterday questioned the legality of the formation of a special governing body, led by Civil Aviation and Tourism Minister Rashed Khan Menon, at Vigarunnisa Noon School and College in Dhaka.

The court asked the government and the minister to explain in four weeks why formation of the body should not be declared illegal.

Justice Zinat Ara and Justice KM Kamrul Kader gave the rule after hearing a writ petition filed by Supreme Court lawyer Eunus Ali Akond on January 13. Eunus said it was con-

temptuous and illegal to form a special committee to run the institution when there was a rule pending with the HC in this regard. On February 17, 2013,

the HC issued a rule asking the government and Menon to explain why formation of a special body should not be declared illegal, he said.

According to a 2008 government circular, the government could not run any institution, which is on monthly payment order (MPO), by any special committee, such institutions must elect governing committees, he said.
