# Abducted schoolgirl traceless for 7 days

A schoolgirl, abducted from Gafargaon Municipality area on January 12, still remains traceless.

The girl, a Class VIII student of Rustom Ali Golandaj High School in the municipality and daughter of a day labourer, was abducted allegedly by Md Sagar, a resident of Sholohashia in the municipality, and his gang when she was on her way to school.

The victim's family members informed the police the same day, but the girl is yet to be rescued, locals said.

Sagar, 26, a microbus driver, had been stalking the girl on her way to

#### Robbers hurt two

#### Drug smuggler jailed

A mobile court sentenced a drug smuggler to two years' imprisonment at Mogholhat village in Sadar upazila of the district on Sunday. He was later produced before the court, led by Executive Magistrate SM Kashem, which pronounced the verdict.

#### Indian goods recovered

Members of Border Guard Bangladesh (BGB) seized a truck laden with Indian goods from Murarikati area in Kolaroa upazila of the district early Monday. Lt Col Arman Hossain, commanding officer of BGB-38 Battalion, said a patrol team of the border guards, led by Habildar Abdul Barek, chased the truck in the area early morning. At one stage, the trucker fled the scene, leaving the vehicle. Later, the BGB members recovered Indian goods, including three pieces, sarees and limestone, from the truck. The value of seized goods is around Tk 2.50 crore.

#### Six shops gutted

At least six shops were gutted at Ikri Bazar in Bhandaria upazila of the district early Monday. Locals said the fire originated from an electric short circuit at a shop around 1:30am. On information, firefighters rushed to the spot and doused the blaze after one hour of frantic efforts. The affected shop owners claimed that the loss caused by the fire could go up to Tk 50 lakh.

#### Youth held with hemp

Four people, including a woman, were stabbed over land disputes in Barisal and Jessore districts on Monday.

Three youths were injured in an attack allegedly by rivals over a piece of disputed land at Char Pattani village in Barisal Sadar upazila, reports our correspondent.

The victims are Bappi, 20, Jumman, 18, and Badal, 33, of the village.

Seriously injured Bappi was rushed to Barisal Sher-e-Bangla Medical College Hospital.

Locals said there was a longstanding conflict between one Afzal and Bacchu over the land at the village.

As a sequel to the conflict, Afzal group attacked Jumman and Badal group with sharp weapons on Monday night, leaving the three youths injured, said Mahbubul Alam, officer-incharge of Bandar Police Station.
