# No legal basis of caretaker govt verdict

Says SC Bar a day after CJ said writing judgment after retirement unconstitutional

The Supreme Court Bar Association yesterday demanded restoration of the caretaker government system claiming the judgment, which scrapped the provision, was illegal and unconstitutional.

The SCBA made the call a day after Chief Justice Surendra Kumar Sinha said a judge's act of writing a judgment after his retirement goes against the law and the constitution. "Some judges make unusual delays in writing verdicts

while others continue to write it even long after their retirement, which goes against the law and the constitution," the CJ said in a message on Tuesday.

SCBA President Khandker Mahbub Hossain said a Supreme Court bench, led by then chief justice ABM Khairul Haque, had declared the caretaker government system unconstitutional. The former CJ had signed the judgment 16 months after

his retirement, and therefore, that verdict "has no constitutional basis and is illegal", he told a press conference at the SCBA Auditorium.

The previous Awami League government had abolished the caretaker government provision through the 15th SEE PAGE 10 COL 5

## Classes resume at public universities

Classes resumed at all the 37 public universities yesterday after seven days of work abstention by the teachers over "pay disparity" in the new pay scale. The strike was postponed upon assurance from the prime minister.

The students attended classes and exams yesterday, bringing normalcy in the universities which were virtually paralysed by the teachers' movement.

Dhaka University, meanwhile, will take make-up classes at weekends to minimise the student's academic loss due to the strike. The decision was taken

in a meeting at the university's Teacher's Club.

# Saudi accuses Iran of sowing 'unrest, chaos'

Khamenei condemns Saudi embassy attack in Tehran

Saudi Arabia has accused Iran of a nearly four-decade record of "sedition, unrest and chaos," as the international community tried to calm tensions between the regional rivals.

The accusation came as Iran's supreme leader Ayatollah Ali Khamenei yesterday publicly condemned for the first time the January 2 attack on Saudi Arabia's embassy in Tehran as "a very bad and wrong incident".

Tensions between Sunni-ruled Saudi Arabia and predominantly Shia Iran reached a new high this month when Riyadh and a number of its Sunni Arab allies cut diplomatic ties with Tehran. They acted after protesters burned Saudi diplomatic missions in Iran following the kingdom's January 2 execution of prominent Shia cleric Nimr al-Nimr.

"Since the Iranian revolution in 1979, Iran has established a record of spreading

sedition, unrest and chaos in the region, the Saudi Press Agency (SPA) on Tuesday quoted an unnamed senior foreign ministry official as saying.

"During the same period, the kingdom has maintained a policy of restraint in spite of having suffered -- as have neighbouring countries -- the consequences of Iran's continued aggressive policies."

The official said Iranian policy was based primarily on the idea of exporting revolution.

"Iran recruits militias in Iraq, Lebanon, Syria, and Yemen", the official said, further accusing Iran of supporting "terrorism" and carrying out assassinations.

SPA published a 58-point "fact sheet", prepared by the foreign ministry, "to illustrate Iran's aggressive policies" and to refute "the persistent lies" from Tehran, including an article by Iran's Foreign Minister Mohammad Javad Zarif in The New York Times last week.

## Man held in Ctg with stun gun, drone

Customs intelligence officials arrested a man with a drone and a stun gun at Shah Amanat International Airport in Chittagong Tuesday morning.

The news of the seizure was made public yesterday, as the officials said it took them a day to verify the items, which the arrestee claimed to be toys, with the help of intelligence and law enforcement agencies.

# IS destroys ancient monastery in Iraq





Justice Mahmudul Hoque passed the order, considering the petition was not properly placed before it, ACC lawyer Khurshid Alam Khan told the Daily Star. He also said there is no

legal bar for the Special Judge's Court-1 of Dhaka to continue the case proceedings after the HC order. On February 6, 2014, the

ACC filed the case with Ramna Police Station, accusing the former health minister of amassing over Tk 9.53 crore between 2001 and 2006 and depositing the amount in a bank account in the UK.
