Rajuk demolishes more commercial structures

Rajuk on the fifth day of its ongoing eviction drive yesterday recovered basement parking spaces knocking down illegal commercial structures at a number of buildings in Dhanmondi, Gulshan and Uttara in the capital. A Rajuk team demolished five

stores and a business centre at the basement of AR Plaza and a mobile court fined the mall and shop owners Tk 4 lakh, said Executive Magistrate Nasir Uddin, who led the drive in Dhanmondi.

The owner of Victoria Convention Centre on Road 14 was fined Tk 1 lakh as the building had no parking lot, said the magistrate, adding that the owner was given a 30-day ultimatum to ensure the facility.

The owner of Cosmos Plaza, another shopping centre, on Road 28 was fined Tk 50,000 for constructing illegal structures at its basement.

Owner of two-storey sari shop Noborupa was fined Tk 1 lakh for running his business at a residential house, said Nasir, adding that two rooms at the basement of Sunrise Plaza were also demolished. AZM Shafiul Hannan, a Rajuk

authorised officer in Dhanmondi, said they also knocked down two illegal warehouses at the basement of shopping mall Rapa Plaza and another structure at the basement car park of a house on Road 16. In Uttara, another Rajuk team

demolished some basement shops and a staircase at Rajuk Commercial Complex, illegal basement shops at AB Super Market, Ameer Complex, SR Super Market and Hossain Tower, said Rajuk authorised Officer Mizanur Rahman.

Adiluzzaman, another Rajuk authorised officer, said they removed 14 access ramps built illegally occupying footpaths and road width in Gulshan area.

"Currently, admin offices only look after Facebook's regular activity, and they are focusing on business issues, not security, so we shouldn't emphasis on that," Tarana said. Facebook authorities will also take

Cold wave to continue for 2-3 days

A cold wave will continue to sweep over the country for another couple of days, according to Dhaka Met Office.

The sun has not been visible in the northern region and some parts in the Khulna division, including Chuadanga and Jessore, for a few days as bone-chilling cold set in.

The country's lowest temperature was recorded at 6.1 degree Celsius in Chuadanga yesterday while the lowest temperature of Dhaka was 11.4 degree Celsius.

According to Met office forecast, mild to moderate cold wave will continue to sweep over Rajshahi, Rangpur, Khulna and Barisal divisions and Tangail, Faridpur, Madaripur, Gopalganj and Sitakunda districts. Moderate to thick fog may occur at places over the river basins and light to moderate fog elsewhere

in the country after midnight until morning. Meanwhile, our Kurigram correspondent reports, dense fog and

chilling cold have paralysed normal lives in all nine upazilas of the dis-The lowest day temperature fell by degree Celsius to 9 degree yesterday

their work stoppage yesterday after Mayor AJM Nasir Uddin assured them of "clearing up misunderstandings between physicians and patients".

They stopped working at private clinics, chambers and diagnostic centres in the port city on Wednesday in protest at the filing of two cases against three physicians over negligence in treatment. The protesters at the time pledged to continue the strike until the cases were withdrawn. Five days into the movement, Md

Mozibul Hoque Khan, president of Chittagong district unit of Bangladesh Medical Association (BMA), announced the withdrawal of the strike at a meeting at Chittagong Medical College.

Meeting sources said the city mayor said he would work towards an understanding between the doctors and those who have filed the cases.

The diagnostic centres in the city were seen collecting samples for tests yesterday afternoon. Doctors at private clinics and chambers were also seeing patients.

Talking to The Daily Star, BMA's General Secretary Mohammad Sharif said doctors were not above the law but before the filing of a case,

Bangladesh Medical and Dental Council should find out if negligence was at all there on the doctor's side, and then submit a report.

The mayor and Chittagong Press Club leaders assured doctors that the issue would be addressed, Mozibul said after the meeting.

"Considering public interest, we have suspended our programme and we think we will be able to come up with a solution," he added.

At the meeting attended by several hundred doctors, Mayor Nasir said, "People sometimes vandalise valuables of clinics, taking the law in hand, which is not acceptable. They should consider that doctors face

many hurdles while giving treatment." He also urged doctors to provide quality service to patients.

On January 10, Meherun Nesa, 22, niece of the expatriate welfare minister, died at a private clinic in Katalganj following a caesarean oper-

Her family filed a case against Shamima Siddiqua Rosy and Mahbubul Alam of the gynaecology department at Chittagong Medical College Hospital, saying their negligence in treatment caused the death.
