### BITING COLD IN LALMONIRHAT, DINAJPUR

# Diarrhoea, pneumonia spread among children

A large number of children in Lalmonirhat and Dinajpur have been hospitalised with diarrhoea and pneumonia as fall in temperature amid the biting cold for the last few days led to spread of the cold related diseases in northern dis-

Over seven hundred children affected with diarrhoea and pneumonia have been admitted to Lalmonirhat Sadar Hospital and four upazila health complexes in the district in last four days, reports our correspondent.

"We provided treatment to 260 children at Lalmonirhat Sadar Hospital in the last four days. Most of them have already been released after treatment. Physicians are facing trouble numbers of child patients here," said Dr Hafizur Rahman, child disease consultant at the hospital.

He suggested preventing children from exposure to smoke, dust and cold, and not allowing them to take outdoor foods to save them from cold related diseases, especially diarrhoea and pneumonia.

Iman Ali, 42, of Kulaghat village in Lalmonirhat Sadar said, his three-year-old daughter got diarrhoea due to heavy cold and she is under treatment at Lalmonirhat Sadar Hospital since Sunday morning.

Abul Kalam Azad, 35, of Kalmati village in Lalmonirhat Sadar brought his four-year-old son Iqbal Hossain to the same hospital after he was affected with pneumonia two days ago. "Child patients with

diarrhoea and pneumonia are coming from morning to to provide treatment to huge night and they get proper treatment here," said Bilkis Begum, a senior staff nurse of Lalmonirhat Sadar Hospital.

Mousumi Begum, 24, of Bhadai village of Aditmari upazila, said his cold related diarrhoea affected son Nur Islam, 5, is now safe from danger after treatment at the upazila health complex for the last two days.

Lalmonihat Civil Surgeon Dr Abdus Samad said he has asked doctors and nurses in Lalmonirhat Sadar Hospital and four upazila health complexes of the district to remain alert for providing treatment to cold related disease affected children on an emergency

Our Dinajpur Correspondent reports: At least 171 children were hospitalised with cold related diseases in the

district in last 48 hours.

hospitals in Dinajpur said they are also getting elderly patients with sinusitis, acute bronchitis, even pneumonia and cough during the ongoing cold wave that affects heart patients too.

Pneumonia patient Babu, 17, died at Dinajpur General Hospital yesterday. Dinajpur General

Hospital is dealing with 51 pneumonia affected children aged between one day to seven years, said sources of Dinajpur Civil Surgeon's office. At least 120 other

children with pneumonia have been admitted to different upazila health complexes, Dinajpur Medical College Hospital and Aurobindo Shishu Hospital. There are a few diarrhoea patients too.

Dinajpur met office sources said the minimum temperature in the district

dropped by four degrees Doctors of different Celsius in last five days. They recorded 8.2 degrees Celsius on Monday, which was 8.00 degree Celsius the day

Visiting Dinajpur General Hospital, Medical College Hospital and Aurobinda Shishu Hospital the correspondent found nurses and doctors struggling to deal with the hospitalised patients.

"The health complexes in 12 upazilas of Dinajpur district are already crammed with child patients infected with pneumonia. We are struggling to cope with the situation as the upazila health complexes refer the serious patients here," said Dr Wahed, a paediatrician of Dinajpur General Hospital.

Abul Kalam Azad, an official of Zia Heart Foundation in Dinajpur, said they are now getting more cardiac patients as biting cold worsens their

### Land dispute leaves 15 hurt in Jhenidah

At least 15 people were injured as two groups of villagers clashed over land dispute at Sherpur village in Shailakupa upazila of the district yesterday. Locals and police said

there had been a longstanding dispute between Tobarak Hossain and Makhon Hossain of the village over the ownership of a piece of land. Some villagers belong-

ing to Tobarak group locked in an altercation with Makhon's men over the issue at around 8:00am. At one stage, they hit each other with sticks. As the news spread at the

village, the supporters of Tabarak and Makhon, equipped with sharp weapons, swooped on each other, leaving at least 15 people from both sides injured.

On information, police went to the spot and fired 15 rubber bullets and tear gas shells to disperse the clashing groups.

A Chuadanga court yesterday sent 20 people to jail for their alleged involvement in a bombing incident that left two people dead at Gangadaspur village in Jibannagar upazila of the district on January 4.

They deceased were Mohammad Ali, 50, and Shahbuddin, 40. The accused surrendered

before the court of the Chief Judicial Magistrate ABM Mahmudul Haq. The magistrate sent them to jail, rejecting their bail prayers. They are Ilias Ali, Kawsar

Ali, Zahir uddin, Abdul Rashid, Mostafa Malitha, Jamaat Ali, Bashar Mondol, Shamsul Alam, Milon Ali, Fozre Mondol, Abdul Malek, Fazlu Mia, Shamsul Bhutto Sheikh, Nazrul, Anisur Rahman, Hamil Mondol and Abdul Hag. They are among the 42 accused in a case for hurling bombs on the villagers filed on January 11. The case statement said a

group of 15 men, allegedly led by Abdul Malek Mollah, president of Simanta union unit of AL, and Milton Mollah, president of the same union unit of Jubo League, threw seven bombs at a tea stall at the village around 7:30pm, killing Mohammad Ali on the spot and injuring three others. The bomb attack could have been over a dispute centring government khas land, locals said.

The injured were rushed to Jessore General Hospital where Sahabuddin died

Ali, Kasem Ali, Ashabul, around 10:30pm. The condition of the two others, including Sahabuddin's wife Maleka Khatun, is critical. They are settlers on the khas land.

Abdus Salam, younger brother of slain Mohammad Ali, filed a case against 42 people with Jibannagar Police Station on January 11, accusing Abdul Malek Mollah, Milton Mollah and Abdul Hye Tuku as the masterminds.

Locals and police said some 46 landless families, including those of the victims, have been living on 116 bighas of government land (khas land), allocated for Gangadaspur Bhumihin Samity, since 1973.

Abdul Hye Tuku has been claiming the ownership of the entire land for the last three years.

There were 1,118km of underground water pipes in the city and if the Madhupur fault had an earthquake of 7.5 magnitude, pipes would leak in 79 points and break in 272 places, he said.
