Father alleges abduction by law enforcers

Father of a missing madrasa student in Kushtia in a press conference at Chuadanga Press Club yesterday alleged that the boy remained traceless after plain-clothes men introducing themselves as members of Rapid Action Battalion (Rab)-12 in Kushtia abducted him four days ago.

Major Mosaddek Ibne Mujib, commander of Rab-12, however, said none of the elite force committed the act. The victim, Abuzar Gifari,

22, is son of Amir Hossain of Chuadanga Sadar upazila, and a student of Ashraful Ulum Qwami Madarsa at Mangalbaria on the outskirts of Kushtia town.

"Four plain-clothes people went to the madrasa on January 28. They introduced themselves as the members of Kushtia Rab, picked up Abuzar on a microbus (No Ga-137267) and disappeared around 2:00pm," said Amir Hossain at the conference.

"Informed of the incident by the madarsa authority, I communicated with Kushtia office of Rab-12 the same day but they denied their involvement with the incident.

"Then I went to Kushtia Model Police Station and filed a general dairy there on January 28 but they could not trace him out," Amir said.

Mawlana Abu Daud, muhtamim of the madarsa, said four people introducing themselves as Rab men picked up Abuzar from the madrasa hostel on Thursday. Obaidur Rahman, second

officer of Kushtia Model Police Station, said police are investigating the matter.

Missing BNP leader found dead in Pirojpur

Police recovered the body of a BNP man at Pirojpur Sadar upazila of the district on Saturday night, 10 days after he went missing. The deceased is Md

Nazrul Islam, 48, son of late Abdul Kader Howlader of Uttar Poregola village in the upazila, and former secretary of Ward No 6 of Sikdermallick union. Nazrul's brother-in-law

Motiur Rahman Nikkon said that Nazrul went out of his house on the night of January 22 but did not return. His family members tried to trace him but failed.


On Saturday evening, locals of Bagmara village, three kilometres away from Nazrul's house, spotted the body lying in a heap of straw on the bank of the Baleshwar River and informed the police.

Police from Pirojpui Sadar Police Station went to the spot, recovered the body and sent it to Pirojpur Sadar Hospital morgue for autopsy yesterday morning.

"Nazrul was murdered in a pre-planned way," said Sardar Kamruzzaman Chan, chairman of Sikdermallick union and also a district BNP leader.

"We are not sure how he was murdered as his body was badly decomposed, said Md Enayet Hossain, officer-in-charge of Pirojpur Sadar Police Station. No case was filed with

the police station regarding the incident, he added.

A man, who was injured during a clash over land dispute at Gobardari village in Satkhira Sadar upazila on Friday, died at Khulna Medical College Hospital (KMCH) yesterday.

Rahman, 50, son of Afsar Uddin, was a resident of the village.

police said there had been a longstanding feud between Mujibur and one Tabibur Rahman of the village over the ownership of eight decimals of land.

On Friday morning, a group of 7/8 people, led by Tabibur went to the land to plant paddy saplings. As Mujibur and his family members tried to prevent them, Tabibur's men swooped on them, triggering a clash among the two sides, leaving 13 people, including Mujibur, injured.

Injured Mujibur was first taken to Satkhira Sadar Hospital and then shifted to KMCH as his condition deteriorated.

He died at the hospital around 7:30am yesterday, the OC added.
