"I earned about Tk 15,000 by selling brinjal in last one and a half months. I expect to earn Tk 15,000 to 20,000 more from the same field this season," Jalal said.

"I have become a buyer of Research Station.

When the brinjal reaches two to three days, the bags are put on the fruits and remain so till the harvest. The same bag can be used several times after harvesting the crop.

By protecting brinjal from diseases and pests, the cheaper and safer method will boost the quality of yield, said Dr Sorof Uddin, senior scientific officer of Regional Horticulture

5 stolen bikes recovered, 4 arrested

Detectives arrested four members of an organised inter-district gang of motorbike lifters from Dhaka and Gazipur early yesterday.

The arrestees are Abdul Jalil, 35, Rafiqul Islam alias Mamun, 30, Sohagh Miah, 30, and Murad Munshi, 30.

On information, a team of the Detective Branch (DB) of Police, led by subinspectors Moloy Chakraborty and Shahidul Islam, raided different areas of Uttara in Dhaka and Gazipur and arrested the four, said Imarat Hossian Gazi, officer-in-charge (OC) of DB, Mymensingh.

Police also recovered five stolen motorbikes from their possession.

During primary investigation, the arrestees confessed their involvement in stealing of the bikes, the OC said.

The arrestees were produced before a Mymensingh court in the afternoon seeking a 10-day remand for each.

Without fixing the date for hearing on the remand prayer, the court sent them to jail, police said.

Drug addict stabs wife

A housewife sustained severe stab injuries in an attack by her drug-addict husband over a family feud at Nauri village in Ishwarganj upazila of the district yesterday.

The victim, Jharna Begum, 23, wife of Tara Mia, 28, of the village, is now undergoing treatment at Mymensingh Medical College Hospital.

Local people caught Tara from the spot and later handed him over to the police.

Police said the couple often used to engage in altercation over Tara's drug addiction.

An altercation took place between the two when Tara returned home in a drunken state around 10:00am. At one stage, Tara started stabbing Jharna indiscriminately with a sharp weapon.

Hearing screams, villagers rushed to the spot and caught Tara from there, Officer-in-Charge Borhan Uddin of Ishwarganj Police Station said.

Housewife tortured for 'dowry' hospitalised

A newly married housewife was tortured by her mother in-law and other members of the family, allegedly for dowry, at Karnapur village under Lalmonirhat Sadar upazila on Monday evening.

"My hands were tied, and I was tortured by my mother inlaw Sakhina Begum. My husband, father in-law and three other members of the family were present but they didn't protest or try to save me," the victim said at the hospital at noon yesterday. "I was tortured as my parents didn't pay the due money after four months of marriage," she added. The victim, Nurjahan

Noor Islam of Purbo Bhelabari village in Aditmari upazila of the district.

Nurjahan was married to Nabirul Islam, 28, son of Jasimuddin of Karnapur village in Mogholhat union of Lalmonirhat Sadar upazila, four months ago. The bridegroom and his family members demanded Tk 1,50,000 as dowry, but the bride's family paid only Tk 15,000.

"The bridegroom and his family members demanded the rest of the amount but I didn't respond to them as they arranged the marriage ceremony willingly after choosing our daughter Nurjahan," said Noor Islam. "It was not possible to pay the dowry demanded, and it is not possible at present as I'm a day labourer living hand to mouth," he added.

"After one month of our marriage, I became victim of torturing over the due money. My husband, his parents and other members of the family tortured me physically and mentally every day, but I tolerated it as I know my parents are poor," Nurjahan said. "I wanted to go my parents' house but my mother in-law didn't allow me," she added.
