### NATIONAL HERALD CASE Sonia moves SC

India's Congress President Sonia Gandhi yesterday moved the Supreme Court against a December 7, 2015 order of the Delhi High Court dismissing appeals filed by her, son and party vice-president Rahul Gandhi, and others to stay summons issued to them by a trial court in the National Herald case.

In her petition, Gandhi contended that the Single Judge of the High Court "conducted a roving enquiry into allegations of a general nature without examining the questions as to what offences are alleged to be prima facie made out".

Gandhi said the complaint in the case was filed with the objective of defaming her. She said she has deep roots in the society and had been at the helm of national politics for years. She said the complaint and summons, if not quashed, would cause irreparable damage to her reputation.

The summons were issued on a complaint by BJP leader Subramanian Swamy of alleged cheating and breach of trust in the acquisition of the now-defunct National Herald by Young Indian Limited (YIL). The Congress leaders own a stake as directors in YIL, registered as a charitable company.

The petition, filed by advocate Devadutt Kamat, before the apex court said the HC order lacked "objectivity, judicial restraint and adherence to the settled principles of law".

It argued that "unwanted assumptions" were made in the HC order of a vague general nature based on unstated and unproved facts without considering if the ingredients of criminal breach of trust has been made out in the complaint.

The complaint alleged corruption in the assigning of loan worth Rs 90.25 crore owed to the Congress by Associated Journals Limited (AJL), publisher of the National Herald, to YIL for Rs 50 lakh.

# Isolated PM KP Oli could be toppled

An unwieldy coalition of lawmakers trying to implement Nepal's first democratic constitution is finding common cause with protesting minority groups, isolating Prime Minister K P Oli and increasing the risk his government could fall this spring.

Oli, of the leftist Communist Party of Nepal (Unified Marxist-Leninist), promised

to resolve simmering tensions in the southern plains and lift a blockade of the Indian border when he was voted in to power almost four months ago.

Yet sporadic violence, in which more than 50 people have died since August, continues in the Himalayan nation with police shooting

#### Mob strips a student of Tanzania

Police in the southern Indian city of Bangalore say they have arrested five people in connection with an attack on a Tanzanian student.

A mob assaulted and partially stripped the 21year-old woman after a Sudanese student's car ran over and killed a local woman on Sunday night. The woman and her three friends - all Tanzanians were attacked as they were passing by the accident site.

The crowd chased the young woman and "removed her top", police said. India's Foreign Minister Sushma Swaraj tweeted on Wednesday that she was deeply pained over the "shameful incident", and asked the chief minister of Karnataka state - of which Bangalore is the capital - to "ensure safety and security of all foreign students and stringent punishment for the guilty"

UN sanctions prohibit North Korea from any use of ballistic missile technology, and such a launch would amount to another major violation of UN Security Council resolutions following its fourth nuclear test last month.

### Pak madrasas fund jihadist

groups Experts told US lawmakers

Radical Pakistani madrasas are engaged in massive trade-based money laundering to fund jihadist groups, eminent experts have told American lawmakers who expressed concerns over terror financing.

Concerned over the practice, Congressman Stephen F Lynch said tradebased money laundering (TBML) involves using trade and products or commodities for value in order to divert and obscure the true nature of the illicit wealth.

"Trade-based money laundering is related to terrorist finance," John Cassara, former US Intelligence Officer and Treasury Special Agent, told members of the House **Financial Services** Committee during a Congressional hearing.

He said in one example of TBML and terrorist financing, a Pakistani madrasa was linked to radical jihadist groups and it received large amounts of money from foreign sources.

"It was engaged in a side business dealing in animal hides. In order to justify the large inflow of funds, the madrassa claimed to sell a large number of hides to foreign customers at grossly inflated prices. This ruse allowed the extremists to 'legitimise' the inflow of funds which were then passed to terrorists," Cassara said.
