

It is an Eco-sustainable garment factory . To conform its Eco-sustainability, it has been constructed complying with the specifications of Leadership in Energy & Environmental Design (LEED), as prescribed by the U.S. Green Building Council • It has lessened its electricity consumption by 1,295 MWH per year by way of curtailing dependency on national grid or by reducing use of fuel oil by 325 MT a year • It uses solar power to meet more than 25 percent of its electricity consumption ● It uses environment-friendly and energy-efficient LED bulb and tubes ● Usage-optimization through Water Fixture helps reduce consumption of water from taps by 30 percent ● Rainwater harvesting is in practice • Sewerage Treatment Plant (STP) can treat 12,000 liters of water an hour, and this water is being reused here properly without discharging it outside the premise • Strategic factory location is meant for occurring a very low carbon emission, by world standard, today and tomorrow - always • Factory premise is purpose built - designed with more than 50 percent of open space, water-efficient landscaping, pond and less water consuming greenery • While the factory building will never rise above three stories, its upstairs have open and wide grass carpeted terrace and gardens • Building construction materials and design are heat-resistant • Fire-door, wide staircase and exit plan are designed to enable all people working in it to leave the building, responding to an emergency call, in a time less than two minutes • Automatic Smoke and Fire Detection System pinpoints the exact place of occurrence instantly and toots Alarm Bell forthwith • Auto sprinklers can spray water to each and every corner of the factory building and premise • On 480,000 SFT of floor space, not more than 4,500 people will be working here ever
