Lalmonirhat children's health, education suffer from rising tobacco farming

For many struggling Lalmonirhat families, relatively lucrative tobacco farming appears to be a blessing. But cultivating the crop brings significant health consequences. Worse still, with children commonly engaged in tending fields, the health of many youngsters is compromised.

"Our three sons and one daughter help in the tobacco field," says Afsar Ali, 45, of Aditmari upazila's Saptibari village. "It saves labour costs. But even we adults suffer headaches, cough, fever and pain from working with tobacco. For the children it's really serious." Ali says he has no viable alternative.

The golden girls

Weightlifter Mabia Akter Simanta and swimmer Mahfuza Khatun Shila yesterday bagged the first two gold medals for Bangladesh in the 12th South Asian Games, being co-hosted by the north-eastern Indian cities of

Guwahati and Shillong. Mabia, participating with a right-elbow injury, won the first gold in the morning lifting a total of 149kgs -- 67kg in snatch and 82kg in clean and jerk -- in the 63kg category at the Bhogeswari Indoor Stadium in Guwahati. In doing so, she became the first female weightlifter from Bangladesh to win an SA Games gold medal.

With the national flag of Bangladesh hoisted and the national anthem playing in the background, Mabia burst into tears saluting the red and green flag.

"I was not expecting to win gold with my elbow injury and I competed only for silver, but I bagged the gold medal. I still can't believe it," Mabia said in her instant reaction, adding that she was still feeling pain in her hand.

However, it was an unexpected gold for Mabia as Indian gold-medal hopeful Reena, who lifted 22 kilos more than Mabia in snatch, failed in her last three attempts in clean and jerk to pave the way to gold for the young Bangladeshi weightlifter.

Later in the afternoon, Mahfuza made it a double delight for Bangladesh by winning gold in the 100m breaststroke at the Dr Zakir Hussain Aquatic Complex in the same city.

Unlike Mabia, Mahfuza dominated her event from the start and finished her swim in 1min 17:86sec to win the title, which she had lost to Sri Lanka's MSN Karunarathe by

17 microseconds in the 2010 SA Games in Bangladesh. "Last time I was defeated by a few microseconds and this

Bangladeshi Jute Products India to shelve investigation

India agreed in principle not to carry out investigations relating to anti-dumping and countervailing duties on jute goods exported from Bangladesh, a senior commerce ministry official said yesterday.

"We were successful in convincing India that Bangladesh has sufficient reasons to give subsidy and cash incentive against exports and that it is given in line with international trade norms," Monoj Kumar Roy, additional secretary of the commerce ministry, told The Daily Star.

Monoj led a Bangladesh delegation comprising officials of Tariff Commission, World Trade Organisation (WTO) cell and Jute Department to discuss the anti-dumping and countervailing duties initiated by India on Bangladeshi jute products. The meeting with India's Directorate General of Anti-Dumping and Allied Duties (DGAD) was held in Delhi on Wednesday.

At the meeting Monoj explained Dhaka's position vis-àvis India's allegations against Bangladesh giving subsidy and cash incentive to its jute products.

The issue came to the fore in October last year when the DGAD under the ministry of commerce of India started investigating imposition of anti-dumping and countervailing duties on jute goods exported from Bangladesh based on the claims of Indian Jute Mills Association.

If a company exports a product at a price lower than that in the home market, it is considered to be "dumping" the product. Accordingly, the importing government takes action against "dumping" in order to defend its domestic industries. SEE PAGE 2 COL 5

Return case files, don't talk to press

CJ asks Justice Manik

Chief Justice Surendra Kumar Sinha yesterday wanted that Justice AHM Shamsuddin Choudhury Manik, a former Supreme Court judge, immediately return all the files of cases of unsettled judgments pending with him" to the SC registrar general's office.

Earlier in the day, Justice Manik in a letter informed the CJ that he finished writing all the judgments and orders, but Justice Md Abdul Wahhab Miah, presiding judge of the apex court bench, of which he (Manik) was a member, refused to accept those "on instructions" of the CJ.

Manik also requested the CJ to take necessary steps for accepting the judgments and orders he has written after his retirement on October 1 last year.

Later in the evening, Manik told The Daily Star that Justice Wahhab Miah agreed to accept the judgments and orders from him
