DMP moves a notch up in gender equality

Launches country's first female traffic police service; barriers yet to be addressed

Even a few days back, boarding a crowded bus amid heavy vehicular movement in the mad streets of Dhaka was a huge challenge for the female commuters, who could hardly imagine getting any help from traffic police with this

Things have, however, begun changing with the introduction of the country's first female traffic police in the city.

"A few minutes ago, a woman couldn't get on a bus. I signalled the bus to halt and helped the woman board it," said Traffic Sergeant Ismat Tara, hailing from Dinajpur, while performing her duty at Crescent Road intersection on Mirpur Road on Wednesday morning.

A total of 24 females underwent a six monthlong training at Bangladesh Police Academy in Rajshahi's Sharda.

inspector, at different intersections in the capital since the beginning of this year while 2 others did not join the service.

"We came up with the idea because it would have a positive effect on ordinary people and the society, when they would see that even women can carry out such challenging jobs," said Nazrul Islam, assistant inspector general (media) of police headquarters, adding that it would boost the confidence of women.

"We are getting positive feedbacks about Twenty two of them have been posted as traffic them. They behave politely with the people while discharging their duties," said Mosleh Uddin

Ahmed, joint commissioner (traffic) of Dhaka Metropolitan Police (DMP).

It looks like the posting of female sergeants has already begun affecting the young girls psyche.

"School going girls often tell us, Apu [sister], we feel good seeing you at work. We want to grow up and join the police like you," said Traffic Sergeant Lima Chisim, who joined the force on January 3, after graduating from Eden Mohila College in the city.

Hailing from Mymensingh, Lima took up this profession as she liked taking challenge.

Asked how she was treated by others, Lima said none misbehaved with her in the streets, but rather they looked amazed seeing a female working as traffic sergeant.

"At first I used to feel uneasy, but now I feel good helping others when I can," Ismat said, adding that when some rowdy drivers disobey her orders, her seniors help her out then.

KHALEDA'S "SEDITION" Cops asked to submit probe

A Dhaka court yesterday again directed police to submit a probe report by March 3 into a defamation allegation against BNP Chairperson Khaleda Zia and party leader Goyeshwar Chandra Roy for their comments on the Liberation War martyrs.

Metropolitan Magistrate Md Nuru Miah passed the order after Shahbagh police failed to submit any report or any application for what they could not submit.

Earlier on January 5, AB Siddique, president of Jananetri Parishad, filed the case against the two for their "insulting" remarks on the martyrs.

Following the case, Metropolitan Magistrate Md Aminul Haque directed officer-in-charge (investigation) of Shahbagh police to investigate the complaint and submit a report to the court by yesterday.

On December 21 last year, Khaleda, in a public address, said, "There are controversies over how many were martyred in the Liberation War."

Four days later, Goyeshwar termed the 1971 martyred intellectuals "anti-liberation elements" who "died like fools" and drew salaries and allowances from Pakistan till the end of the war.

Two more cases were also filed against Khaleda for her comments on the same issue.

Mariners not okay with 'move to give CDCs to fishers'

expressed their disapproval of an alleged move to provide Continuous Discharge Certificates (CDC), a type of experience logbook of mariners issued under the shipping ministry, to graduates of Bangladesh Marine Fisheries Academy. They claimed that CDCs were exclusively meant for

Ashraf claimed that, as per a government report, the number of Bangladeshi merchant vessels had decreased while ones for fishing increased and that 60 percent of the posts for officers in 269 fishing vessels were vacant.

Contacted over the phone, Department of Shipping Director General Commodore Zakiur Rahman Bhuiyan said a new committee was formed recently to look into the issues as another formed in 2013 had made a probe report contradicting its own recommendations.

The contradiction was that though it found out about the vacant posts, it had recommended giving CDCs to fisheries graduates so that they could serve in merchant vessels, he said.

He said the government hardly took up any policy working against the businesses of pesticides and chemical fertilisers and that successive governments never thought about occupational health hazards faced by farmers.
