AL warns leaders who ignored party decisions

The ruling Awami League has decided that the grassroots leaders, who ignored party decision during the municipality elections last December, will be forbidden to participate in the party chairman candidate selection process before union parishad polls.

The decision was made at a meeting of party joint general secretaries and organising secretaries, held at party president's Dhanmondi office in the capital yesterday with party presidium member Obaidul Quader in the chair.

According to the meeting decision, the presidents and general secretaries who participated in the last municipality polls as independent candidates or worked for party rebels, ignoring party decisions cannot take part in the scrutiny process, said AL Joint General Secretary Mahabubul Alam Hanif after the meeting.

Presidents and general secretaries of district, upazila and union units will select chairman candidates and send the list to the central committee for final selection.

Hanif said those who would contest the UP polls defying party decision or get involved in any activity going against the party's discipline would face a harsher punish-

The party will send directives to the grassroots today asking them to start the selection process and send the list in the shortest possible time.

dangerous animal on Sunday.

The leopard, which strolled into the Vibgyor International school, was eventually tranquilised and released. A recent wildlife census estimated

that India has a leopard population of between 12,000 and 14,000.

The eight-year-old male was spotted strolling inside the school premises in the Kundalahalli area.

Footage on the school's security cameras showed it attacking a man near a swimming pool.

Conservation scientist Sanjay

Gubbi and forest department employee Benny Maurius were injured when they tried to corner the animal and tranquilise him, reports

"It was a long struggle to capture the leopard. Although it was injected with tranquilisers it could be captured only around 20.15 local time when the medication took full effect," senior police official S

Boralingaiah told reporters. Wildlife official Ravi Ralph told the BBC Hindi's Imran Qureshi that the leopard possibly strayed into the school from a patch of forest not far from the school.

The captured animal has been moved to a national park and the six injured people, including a cameraperson of a TV channel, have been treated for minor injuries.

Leopards and other big cats have been known to stray into populated areas, and conservationists have warned that such confrontations may increase as humans encroach on

animal habitats. Last year a male leopard spent five hours with its head stuck in a metal pot in a village in the northern state

of Rajasthan.

lobbies with vested interests had a part in the failure of the G2G, which led Malaysia to take an initiative in June last year for recruitment of workers through private sector.

Both the countries went for the G2G, as Bangladesh's labour relations with Malaysia had been stained with corrup-

payment and bad living conditions when private recruiting agents were involved in the business in 2007-08. Involvement of too many middle-

men and charging each worker around Tk 2 lakh for recruitment in Malaysia were cited as major reasons behind the problems then, which led to a ban on recruitments from Bangladesh in early 2009.

The recent government move to send workers to Malaysia through the private sector caused controversies with several Malaysian companies allegedly lobbying the two governments to win contracts for management and monitoring of recruitment.

The names of Bestinet, Real Time Networking and Synerflux came up prominently.

Following rights groups' criticism against Bestinet and Real Time Networking, Synerflux was reportedly short-listed by Malaysia.

lapse in his editorial judgement in publishing a few reports that the newspaper could not independently verify at the time. During the 2007-08 period, almost

all the mainstream media outlets -both print and electronic -- ran reports on corruption by top political figures based on information given by the joint forces. But some ruling party leaders and

lawmakers are making an issue out of it and taking a dig at The Daily Star and its editor. Attempts are also being made to distort and give negative spins to what Mahfuz Anam has actually said during the talk show. Talking to reporters at the AL presi-

dent's Dhanmondi office after a party meeting, Hanif said, "We think that by doing such an unethical job [running reports without verification], the editors have proved that they sometimes work as a partner of conspiracy against the country's interest." Meanwhile, Chhatra League men of Dhaka-10 constituency staged a dem-

onstration in the city's Jigatola, demanding the arrest of Mahfuz Anam and closure of the paper for what they claimed running "false news" against Sheikh Hasina after 1/11. Responding to a query, Hanif said

the authorities concerned might take legal action against those who took part in the "conspiracy".

"The person who was involved with such activities and who has conceded his mistake ... there is no chance of avoiding the responsibility by mere confession," he said, adding that the nation wanted to hear more from the editor.

The AL leader also said a daily newspaper's editor admitted that "they committed a mistake" after eight years, reports BSS.

"But who will take the responsibility, as this mistake caused a huge loss to the countrymen and Sheikh Hasina had to go to jail? Sheikh Hasina was defamed. Who will take this responsibility? There is no scope to skip this responsibility," the BSS quoted him as saying.

BCL PROTEST

About 200 BCL activists formed a human chain at Jigatola bus stop around 11:30am, marched through Dhanmondi-15 area and burnt two effigies of Mahfuz Anam.

They chanted various slogans against Mahfuz Anam and demanded that he resign immediately. They also urged the government to arrest and try him for "sedition".

The BCL men took to the streets a day after seven lawmakers, including Falze Noor Taposh of Dhaka-10 constituency, lambasted the newspaper

and its editor at Jatiya Sangsad.

lenged teenage boy. Jahirul and Rubia are two of 120 volunteers, all of whom are college students, working under a project called "We too can" in Ghior and Daulatpur. Funded by Niketon, a Netherlands-funded NGO, the project was initiated by Disabled Rehabilitation and Research Association (DRRA), says Dalima Rahman, project co-coordinator.

The volunteers are working for 130 physically challenged children in the two upazilas of Manikganj.

Jahirul is a first-year student of BBS and Rubia a second-year student of BA. They say they are happy to work in an organisation that helps physically challenged children.

DRRA gave training to college students of Ghior and Daulatpur upazila. After training, 120 college students expressed their willingness to work for physically challenged children as volunteers.

The organisation sits with the volunteers every month, says Dalima.
