ATTACK ON LAW ENFORCERS IN BOGRA TOWN IN 2014

Charges pressed against 15 Shibir, Jubo Dal men

Charges have been pressed against 15 Shibir and Jubo Dal men in the case for attacking law enforcers during hartal in Bogra town in 2014.

Although sub-inspector (SI) Abdur Razzak, also investigation Officer (IO) of the case, submitted the charge sheet to the Judicial Magistrate's Court recently, police disclosed the matter

to local press on Sunday.

The charge sheeted accused are Shibir Bogra town unit president Alauddin Shohel, secretary Abdus Samad, activists Nujafa Nayeem, Shah Jamal, Mostayeen Billah, Jahangir Alam, Shamim Mia, Mahamudur Rahman, Shohel Rana, and Rezaul Karim, and Jubo Dal district unit organising secretary Shanto Mia, Jubo Dal district unit leader Mahamudur

Rahman, and activists 2014. Khorshed Alam, Ataur Rahman and Jony Mia.

Sub-Inspector (SI) Zulhaj Uddin of Sadar Police Station lodged the case, accusing the Shibir and Jubo Dal men on the day.

According to case statement, the accused swooped on the on-duty police and BGB men in Satmatha area of the town during hartal enforced by the BNP-led alliance on September 21,

They also hurled crude bombs at the law enforcers, leaving policeman Ruhul Amin injured, the statement said, adding that police and BGB men had to fire at least 15 rubber bullets to disperse the attackers.

After investigation, Investigation officer Abdur Razzak pressed charges against the accused. He said most of the accused are now on bail.

3 polythene factories sealed, fined in Bogra

Three polythene factories were sealed and also fined at Joypurpara area in Bogra town on Sunday. A mobile court led by SM

Zakir Hossain, executive magistrate of Bogra, conducted a drive in the area with the help of Armed Police Battalion (APBN) of Bogra.

Md Shamsuzzoha, assistant superintendent of police (ASP) and officials of the Department o Environment were present during the drive.

The court seized around 11 tonnes of polythene worth around Tk one crore from the three factories and fined them Tk one lakh each for making and storing polythene bags under 10 mili microns. The court also sealed the factories.

The factories are Bismillah Poly Printing owned by Tofazzal Hossain, Minar Poly owned by Fazlul Bari and Amin Super Packaging owned by Mir Hossain of the area.

40 maunds of jatka seized

The law enforcers rushed to the spot, recovered the body and sent it to Gaibandha Hospital morgue for autopsy. Criminals might have killed Tarani, said police.

"Her condition has improved and she can be released tomorrow or day after tomorrow," Dr Sabuj said, adding that she is in mental stress although she has been cured physi-Later, her parents took cally. The mental stress added.

Suruj Miah said he felt that he was responsible for the torture of his daughter. "I could not afford to give her a new uniform this year due to poverty," Suruj, a day labourer, said, adding that he had submitted a complaint to the primary

education department. Md Abul Bashar, primary education officer of the upazila, said, "I have formed an inquiry committee headed by an assistant primary education officer. The team has already visited the hospital. They will also visit the school to know about the incident."

He added that the accused teacher would be punished if the inquiry will take time to ease, he committee found him guilty.
