# The sisters indomitable

Visually impaired since birth, they would not give in

Who would have thought the four sisters would be where they are today? Visually impaired since birth, they grew up seeing their parents endure frequent taunts from neighbours and gossip-mongers who labelled them as "ill-omened". The only other response they elicited from people was that of pity as everyone had thought they would end up being a burden to the family.

But what the sisters from Patia of Chittagong have achieved with their unswerving determination is an awe-inspiring story of refusing to give in to disability and of realising their goals.

In a country where facilities for visually impaired people are scant, Umme Habiba Chowdhury completed her master's in law and Umme Taslima Chowdhury in political science, and both Umme Tanzila Chowdhury and Umme Salima Chowdhury are currently doing their master's in sociology. All of them have studied at Chittagong University.

What is more, three of them have already embarked upon a teaching career at primary schools in Patia, and they are doing their job with reputation.

Their parents deserve special mention as they left no stone unturned to see their children established in society.

"Perhaps the proverb 'Where there is a will, there is a way' applies to us. A person with disability can be established in society if they are determined and motivated," said Taslima, a teacher of South Gobinderhill Government Primary School in Patia upazila.

## Submit BASIC Bank scam probe reports

HC asks ACC, central bank

The High Court yesterday directed the Anti-Corruption Commission and Bangladesh Bank to submit their probe reports on BASIC Bank loan scam. The anti-graft watchdog has been given seven days and the central bank four weeks to present the reports. The court also asked the authorities of the state-owned BASIC Bank to

submit its documents on the decisions taken by its board of directors for granting loans to different institutions. The HC bench of Justice Md Ruhul Quddus and Justice Mahmudul

Haque came up with the order after hearing a writ seeking further investigation into the loan scam, ZI Khan Panna, counsel for petitioner Harun-or-Rashid of Noakhali, told The Daily Star. In his petition filed on November 12, Harun said 57 cases had been

lodged over the BASIC Bank loan scam, but Abdul Hye Bacchu, former chairman of the bank, and the board members responsible for the scam were not implicated in any of them.

He prayed to the court to direct the ACC to implicate them in the cases. One of the best-run banks until 2009, the BASIC Bank was mired in financial irregularities following Bacchu's appointment as its chairman that year.

"The government has taken precautionary measures. It is capable of tackling any circumstance [regarding the epidemic]," he told a press briefing at his ministry in the secretariat yesterday.

He said if anyone is detected with the virus, the government will bear the cost of their treatment.


On February 1, the World Health Organization (WHO) declared a global public health emergency on mosquito-borne Zika virus, first discovered in Uganda in 1947.

A Zika virus infection causes symptoms like fever, rash, joint pain and conjunctivitis. The illness is usually mild with symp-

toms lasting a week. At the press briefing, Prof AKM Shamsuzzaman, director of the Centre for Disease Control of the Directorate General of

## 49pc children encounter cyberbullying

Reveals Telenor study on Bangladesh

Around half of the school-goers in the country have encountered cyberbullying, global mobile phone giant Telenor yesterday said.

The parent company of Bangladesh's top operator Grameenphone conducted a survey last year of 1,510 students aged between 12 and 18 years to understand internet use patterns and practices among youths here.

Young people are increasingly becoming vulnerable to online harassment with 49 percent of the students having fallen victim to cyberbullying in one way or the other, according to the study. As many number of students also said they had succumbed to at least one form of peer pressures like being encouraged to visit unsuitable websites or use bad language on social networks.

However, 39 percent students in Malaysia and 35 percent in Thailand admitted to having been bullied in the cyber world. Telenor's region-wide survey between June and July involved 1,896 students in Malaysia and 1,336 in Thailand.

The survey report was released yesterday marking Safer Internet Day. Grameenphone celebrated the day through an internet safety awareness session at HURDCO International School in the capital's Bashundhara Residential Area.

The inaugural study also found that school students in all the three countries tend to confide in parents and teachers when they face online issues that they do not know how to solve alone.
