### sub-committees for sixth council today

Suggests Justice Manik has been a lackey of ruling AL; Fakhrul says Manik's defiance against CJ is proof of state affairs being in disarray

BNP is likely to finalise today at least 12 sub-committees including the body for reforming its charter for holding its sixth council at its standing committee meeting, presided by BNP chairperson Khaleda Zia, and also might extend the time of the council at least for seven days, said the insiders.

Meanwhile, BNP leader Rizvi Ahmed yesterday, at a press conference at party headquarters in the capital, criticised former Appellate Division judge AHM Shamsuddin Choudhury Manik for his recent remarks about the chief justice.

In the last meeting, the standing committee decided to hold the council in mid March, later finalised March 19 and applied for three places to hold the meeting.

A BNP leader, involved with the council, said acting secretary general Mirza Fakhrul Islam Alamgir roughly categorised the subcommittees and will start working from tomorrow after getting an approval of the party chief.

### War criminal Mir Quasem's appeal hearing starts

The Supreme Court yesterday started hearing an appeal of war criminal and Jamaat leader Mir Quasem Ali, challenging the death sentence for his crimes against humanity during the Liberation War in 1971.

A five-member bench of the Appellate Division headed by Chief Justice SK Sinha began the hearing with Quasem's lawyer SM Shahjahan reading out the charges.


The defence lawyer also read out statements of the prosecution witnesses during the four-hour hearing. The bench fixed today for further hearing.

The International Crimes Tribunal-2 on November 2, 2014 sentenced Quasem to death after finding him guilty on 10 charges for abducting, confining and torturing people during the Liberation War.

Around four weeks later, he filed an appeal with the SC, challenging the tribunal's verdict.

Quasem, a member of Jamaat's central executive council, in his appeal cited 181 reasons for his acquittal on all the charges.





## Children find reason to go to book fair

Bangladeshi comics are becoming popular day by day and emerging as a potential competitor of American and Indian comics among children and teenagers.

Children and youths yesterday at the Ekushey book fair swarmed around Panjeree Publications Ltd and Dhaka Comics to buy comics of their favourite characters.

Panjeree Publications has brought 30 different comic books. Of these, Basic Ali, Babu, Somo Mongol Abhijan, and Somo Kalpa Shikari written by cartoonist Sharier have become immensely popular among children.

Nayan, a third-grader, pleaded his mother to buy him a copy of Babu. Even though she was reluctant, she yielded to her son's persistence.

"I love to read Babu," said a jubilant Nayan. Shimul and Jyonti, two university goers, brought three sequels of Basic Ali, another creation of Sharier, a hilarious comics based on various aspects

Dhaka Comics also set up a stall at the book fair. A group of young cartoonists and comic book artists initiated the organisation with an aim to publish comic books that can cater to Bangladeshi preferences and culture.



A Jatiya Party lawmaker yesterday in parliament stoutly protested harassment of his personal secretary by policemen while he (PS) was entering Bangladesh Secretariat in the capital.

Speaking on a point of order, Nurul Islam Omar, elected from Bogra-6, asked the government whether it was true that "Police is the king of the country"- a highly lambasted remark a policeman made recently while pestering another man employed at Dhaka South City Corporation.

Describing the police harassment, the lawmaker said he along with his PS went to the secretariat yesterday morning.

"Later, I sent my PS outside the secretariat to bring a document from my house, which I forgot to bring with me, but the on-duty police denied my PS access to the secretariat when he returned", Omar added.

"Even police didn't let him go from the entrance of the secretariat. After a long time, a sub-inspector showed kindness and agreed to talk to me over my PS' phone," he added.

The lawmaker also lambasted security of this sort, questioning, "Is the country at war? Is martial law in effect in the country now?"

"It's not security. It's totally harassment by police. I demand exemplary punishment of the policemen involved," Omar added.

### Sedition case filed against AL's Latif over doctoring Bangabandhu's photo Another case filed

Two cases including one for sedition were filed against Awami League lawmaker MA Latif yesterday, over his alleged involvement in tampering with the photo of Bangabandhu Sheikh Mujibur Rahman. The court of Chittagong

Metropolitan Magistrate, with which the cases were filed, took the cases into cognisance and ordered investigation, said lawyers of the complainants. The other case was filed

under Section 57 of the Information and Communication Technology (ICT) Act, for spreading the manipulated photo.

Vice President of Chittagong city AL AKM Belayet Hossain lodged the sedition case against Latif, while former Jubo League leader Saifudddin Ahmed Rabi filed the other case, accusing Latif and three others -- designer Kabir Hossain of Haider Printers and Computers in the port city and its two staff Rajib Das and Md Amzad.

communalism, and extreme religious fanaticism today, said Prof Ajay Roy, father of slain writer-blogger Avijit Roy. "We are going through a critical time now," he told the discussion, "Militant fundamentalism in Bangladesh: Free-

thinking is constrained", in the capital's Bilia auditorium. Ekatturer Ghatak Dalal Nirmul Committee organised the discussion on the 94th birth anniversary of late

National Professor Kabir Chowdhury. Prof Ajay said militant groups were carrying out extremist activities by targeting and killing free-thinkers in different names.

They have already killed bloggers Ahmed Rajib Haider, Avijit Roy, Oyasiqur Rahman, Ananta Bijoy Das, Niladri Chattopadhyay, and publisher Faisal Arefin Dipon, he said.

"But the killers are still out of the police radar. This failure makes us more anxious." Eminent journalist and cultural personality Kamal


Lohani also expressed frustrations over the law enforcers' failure to protect the free-thinkers. "They are talking about zero-tolerance against militants.
