Israel charges Arab schoolgirls

Israel yesterday charged two Arab Israeli schoolgirls with the attempted murder of a security guard last week, saying they expected to die in the attempt and become martyrs for Islam.

A police statement quoted the charge sheet as saying that the two girls were both aged 14, from the mixed Arab-Jewish town of Ramle, and had been influenced by a wave of Palestinian violence since October.

"On February 3, 2016, after a stabbing attack in which three terrorists were shot dead at Jerusalem's Damascus Gate and because of the wave of terror, the accused agreed to meet the next day, equipped with kitchen knives, to carry out a nationalist stabbing attack," it said.

"They conspired to become 'martyrs' and die in the war for religion." On February 4, "one of the accused suggested to the other that they go to school first and carry out the stabbing attack in the afternoon,"

it added. "Nevertheless the other accused persuaded her that they should mount the attack in the morning instead of going to school."

vacation. There are over four lakh legal Bangladeshi workers there who sent \$112.08 million in remittance last year, according to the Bureau of Manpower Employment and Training.

Recently, Malaysia has selected Bangladesh as the source country to hire 1.5 million fresh workers in the next three years under a new system called G2G Plus, through which both government and private agencies can recruit labour. A Memorandum of Understanding (MoU) to this end is expected to be signed between the two countries within a month.

Last Monday, Dhaka approved a draft deal to allow Bangladeshi private recruiting agents to send workers to Malaysia, after the government-togovernment (G2G) hiring system failed.

Under the new G2G Plus system, migration cost per person would be Tk 37,000 at best, Cabinet Secretary M Shafiul Alam had said after Monday's cabinet approval.

signing within two or three days," said the Bangladesh envoy in Kuala Lumpur.

According to the sources, the deal is expected to be inked by next week. A Bangladesh delegation, led by Expatriates Welfare and Overseas Employment Minister Nurul Islam, will be in Kuala Lumpur for the signing.

The issue of undocumented workers emerged every time moves were made for fresh recruitment. Organisations working on migration in both countries pressed for legalising the undocumented workers first.

Tenaganita, a reputed NGO in Kuala Lumpur, on Tuesday told a local newspaper that the Malaysian government should focus on legalising the undocumented Bangladeshi workers before bringing in another 1.5 million.

"We've already written to the government on this matter and we've suggested that they sort out things like having proper work permits for those who are already here," Tenaganita Director Aegile Fernandes told Malaysian English daily The Star.

She said the Malaysian government should also blacklist all agents who overcharged migrants, according to the

report. "Many of these migrants pay a lot of money to them [agents] to make a living here," Aegile Fernandes said, adding that

IMF threatens to cut Ukraine aid over corruption

The International Monetary Fund threatened to cut crucial financial aid to cash-strapped Ukraine Wednesday because of the country's "slow progress" in fighting corruption.

"Without a substantial new effort to invigorate governance reforms and fight corruption, it is hard to see how the IMF-supported program can continue and be successful," Christine Lagarde, the IMF managing director, said in a strongly worded statement. Lagarde's comments followed the

shock resignation one week ago of Ukraine's reformist economy minister, Aivaras Abromavicius, in protest against alleged influence-peddling and state graft.

Lagarde last week said the reasons for his resignation were troubling, and she went much further Wednesday.

"I am concerned about Ukraine's slow progress in improving governance and fighting corruption, and reducing the influence of vested interests in policymaking," she said.

"It is vital that Ukraine's leadership acts now to put the country back on a promising path of reform."

"We told them that the transfer of power is not possible in a proper way without a free, fair and impartial election," he added.

European Union Ambassador in Dhaka Pierre Mayaudon and other members of the delegation -- Richard Howitt (Labour Party), vice-chair, delegation for relations with the countries of South Asia; Ivan Štefanec (Christian Democrats), member, committee on the internal market and consumer protection and delegation for relations with the countries of South Asia; and Sajjad Karim (United Kingdom Conservative Party) of committee on international trade -were also present at the meeting.

The EC came up with the schedule around one and a half months after the municipality polls. A total of 234 municipalities went to polls on December 30 last year.

The UP election is set to generate heat in the political landscape, as the ruling Awami League and opposition BNP will formally step into the battle of ballots along with other parties.

For the first time, the parties will be able to pick their grassroots leaders to vie for UP chairman posts with the party's electoral symbol "boat" and "sheaf of paddy".

The new electoral code of conduct will offer some benefits to BNP leaders, as its Chief Khaleda Zia and all her party leaders will be able to participate in electoral activities and campaigns for partynominated candidates.

But AL President Sheikh Hasina cannot do so, as being the prime minister she is enjoying government benefits. Like her, all the ministers and her party lawmakers are barred by the code of conduct from carrying out electoral activities for party nominated candi-

According to the electoral code, individuals enjoying government benefits include the prime minister, the speaker, ministers, chief whip, whips, deputy speaker, deputy leader of the House, leader of the opposition, state ministers, deputy ministers, MPs and mayors of the city corporations.

A political party registered with the EC has to nominate a single candidate for the post of chairman in each UP. If any party nominates multiple candidates in one UP, candidacy of all aspirants nominated by that party in the UP will be cancelled, say the electoral laws.

Political parties willing to contest the polls will send letters to the ROs, mentioning the names of partyauthorised persons, who will pick the candidates within seven days of announcement of the polls schedule. Copies of the letters will have to be sent

Meanwhile, several hours after announcing the schedule, the EC issued letters to all the 40 registered political parties, asking them to comply with the

In the last municipality polls, AL Chief Sheikh Hasina attested the partynominated mayoral aspirants, while BNP Joint Secretary General Mohammad Shajahan did the job on behalf of BNP Chairperson Khaleda Zia.

He said action would be taken against polls officials and law enforcers if found guilty of negligence in carrying out duties.
