FROM PAGE 1 The workers' associations had no legal status earlier but the amendment would give them the legal status of the Collective Bargaining Agent in factories inside of the EPZs, said Nazma Binte Alamgir, general manager, public relations of the Bangladesh Export Processing Zones

Authority (BEPZA), the regulating

body for the EPZs.

Under the new rules, 30 percent workers would have to ask the BEPZA, filling in a form, for the formation of the Workers' Welfare Associations, Nazma Alamgir said.

Once the BEPZA verifies the applications and allows the WWAs, there would be a referendum among the workers for holding a polls to elect WWA leaders. Workers would only be allowed to hold the polls after the referendum decides that the workers want a WWA.

However, Sirajul Islam Rony, a member of the minimum wage board for garment workers, said the amendment to the law would allow partial trade unionism in factories, not the full rights due to the provision for referendum.

"But, at the same time giving the legal status to the workers' welfare association as unions will also allow guaranteed benefits to the workers. The workers will enjoy all benefits if any factory is shut down for any reason," he said.

"We want equal labour law for workers inside and outside of the EPZs in our country," said Nazma Akter, president of Sammilito Garment Sramik Federation, a garment workers' platform. "I do not agree with many provisions in the amendment," she said.

Currently, more than 4.40 lakh workers are employed in eight EPZs across the country with 453 factories in operation. A total of 121 factories are under construction there.

There is a \$3.74 billion investment from home and abroad, Nazma Alamgir said, adding that the factories exported goods worth \$6.11 billion in 2014-15 fiscal year. The Bangladesh EPZ Labour Law,

2016, also has a provision for forming a permanent wage board for workers, said Cabinet Secretary M Shafiul Islam yesterday after the cabinet meeting held at the Secretariat with Prime Minister Sheikh Hasina in the chair. Briefing reporters, he said workers

would get various advantages, including retirement benefits, mandatory group insurance, compensation in case of deaths, cash payment for earned leave, full salary as festival bonus, and maternity leave for 16

He said the family members of a worker would get Tk 2 lakh compensation if he or she dies on duty and Tk 2.25 lakh for any worker for his or her permanent disabilities caused by

accidents at work. Shafiul said the labour organisations in EPZs would be named Sramik Kalyan Samity.

The cabinet secretary said the proposed law would ensure the right to joint wage bargaining for workers where their representatives would be able to bargain directly with the owners for fixing wages, working hours, appointments, and conditions for appointments and observing strikes.

"The law is going to be framed in light of the existing Labour Law 2006 and in line with the central bargaining agent (CBA) and trade union," the cabinet secretary told reporters.

The executive chairman of BEPZA would act as the chief of the permanent wage board for fixing the minimum wages for workers. "The wage broad, if it deemed necessary, can reorganise the wages of the workers," he added.

The government had earlier formed a committee to formulate a law in line with the Bangladesh Labour Law, 2006.

The draft law has a total of 16 chapters and 202 sections.

Flight turned back to Heathrow after 'laser' incident

A British pilots' union yesterday demanded action after a laser beam dazzled the co-pilot on a New Yorkbound flight, forcing the Virgin Atlantic jet to turn back shortly following take-off from London's Heathrow Airport.

Police responded to "reports of a laser shone in the direction of a commercial flight that had taken off at Heathrow" on Sunday night, a spokesman said.

The Airbus A340 carrying 252 passengers and 15 crew from London to New York continued over Ireland before requesting to return, flight radar showed.

A crew member told air traffic control there was a "medical issue with one of the pilots after a laser incident after take-off," according to flight radio recording.

Acting on the petitions seeking to bring sedition charges against Anam in Kurigram and Tangail, the courts there ordered local police to seek permission from the government, as required the law, and investigate the allegation. In the 11 defamation cases, courts in

Natore, Khagrachhari, Chapainawabganj and Rangpur issued summonses on Anam after taking the cases into cognisance.

In Kurigram, advocate Md Ruhul Amin Dulal, convener of district Jubo League, sought to sue Anam in a sedition case. Judge Maksudur Rahman of Additional Judicial Magistrate Court told officer-in-charge of the Sadar Police Station to probe the complaint after taking permission from the home ministry.

In Rajshahi, Abdus Salam, a public prosecutor of Metropolitan Judge's Court and president of Mohonpur upazila Awami League, submitted a plea to bring sedition charges against the editor. Rajshahi Chief Metropolitan Magistrate Court ordered the OC of Boalia Police Station to investigate the allegation.

In Tangail, advocate Joaherul Islam, general secretary of the district AL, brought sedition complaints and demanded Tk 100-crore in compensation from Anam.

Judge Md Aminul Islam of Senior Judicial Magistrate Court told the OC of Tangail Model Police Station to investigate the case after taking permission from the government and report back to it.

In Rangpur, organising secretary of district AL Motahar Hossain Moula filed a Tk 100-crore defamation case against Anam. Rangpur Senior Judicial Magistrate Shafiqul Alam summoned Anam to appear before it on March 1.

In Chapainawabganj, Ejabul Haque Buli, treasurer of Sadar unit AL, filed a libel suit against Anam. Senior Judicial Magistrate Nur Nabi issued a summons for Anam to appear before it on April 28.

In Khagrachhari, Teko Chakma, district unit president of pro-AL student body Chhatra League, sued Anam in a Tk 10-crore libel suit. Chief Judicial Magistrate Abu Sufian Md Noman summoned Anam on March

16, said plaintiff's lawyer Nazrul Islam. In Sylhet, district Swechchhasebak League President Afsar Aziz Khan filed a Tk 150-crore defamation case. Judge Kudrati Khuda of Sylhet Judicial Magistrate Court-4 ordered an executive magistrate to probe the allegation and submit a report to it in 15 days. In Sunamganj, Syed Abdul Kashem,

organising secretary of the Awami League's United Kingdom unit, filed a defamation case seeking Tk 100-crore in compensation. Judge Shahidul Islam took the suit into cognisance. In Cox's Bazar, ex-Moheshkhali

municipality mayor Sarwar Azom filed a Tk 100-crore defamation suit. Senior Judicial Magistrate Arun Pal ordered the senior assistant superintendent of police to probe the allegation and report back immediately. In Natore, Alek Uddin Sheikh, joint

Tense Indian Kashmir shuts down after civilian deaths

Indian Kashmir largely shut down yesterday as a general strike was called to protest at the killing of two civilians during a gunbattle between troops and suspected separatist militants.

Authorities also imposed a curfew in parts of the region's main city of Srinagar, where hundreds of police and paramilitary troops patrolled deserted streets and erected checkpoints to halt any protests.



FROM PAGE 1 All but Mehedi, who were present at the Cyber Tribunal, pleaded not guilty and demanded justice in the case after Judge KM Shamsul Alam read out the charges to them. The court set March 28 to start trial of the case.

On October 1, 2013, soon after the pronouncement of the verdict in the war crimes case, Salauddin's wife and family members showed "a copy of the verdict" to newsmen and claimed that it was leaked.

Three days later, detectives filed the case with Shahbagh Police Station against Fakhrul, Mehedi, Faruk, Nayon

Foreigners in ATM fraud ring

of the central bank, told The Daily Star yesterday.

The foreign national, who installed skimmers at three ATM booths in Gulshan and Banani areas, wore a cap to hide his face. It appears that another foreigner set

up the device at another ATM booth at Kalshi in Mirpur, according to the BB official. Rafiqul Islam, assistant commissioner of Dhaka Metropolitan Police,

said an initial probe indicated the involvement of a foreigner in installing skimming devices at ATMs. Eastern Bank Ltd, United

Commercial Bank Ltd and the City Bank -- hit by ATM frauds -- have similar suspicions.

A skimmer is a small device, an illegal technology that can scan and store credit card data from magnetic stripes. Fraudsters installed the devices at

four ATMs -- two of the EBL and one each of the UCBL and the City Bank -to filch data from debit cards used in

the booths. The gang waited for a few days to copy as many card details as it could. After three to four days, it removed the

devices and cameras from the ATMs,

and then loaded the details on cloned

In these cases, the original card details were still with the users who came to know about the fraudulence through text messages on Friday.

The BB has found that more than 200 cardholders had lost data to the fraud last week. Of Tk 25 lakh stolen by the racket,

the EBL alone lost around Tk 14 lakh. However, the total figure might go up once the central bank gets details from all banks. In a case filed with Banani Police

Station, the UCBL said video footage shows that a foreigner installed a skimmer and a camera at the bank's ATM in Banani area on February 7, telling the guard at the booth that he was there to check technical faults.

The fraudsters made unauthorised transactions from various ATMs in the capital and withdrew Tk 1.26 lakh on Thursday. The total amount could be higher, said the bank.

Similarly, skimming devices and cameras were set up at two ATMs of the EBL at Gulshan-1 and 2 on February 8, transactions on February 12.

The bank said 66 transactions were made after a skimmer was installed at the ATM booth. Of the transactions, 32 were made through the City Bank cards and 34 through cards of other banks.

The City Bank has so far received claims from clients for loss of Tk 1.4 lakh, said Mashrur. The bank filed a case with Pallabi

Police Station in this regard yesterday evening. Meanwhile, the BB issued a circular yesterday, making it mandatory to

install anti-skimming and PIN shield devices at all new ATM booths. The central bank also said the exist-

ing ATM booths must be equipped with these devices within a month. It also instructed all the banks to

examine video footage of their ATM booths every day and send reports to it on a monthly basis. The national payments switch (NPS)

Pakistan varsity reopens a month after deadly attack

A Pakistani university attacked last month by the Taliban reopened yesterday guarded by hundreds of police, highlighting a pervasive atmosphere of fear after the Islamist group vowed more strikes on schools.

Gunmen stormed Bacha Khan university in the northwestern town of Charsadda on January 20, killing teachers and students in a rampage that left 21 dead.

The attack shattered a growing sense of security in the troubled region a year after the Peshawar school massacre, in which more than 150 people -- mainly
