Mirza Fakhrul defends Khaleda's remarks about number of martyrs

BNP chief Khaleda Zia's remarks on the number of martyrs during the 1971 Liberation War were "contextually correct", party acting secretary general Mirza Fakhrul Islam Alamgir claimed yesterday, without elaborating his statement.

"Awami League leaders and activists distorted Khaleda Zia's comments on the number of the 1971 martyrs to keep her off politics," he told a seminar on the "violation of the constitution", organised by the Bangladesh Nationalist British Law Students' Alliance in the capital's Supreme Court auditorium. Criticising the ruling

party leaders for calling Khaleda an associate of the Pakistan army, he said people falsely accused others when they failed to defend themselves. Pointing to the "false"

cases and remarks against Khaleda, he said AL's activities proved that the party had become politically bankrupt. On December 21,

Khaleda, in her first public address in more than a year, said, "There are controversies over how many were martyred in the Liberation War." Her comments drew widespread criticism, while many slammed her as an "agent of Pakistan" and demanded that she leave Bangladesh. She was also sued for sedition. Without giving any time

period, Fakhrul said more than 600 people were killed extra judicially, 460 fell victim to forced disappearance, and around 17,000 cases were filed against BNP workers. Last year, 4.6 lakh BNP leaders and activists were accused, he added.

Fakhrul claimed that democracy was under threat, and requested the government to hold an election after talking to BNP.

AL-led 14-party urges govt; demands trial of Khaleda, Jamaat

STAFF CORRESPONDENT

The ruling Awami League-led 14-party alliance yesterday demanded an end to diplomatic relations with Pakistan for interfering in Bangladesh's internal affairs and trial of the Jamaat-e-Islami for its alleged involvement in war crimes in 1971.

They also called BNP chief Khaleda Zia a traitor for questioning the number of martyrs in the 1971 Liberation War and demanded her trial too.

The demands were raised at a human chain, held at different points on the 14km route between Gabtoli and Sayedabad in the capital. The alliance organised it protesting Pakistan's denial of the 1971 atrocities and Khaleda's remarks that there were controversies over how many were martyred in the war.

The protesters said Pakistan had overstepped the boundaries of diplomatic decency by meddling in Bangladesh's affairs and requested refrainment in the future.

Several hundred leaders and activists joined the hourlong human chain, which started at 4:00pm and created traffic congestion in different parts of the city. Though the human chain aimed to protest Pakistan's

meddling and Khaleda's remarks, there were some banners demanding immediate arrest of The Daily Star Editor Mahfuz Anam and shutdown of the newspaper.

The alliance announced to hold human chains to protest the same in the district headquarters on February 24.

teenager in a narcotic case to compel his family to withdraw a case filed against them, the family claimed yesterday at a press conference, held at the office of Crime Reporters' Association in the capital. Al Amin, an eighth-grader of Pragati High School

in the capital's Pallabi, was supposed to get admitted to the ninth grade, but he is now in Dhaka Central Jail, they added.

According to the family, drug peddlers had 14-year-old Al Amin arrested, showing him to be 21, so that they could get discharged from a murder case filed by the teenager's father.



HC printed cause lists to go on till March 31

The system of printed cause list, a roll of cases to be heard by the High Court any day, will run till March 31.

The Supreme Court authorities were set to abolish this age-old system through introducing online cause list yesterday.

Chief Justice Surendra Kumar Sinha has changed his earlier decision in this regard and asked the officials concerned to keep the printed cause list running till March 31, SC Registrar General Syed Aminul Islam

told The Daily Star. He said the chief justice changed the decision at the request from the SC lawyers.

Man links 9 of Jessore to killing of father, brother

Tribunal orders ads for surrender of Kishoreganj fugitive suspect Syed Hussain

A prosecution witness yesterday linked nine men of Jessore, including former BNP and Jamaat-e-Islami lawmaker Shakhawat Hossain, to the killing of his father and younger brother during the Liberation War in 1971.

Gaziur Rahman, the son of martyr Chadtulla Gazi of Chingra village in Jessore's Keshabpur upazila, narrated the killings before the International Crimes Tribunal-1.

He is the first witness in the case against the nine, all from Keshabpur. Shakhawat is now involved with Jatiya

Party, and in jail along with two other accused Billal Hossain Biswas of Nehelpur and Lutfar Morol of Porchakra.

The rest are Ibrahim Hossain of

Kazi Ohidul Islam of Shekhpur, Aziz Sardar of Mominpur, Aziz Sardar of Boga, and Abdul Khaleq Morol of Altapol. The nine face five charges, but the detained three pleaded not guilty before the
