Railways Minister Mujibul Haque falls sick at JS session

Railways Minister Mujibul Haque was admitted to a hospital in the capital as he fell sick while replying to lawmakers' queries in parliament yesterday evening. While reading out a scripted answer before the House, his nose began bleeding, and he requested Speaker Shirin Sharmin Chaudhury to table the rest of the answer, said the parliament sources. The minister was quickly taken to the parliament lobby, and later he was rushed to Square Hospital, said Shariful Alam, public relations officer of the minister.

South Korea to give scholarships to Bangladeshi students

NID cards to be corrected in upazilas too

Says registration wing; AL says Hasina to attest its chairman candidates of Union Parishad polls

People will no longer have to come to the National Identity Registration Wing's (NIDW) headquarters in the capital's Agargaon for corrections in national identity cards as the service will be provided from upazila election offices. "Now we are facing huge pressure at our head office...Such a huge number of applications and public gathering creates chaos...It will make the service comfortable for people," Director General Brig Gen Sultanuzzaman Md Saleh Uddin of NIDW told The Daily Star on the decision taken yesterday. NIDW, an associate body of the Election Commission (EC), corrected around 1 lakh NID cards upon receiving around 2.5 lakh applications in the last couple of months, he said. The EC has been preparing the cards along with the voter list with photographs from 2007. A large number of people who got the cards on registering as voters faced spelling mistakes and wrong information and they have been gathering at the headquarter for amendments. The gathering intensified in the last couple of months as the government's new pay scale made it mandatory providing the card number in a particular form for accessing salaries. Meanwhile in a letter to the EC, the ruling Awami League named its president, Sheikh Hasina, as the person who would attest their chairman aspirants in the upcoming union parishad (UP) polls. The EC sought the names on February 11, asking the 40 registered political parties to provide it to returning officers. The EC on Thursday announced that elections to 4,275 of the over 4,500 UPs, the lowest tier of the local government system, will be held, on partisan lines for the first time, in six phases starting March 22.

TACKLING ILLEGAL MIGRATION, TERRORISM UK to work closely with Bangladesh

Says UK immigration minister

The United Kingdom (UK) will work closely with Bangladesh to address shared issues and threats, including tackling illegal migration and organised crime, countering the risk of terrorism and improving aviation security. British Immigration Minister at the Home Office James Brokenshire said this before leaving following a 24-hour visit yesterday. Talking to Hazrat Shahjalal International Airport officials, he expressed his pleasure on hearing of the effective use of some equipment the British government donated last year to detect and prosecute use of false and counterfeit travel documents. "...we are now working together to make both of our countries safer by prosecuting the organised crime groups involved in illegal migration and human trafficking. "We hope to see a reduction in human trafficking and illegal migration as a result of this good work," said Brokenshire.

Thailand keen to get its army trained by Bangladesh

Thailand yesterday expressed interest in training its army officers in the Bangladesh Institute of Peace Support Operation Training (Bipsot) before deploying them to UN peacekeeping missions. During a call on by Bangladesh Ambassador Saida Muna Tasneem in the morning, Royal Thai Army Commander-in-Chief General Teerachai Nakwanich conveyed the interest and praised Bangladeshi peacekeepers' professionalism and leadership in UN operations. Tasneem invited the army chief to visit Bangladesh later this year and senior and mid-ranking army officers to take up courses offered by National Defence College, and the Defence Services Command and Staff College. She also urged providing short term professional training and post-graduate courses to Army Medical Corps personnel in Thai universities.

Now boy gets burned in acid attack
