The International Federation of Journalists (IFJ) has expressed serious concerns over a barrage of cases filed against Mahfuz Anam, editor and publisher of The Daily Star.

"The IFJ is seriously concerned by the legal harassment of Mahfuz Anam as [a] result of reporting in the public interest at a time of political crisis," it said in a statement on its website yesterday.

"The high number of cases and the filing of these across the country indicate an aggressive politicallymotivated effort to harass a senior editor and a key newspaper in Bangladesh."

The IFJ said the "attempts to pursue

Private recruiters against monopoly

Baira writes to PM to intervene and ensure local agencies' involvement in hiring labour

Private recruiting agencies yesterday wrote to the prime minister seeking her intervention in halting possible monopoly by a "syndicate led by a Malaysian company" in hiring Bangladeshi workers there.

They made the plea as Dhaka and Kuala Lumpur is set to sign a memorandum of understanding (MoU) in Dhaka tomorrow over recruiting 1.5 million workers -- both male and female -- in the next three years.

Bangladesh cabinet on February 8 approved the draft MoU despite a series of controversies since Malaysia last year announced that it would hire Bangladeshi workers through private sector.

"We have learned from reliable sources that in the draft agreement, Malaysian private company Synerflux Sdn. Bhd has been awarded the main job in recruiting Bangladeshi workers, including collecting job demand letters from the employers, said the letter.

Mohammed Abul Basher, president of Bangladesh Association of International Recruiting Agencies (Baira), signed the letter.

"They [the company] want to control the business [recruitment] through the syndicate. Thus, the foreign company through its syndicate members would have scopes to make profits unilaterally, and deceit [work-

DMP sets up counter terror unit

The much-sought-after "Counter Terrorism and Transnational Crime" unit under Dhaka Metropolitan Police started functioning yesterday headed by newly appointed Deputy Inspector General (DIG) Monirul Islam.

The 600-men police unit specialising in technology has been formed to enhance police capability in combating militancy and terrorism.

The unit started its journey at a time when the country has witnessed a sharp rise in deadly attacks on bloggers, publishers, different Muslim sects, foreigners, and people of other religion.




people including the publisher of a book allegedly containing elements that could hurt religious sentiments.


The arrestees are Shamsujjoha Manik, publisher and editor of the book titled Islam Bitarka (debate on Islam), its distributor and Manik's brother Shamsul Alam and printer Fakir Taslimuddin Kajol.

A Dhaka court yesterday placed the trio on remand. Manik was remanded for five days, Shamsul for a day and Taslimuddin, owner of Shobdokoli Printers, for two

Cardholders' data were copied off four ATM booths of commercial banks and at least Tk 25 lakh was stolen last week. At least two foreigners seem to be directly involved in the crime. A skimming device is an illegal apparatus that can scan and copy date stored in the magnetic strips of cards. Fraudsters installed the devices at four ATMs -- two of the EBL and one each of the UCBL and the City Bank -- to filch data from cards used in the booths.

Probe on to find ATM frauds

Various government agencies have started investigating the recently ATM frauds in Dhaka, in which cardholders lost about Tk 25 lakh, according to police and bankers.

The Rapid Action Battalion, the Detective Branch of police, the Bangladesh Bank, and the police stations concerned were probing the incident.

Rab has already taken CCTV footage from two of the four ATMs where the crime was committed, according to the banks' officials. One ATM was of City Bank and the other

was of United Commercial Bank. Even though the DB had taken the footage from two ATMs of Eastern Bank, Rab is yet to take a copy of it, accord-

ing to an official of the bank. "The case has already been handed over to the DB," Rafiqul Islam, assistant commissioner of police (Gulshan),

told The Daily Star yesterday. The DB has formally started the probe, according to a

police officer of Gulshan zone.

Even though ATM fraud is a menace in the global stage, this kind of crime is very new in Bangladesh.

The fraudsters used skimming devices at the ATMs and cloned cards using the copied data to steal money from the cardholders.

Last week, four ATMs of three banks -- two of Eastern Bank and one each of the United Commercial Bank and the City Bank -- were hit by the criminals.

The fraudsters put skimming devices to read data from the debit cards used in the booths.

They waited to get card details after which they removed the skimming devices and the camera from the ATMs.

They then loaded the details on cloned cards to make unauthorised transactions. The Daily Star got some pictures that depict two

fraudsters installing skimming devices at an ATM of City Bank in Kalshi of Mirpur.
