#### 'BCL men' of CMC beat up Prothom Alo photojournalist

After he took photos of them beating a motorcycle rider trying to pass their blockade STAFF CORRESONDENT, Ctg

A Prothom Alo photojournalist and a motorcycle rider were allegedly beaten up by some Bangladesh Chhatra League (BCL) men of Chittagong Medical College (CMC) unit yesterday in Chittagong city when the former took photos of

The rider was tailgating an ambulance crossing a blockade being enforced by the BCL men at the Probortok intersection around 2:15pm, said several eyewitnesses and local shop owners requesting anonymity.

them beating the latter.

The blockade came following a procession brought out from CMC denouncing the hacking of three fellow activists during a clash with local youths of Nasirabad in the early hours of Tuesday, they said.

The BCL men saw Jewel Shil taking the photos and four or five of them, led by CMC unit BCL President Rashedul Islam, attacked him, snatched the camera and deleted the photos, added the witnesses.

The rider managed to escape and Jewel was threatened of further beatings and humiliated in front of a gathering crowd for some 20 minutes before being released, they said. Rashedul neither

received repeated calls last night, nor answered a text message seeking comment. CMC Central Students' Union Vice President Nabid Anzum Tanvir, reportedly present on the scene, did not answer calls.

Chittagong city unit BCL General Secretary Nurul Azim Rony said, "It is a matter of great regret. If we get any complaint, we will take organisationa action against the culprits". Jewel said he would file a case.

### Father deplores bail of accused

Seeks PM's intervention for justice

The father of one of two child torture victims yesterday broke down in tears and sought the prime minister's intervention seeking a "proper trial" after three more accused got anticipatory bail from a Rajshahi court in a case he filed against 13 persons. "...police betrayed (me) filing the case using weak

charges," Emran Hossain told journalists on the court premises, adding that now his family was even more fearful over "threats of eviction" they received recently.

His son Zahid Hossain, 15, and orphan Emon Ali, 13, from Chowbaria village of Rajshahi's Poba upazila, were abducted and tortured for over seven hours on February 12.

They were confined in a house of an influential farmer, Fazlur Rahman, who accused the duo of stealing his son's cellphone. Although they protested their innocence and howled in pain, the tormentors, including an army soldier and a Rapid Action Battalion member, continued the beating.

Yesterday Fazlur, his son Rakib and their neighbour Komol got the bail from a juvenile court, granted by Judge Haider Ali Sarker of 2nd Additional Judge Court, said the victims' lawyer, Dil Sitara Begum Chuni.

On Tuesday, one Azizul Islam, who was under arrest, got bail while his son Uzzal got anticipatory bail from a lower court in violation of provisions stipulating that it must be granted by a juvenile court, she said.

Police used a bailable section and not ones for abduction and grievous injury, she added.

# Movement

140 new books hit fair yesterday

The sentiment of the Language Movement in 1952 was limited not only to the capital, but it rippled through different parts of the country, including Chittagong, where local political and cultural leaders created the "Rashtrabhasha Sangram Parishad" on February 4.

Aiming to bring together people of all strata, the Parishad distributed a leaflet narrating the discriminations of the then regime against the poor people of Chittagong.

In the leaflet, they called upon people to observe daylong hartal on February 21, 1952

over the demand of declaring Bangla as a state language. In one of his articles in a

new book, historian Muntassir Mamoon pointed out the contents of this leaflet and of seven other leaflets, which had been circulated by both the government and the Rashtrabhasha Sangram Parishad.

The contents of the leaflets were not published before; they appeared in the book "Rashtro Bhasha Andoloner Dalilpatra" (documents on the movement for state language).

Ahmed Publishing House has brought out the book, which is based on 36 documents on the Language Movement.

The book was compiled by Prof Abul Kashem Fazlul Haque and researcher MR Mahbub.

Mahbub said, "There are many books on the Language Movement, but the contents of the leaflets were not found anywhere."

The book also contains rare photographs of 1952, the US secret cable on the movement, and the proposal of Bangabandhu Sheikh Mujibur Rahman on state language. Language Movement hero Prof Fule Hossain unveiled the

book in front of stall no. 397 of Ahmed Publishing House at the Amar Ekushey Granthamela 2016. In the preface, Kashem said they tried to give a vivid description of the movement to readers through these

documents. Underscoring the need for having knowledge on history, he also said the roadmap of the future needed to be built by

analysing the past. Meanwhile, two poetry books titled "Amader Sommilito Medha Talikar Din" and "Ja Kichhu Swargiyo Chilo", by Tushar Das and Aftab Ahmad respectively, were launched at


The first book contains 63 poems and the second one 37. Both were published by Fahrenheit MCL.



#### NIKO GRAFT CASE Indictment hearing against Khaleda deferred

A Dhaka court yesterday deferred to April 12 for hearing on charge framing against BNP Chairperson Khaleda Zia and 10 others in the Niko corruption case. Khaleda could not appear before the court due to her physical illness.

Three accused, including former acting energy secretary Khandaker Shahidul Islam and Giausuddin Al Mamun, were present in the court while four others, including former law minister Moudud Ahmed, remained absent.

The Anti Corruption Commission filed the case in December 2007, accusing Khaleda and several others of abusing power to award a gas exploration and extraction deal to Canadian company Niko when she was the prime minister between 2001 and 2006.

Nur Uddin, also of Chingra village, said he along with Chadtulla, went to India in the Bangla month Ashar to train and join the Liberation War, and he took part in the war under Sector-8. He and Chadtulla returned home on the 25th of Bangla month Ashwin to meet his parents.

On Ashwin 28, accused Shakhawat, Mujibur, Khaleq, Lutfar and Billal, and Akram Hossain along with 10 to 12 Razakars came to his house, picked him up, and took him to Chingra Razakar camp, where Razakars tortured him, the 73-yearold witness said.

He said on the same day, Razakars brought Chadtulla to the same camp where they tortured the two to know about their arms and fellow freedom fighters.

On the first day of Kartik, Shakhawat, accompanied by the other accused and Razakars, shot dead Chadtulla on the bank of the Kopotakkho river, said Nur Uddin. "I saw the incident from a window of the camp." Nur Uddin said he was released from the

camp after giving a bond that he would not work against Pakistan. The tribunal adjourned the proceeding

until February 22 after defence counsels completed his cross-examination.
