# Bottle gourd farming boon for Meherpur farmers

AMANUR AMAN, Back from MEHERPUR

Hundreds of farmers in Meherpur are happy to make good profit by farming bottle gourd this year. Due to favourable weather, low labour cost and high demand, farming of the popular item is increasing day by day in the district.

According to the Department of Agricultural Extension (DAE), farmers of around 30 villages in the district cultivated bottle gourd on around 475 bighas of land this year. This is 125 bighas more than last year.

The farmers have now captured the markets across the country, DAE sources

Robiul Islam, a 43-year old farmer at Madna village in Sadar upazila of the district, has been farming bottle gourd for the last seven or eight years. This corresponfarmed bottle gourd on three bighas of land. "I have been lucky farming this vegetable," Robiul said.

According to Robiul, he went to a foreign country selling his two bighas of land 10 years back, but had to return to Bangladesh with empty hands within two

"Bottle gourd farming has given me three bighas within five years," Robiul

The official said farmers need to use fertilisers like urea, TSP, MP and gypsum, and prevents constipation.

### Motorbike lifter killed in mob beating

A motorbike lifter was beaten to death by an angry mob in Kanhor area on Dhaka-Mymensingh highway in Mymensingh's Trishal upazila on Tuesday night.

The victim was identified as Hafizur Rahman, 30, son of Nurul Islam Munshi of Vollah village in Kalihati upazila of Tangail district.

Quoting local people, Md Moniruzzaman, officerin-charge of Trishal Police Station, said the incident took place when a gang of three was fleeing after lifting a motorbike from the area around 7:30pm.

As a hue and cry was raised in the area, locals chased the gang. At one stage, the gang members opened fire, injuring a youth, the OC said.

After a long chase, locals caught one of the gang members and beat him up mercilessly. He died on the spot, police said.

However, two other gang members managed to flee the scene, leaving the motorbike, police said. On information, police

rushed to the spot, recovered the body and sent it to MMCH morgue for autopsy. Police also recovered a

pistol and the motorbike from the spot. A case was lodged with

Trishal Police Station. None was arrested in connection with the killing, the OC said.

The youth, Al Amin, 18, son of brick field labourer Tota Miah, was admitted to Mymensingh Medical College Hospital (MMCH) with bullet wounds in his back, police said.

#### ATTACK ON NOOR'S MOTORCADE

## 42 more BNP-Jamaat men sent to jail on surrender

The Additional Chief Judicial Magistrate's Court in the district ordered sending 42 more BNP-Jamaat men to jail rejecting their bail prayers after they surrendered to the court in the case for attack on the motorcade of Asaduzzaman Noor, the then lawmaker of Nilphamari-2 constituency, on December 14 in 2013.

Of the accused, 34 Bangladesh Nationalist Party (BNP) activists surrendered to the court yesterday noon while the rest Jamaat men to it on Monday, said Court Inspector Sukumar Mohonta. The BNP activists include Rafiqul Islam,

vice president of Laxmichap union unit of the party in Sadar upazila, and Sakimuddin, former president of the same union.

The Jamaat men include prime accused Abu Helal, general secretary of district unit of the party, and Abdul Malek Kazi, ameer of Tupamari union unit of Jamaat.

The attackers on the motorcade of Asaduzzaman Noor, also present lawmaker and minister for cultural affairs, killed four activists of ruling Awami League's front organisation at Ramganj Haat of Tupamari union of Nilphamari Sadar upazila.

The investigation officer of the case, sub inspector Mostafizur Rahman submitted charge sheet in Chief Judicial Magistrate's

Court on March 15 accusing the 207 people, all involved with the politics of BNP and Jamaate-Islami and their front organisations.

On the night of December 12 in 2013, several thousand BNP-Jamaat activists protesting the execution of war criminal Jamaat's assistant secretary general Abdul Kader Molla attacked the houses of minority Hindu community in several villages of Polashbari and Laxmichap unions in Sadar upazila, mentioned the charge sheet.

Upon arrival from Dhaka on December 14, Asaduzzaman Noor in a motorcade went to visit the houses of affected people and gave them some assistance.

At the time of his returning, several thousand BNP and Jamaat activists attacked his motorcade at Ramganj Haat of Tupamari union under Sadar upazila.

The attackers killed Md Khorshed Alam,

president of Tupamari union unit of Krishak

League, local Jubo League activists Forhad Hossen and Lebu and Chhatra League activist Murad Hossen. On the same night, Babul Akhtar, officer

in charge (Investigation) of Sadar Police Station, filed a case mentioning names of 14 people and 150 unnamed ones as accused. Dead bodies of first, second and seventh of the

14 named accused were found in Nilphamari and Bogra districts within a few days.

Anwar Hossain Bipul, secretary of Jessore district unit of Chhatra League, claimed that their activists were not involved with the incident.



#### 4 Dakhil invigilators fined


