6 jailed for selling jatka in capital

A mobile court, backed by Rapid Action Battalion, yesterday fined a fish trader Tk 5,000, and sentenced six others to one year's imprisonment each for selling jatka (hilsa fry less than 10 inches long) in the capital's Karwan Bazar kitchen market, says a Rab press release.

The convicts are Manik Mia, Md Alamgir, Monir Hossain, Lutfar Rahman, Sirajul Islam, Kanchan and Sohel. The court led by Executive Magistrate Helal Uddin raided different wholesale shops at Karwan Bazar around 6:00am and seized around 1,100 kilograms of jatka, the release added.

BNP leader Moudud Ahmed yesterday criticised former chief justice ABM Khairul Haque as he wrote the final verdict of scrapping the 13th amendment to the constitution after his retirement and changed his short order

regarding the issue. Khairul Haque had written in his short order on May 10, 2011 that election to the 10th and the 11th parliament might be held under a non-party caretaker government as provided by the 13th amendment for national interest and welfare of the people, he said.

"But surprisingly he dropped that portion in his final verdict, which was written 16 months into his retirement," said Moudud, also the BNP standing committee member.

Addressing a discussion of the Jatiyatabadi Muktijoddha Dal at the Jatiya Press Club, he said the ex-justice had not only violated the constitution by writing the verdict 16 months after his retirement, but also set an example of immorality as a chief justice. He did that to fulfil a

political motive and deceived the nation; he will have to stand trial for this, he said.

The Supreme Court yesterday asked BNP acting secretary general Mirza Fakhrul Islam Alamgir to explain his comment on the judiciary through his lawyers by February 22, Sagir Hossain Leon, a lawyer for the BNP leader, told The Daily Star. He said different newspapers reported that Fakhrul, while

addressing a party meeting in Sylhet on February 7, alleged that the government was trying to control the judiciary. Yesterday, the apex court asked for the explanation on

The five-member bench headed by Chief Justice SK Sinha fixed February 22 to pass orders on the pleas.

Meanwhile, Attorney General Mahbubey Alam prayed to the SC to issue a guideline for the media to curb any adverse comments on judiciary in talk shows on television channels. The court is yet to say anything about the prayer.

On November 24 last year the HC granted bail to Fakhrul for three months in the cases on his health ground.
