A Dhaka court yesterday granted BNP standing committee member MK Anwar bail in a case filed for an arson attack that killed a policeman near Matsya Bhaban in the capital last year.

A metropolitan magistrate passed the order after the BNP leader surrendered before it seeking bail in the case. Anwar was accompanied by his lawyer.

Thirteen policemen, including Constable Shamim Mia, were severely injured while trying to escape a petrol bomb attack on a police bus near Matsya Bhaban intersection on January 17 last year during the BNP-led alliance's threemonth blockade. Shamim later died at Dhaka Medical College Hospital. Police filed a case against MK Anwar, Ruhul Kabir Rizvi, Amanullah Aman and 23 others for their alleged involvement in the attack.

After an investigation, Sub-inspector Dipak Chandra Das of Detective Branch of police on June 8 submitted a charge sheet, from which names of 26 BNP leaders and activists, including MK Anwar and Rizvi, were dropped while only seven people, including BNP leader Habibunnabi Khan Sohel, were charged.

Later on September 10, the court directed Criminal Investigation Department (CID) to probe into the case as it found flaws in the probe by detective branch of police.

Cops rescue shackled 14-yr-old in N'ganj

He was used in forced factory labour

A 14-year-old worker was tortured and kept in shackles for almost two weeks inside a factory in Narayanganj and was forced to work by his employer.

On February 22, police arrested Akhter Hossain, owner of a Jamdani factory at Dakkhin Rupasi, in Rupganj and rescued Ansarul Islam, hailing from Hatibandha upazila of Lalmonirhat.

Ansarul has been working for Akhter for a couple of years. He wanted to quit his job since Akhter did not pay his last few months salary. When he approached his employer, much to his surprise, Akhter demanded Tk 50,000 from him before letting him leave. On February 9, Akhter shackled his legs and made him work in the factory, said ABM Mehedi Hossain, officer-in-charge (investigation) of Rupganj.

"I just asked for my salary as I wanted to go my village. Rather than paying me, he put me in chains and demanded money. He even threatened to kill me," said a relieved Ansarul, who is now undergoing treatment at a local hospital.

"I went to see my brother on February 19," said Anawar Hossain, elder brother of Ansarul, adding, "Akhter pushed me to the ground and started scolding and sought Tk 50,000 from me. He threatened that he would sell Ansarul." To save his brother, Anawar filed a case. Akhter gave a confessional statement in a court yesterday.

Why Fakhrul's bail extension petitions were dropped from cause list

SC directs registrar general to probe STAFF CORRESPONDENT

The Supreme Court directed its registrar general to probe why the bail petitions of BNP's Acting Secretary General Mirza Fakhrul Islam Alamgir were not included in its yesterday's cause list. The apex court on

February 22 fixed yesterday for dealing with Fakhrul's petitions seeking extension of his bail granted by the High Court in three separate arson and vandalism cases. But, the petitions were not included in yesterday's cause list, Attorney General Mahbubey Alam told The Daily Star.

SC Registrar General Syed Aminul Islam told The Daily Star last night that his office was yet to get any order from the apex court.

The HC on November 24 last year granted three months' bail to Fakhrul in the cases filed in January last year.

The BNP leader recently filed three petitions with the SC seeking extension of his bail in the cases.

On February 18, during hearing on the petitions, a five-member SC bench headed by Chief Justice

Pedestrian dies being crushed between buses in capital

A pedestrian was killed after being sandwiched between two buses in the capital's Azimpur yesterday afternoon. Mohammad Russell, 24, of Savar was standing in

front of a parked bus when another bus driver of Falgun Paribahan tried to speedily pass it and Russell got sandwiched between the two vehicles. Seriously injured Russell was rushed to Dhaka Medical College Hospital where doctors pronounced him dead.

Kabir Hasan, who was with Russel, said they came from Savar in search of a job as a cook at the Police headquarters mess. They stood there to board a Savar bound bus for Savar. Police said they seized the bus of Falgun Paribahan but the driver fled.

Janitor found dead in capital

A cleaner of Eastern Bank was found dead in its office in Motijheel yesterday. Police recovered the hanging body of Jahangir Alam,

27, of Mugda, from the storeroom. The body was sent

to Dhaka Medical College morgue for an autopsy. Inspector (Investigation) of Motijheel police Proloy Kumar Saha told The Daily Star that a note was found

in Jahangir's pocket, where he mentioned about his frustration over his job. Police arrested one Omar Asish Belal, who supplied Jahangir to the bank as a cleaner under his company

him commit suicide. One of Jahangir's relatives Feroz Miah, however, said there was no reason for him to commit suicide.

He claimed it was a murder and demanded justice after proper investigation.
