'GUNFIGHT' WITH COPS Murder accused shot dead

An accused in a murder case was killed in a "gunfight" between his cohorts and police in Moheshpur upazila of Jhenidah early yester-

The dead, Chhontu Mia, 23, of Lalpur village in the upazila, stood accused in a case filed for killing one of his villagers, said Aminul Islam Biplob, officer-in-charge of Moheshpur Police Station.

Chhontu was an active member of a gang which snatches motorcycles, according to police.

Police arrested Chhontu from Kushtia town on Monday afternoon. As per his statement, the law enforcers took him to Halidapara, about 20 kilometres southeast of the upazila headquarters, around 3:30am yesterday for recovering firearms and ammunition.

When police reached the spot, associates of Chhontu opened fire on the law enforcers. Police then returned fire, triggering the "gunfight", the police official said. After the gun battle, police found

the bullet-hit body of Chhontu on the spot and sent it to Jhenidah Sadar Hospital morgue for an Two constables of Moheshpur

Police Station suffered bullet wounds, he claimed. They were admitted to Khulna Police Lines Hospital.

Police also claimed to have recovered a homemade gun and six bullets from the spot.

The witness said after sometime, when he and a shopkeeper Khandakar Abdul Razzak headed for home, those Razakars intercepted them, and at that time, Aziz heard Ibrahim asking the boy "to get ready".

Then Ibrahim asked the two of them to take the boy to the ferry ghat of Chingra Bazar but when they refused, Ibrahim and Aziz (son of Ful Sarder) hit them with the rifle butt, the witness said.

When they took the boy to the ferry ghat, Shakhawat asked his accomplices, "You are yet to kill the boy?" Shakhawat then took a rifle from Ibrahim and shot the boy.

When Ibrahim and Aziz beat them again, they threw the body into the nearby river, said the witness, adding that later they learnt the name of the boy, Abdul Malek of Hijaldanga; he was killed because he used to supply information about Razakars to the

freedom fighters. The case proceeding was adjourned until March 2 after the defence completed his crossexamination.

none of the offenders could be identified or arrested. Earlier on January 27, the DB

According to detectives, the arrestee during primary interrogation confessed to his involvement in the sexual harassment. He was later placed on two-day remand for interrogation. Kamal is among the eight people

recording his confessional statement. But he refused to confess and was later sent to jail. At least 20 women were sexually harassed in the span of an hour,

incident and demanding immediate arrest of the culprits. Shahbagh police on April 15 last year filed a case in this connection.



"The Government of Bangladesh's commitment to rooting out militancy is demonstrated by the recent arrest of suspects involved in these incidents and by the counter-terrorism raid in Dhaka, which lead to the seizure of bombs and bomb-making materials," Bernicat added.
