### Bacchu, 27 bankers behind loan scam

56 organisations also involved, Muhith tells JS on BASIC Bank

STAFF CORRESPONDENT

Twenty-seven bank officials, 56 organisations and eight surveyor firms were involved in the BASIC Bank loan scam, Finance Minister AMA Muhith told parliament yesterday.

Replying to lawmakers' queries, he said external audit firms appointed by Bangladesh Bank and BASIC Bank found involvement of Abdul Hye Bacchu, a former chairman of the state-owned bank, in granting irregular loans, recruitment and promotion.

The minister informed the House in details about the swindling of around Tk 4,500 crore in the bank.

Other officials involved in the scam are former BASIC Bank managing directors AKM Sajedur Rahman and Kazi Faqurul Islam, former additional managing director Sheikh Monjur Morshed, deputy managing directors Fazlus Sobhan and Kanak Kumar Purakayastha, suspended deputy managing director A Monayem Khan, deputy managing director M Selim, general managers Joynul Abedin Chowdhury, M Mozammel Hossain, M SEE PAGE 11 COL 2

#### Two 'Shibir men' held, 55 bombs seized

Police file case against the duo

Police yesterday detained two alleged Shibir men and recovered 55 crude bombs and bomb-making materials from a flat at Mirpur in the capital.

The detainees are Shafi Uddin, 22, and Abdur Rahim, 20, said Shafiqur Rahman, inspector of Mirpur Police Station.

They are leaders of Dhaka College unit Shibir, he claimed.

Four hundred Jihadi books and explosive materials were also recovered from the flat in Dakkhin Pirerbagh area around 7:30pm, the police official

Liton Sharif, an assistant sub-inspector of the station, said they raided the flat on a four-storey building on information and detained the two.

# Investigate further BNP questions EC fairness in UP polls

25 AL candidates set to be elected chairman unopposed; no BNP candidate in 70 unions

The BNP yesterday alleged that the government and the Election Commission are "working together" to hold the upcoming Union Parishad polls as per their will.

The party alleged that some 100 of its chairman aspirants faced obstruction from ruling Awami League men while filing their candidacy on Monday, but the EC did not take any action.

In response, Election Commissioner Zabed Ali said, "It is painful if anyone created obstruction for others in submitting nomination papers."

Some 25 AL-nominated chairman aspi-

rants are meanwhile set to be elected unopposed.

In the first phase, polls to 738 UPs would be held on March 22. The deadline for filing application expired on Monday.

For the first time in Bangladesh, elections to the post of chairman will be held in partisan lines and 16 political parties, out of 40, are contesting the polls.

Addressing a press briefing yesterday, BNP Joint Secretary General Rizvi Ahmed alleged that at least 100 of its chairman aspirants faced obstructions from AL men while filing nominations in different districts, including Bagerhat, Jhalakathi,

## 'Coming home'

Topu told his wife by phone minutes before being hit and killed by police vehicle plying wrong side of road

The youth was quite popular among his peers.

His life was cut short after a police vehicle going the wrong way ran him over on his motorcycle in the city's Kakoli area on Monday.

The father of a four-month-old boy, Riazuddin Topu secured a job at a mobile phone company only two

Riazuddin Topu weeks ago. The 26-year-old was returning to his Purbo Tejturibazar

home after attending a company event at Radisson Blu Hotel, said his cousin Afsana Afroz.

"Topu called his wife around 3:00pm to inform her that he was on his way home," she added.

After hearing about the incident around 3:45pm, some family members rushed to Kurmitola General Hospital, only to find Topu dead.

The pillion passenger, a colleague of Topu, was also injured in the crash. Police had sent the two bikers to the hospital.

Meanwhile, protesting the death of Topu, a final year BBA student at ASA University, several hundred students of the institution blocked part of Mirpur Road in front of their Shyamoli campus yesterday. The demonstration obstructed traffic in the area for about two hours.

The agitating students demanded the government ensure exemplary punishment for those responsible for the
