

# DU Sufia Kamal Hall residents demand resignation of provost

**Inform VC about 'mismanagement'**

Around 50 students of Sufia Kamal Hall of Dhaka University yesterday informed the vice chancellor of several problems due to "mismanagement" at the dormitory and demanded resignation of its provost.

Earlier, they staged a sit-in for over nine hours before the residence of VC AAMS Arefin Siddique to meet him on the issue.

A written complaint submitted to the VC reads, "We, the general students of Sufia Kamal Hall, have been suffering from various problems due to mismanagement for a long time. We have informed the hall administration but to no avail."

"There is mismanagement in the seat allotment process and sometimes legal residential students are threatened that their seats will be cancelled. Attempts are made to grab their seats and they are mistreated. The administrative building, reading room and the television room are used as 'illegal mass living' rooms. Legal aspirants do not get seats, although they are available."

The security arrangement is poor at the dormitory. There is an inconsistency in the price of food and its quality, it reads.

Although the students informed the provost of such mismanagement, she did not take any step in this regard, it says.

Provost Nilufar Nahar, however, denied the allegation. "We have only 1,320 seats, but more than 1,700 students

# Trader shot, robbed in capital

Muggers snatched away Tk 80,000 from a trader after shooting him in the right leg in the capital's Bangshal yesterday.

The victim, Mohammad Yusuf, 38, a trader from Chandpur, came to Dhaka to buy machinery equipment for his workshop.

When he reached Suritola by a rickshaw, four muggers attacked and robbed him, said Sub-inspector Mizanur Rahman of Bangshal Police Station.

Locals rushed him to Dhaka Medical College Hospital for treatment, he said.

None was arrested in connection with the incident.

# Menon slams EC for failing to ensure fair polls

Workers Party President and Civil Aviation Minister Rashed Khan Menon yesterday in parliament sharply criticised the Election Commission for not playing its due role in arranging fair elections.

"Despite having enough power, the Election Commission has failed to play its due role in holding fair elections to local government institutions," Menon said, while participating in a thanksgiving motion on the president's speech.

Lambasting EC, Menon said during the last municipal elections, there were different allegations, including stuffing of ballot boxes on the eve of voting day, and occupation of election booths. "But the Election

Commission did not pay heed to any complaints," he added.

Menon said now there were allegations of obstructing even candidates from his political party from filing nomination papers in the upcoming Union Parishad elections.

"But the EC is totally unwilling to take the matters into account." He quoted EC as saying they would not be able to maintain the election schedule if they started addressing complaints raised by candidates.

"But I would like to ask which is important? Holding a free and fair election or to maintain the election schedule?" he quipped.

"If people's voting rights cannot be ensured in the Union Parishad election, frustration will grip the people. And the people will lose confidence," he said.
