# Keeping media out, trial on

Public prosecutor, defence counsels refer to 'court order', ask journalists not to stay in courtroom

STAR REPORT

A Narayanganj courtroom was made off limits to journalists as the recording of witness testimonies began in the seven-murder trial yesterday.

Referring to a "court directive", the public prosecutor and counsels for the accused said journalists cannot attend the proceedings. Police then asked the newsmen to leave the courtroom.

Journalists present there complied with that but their community in Narayanganj condemned it, saying it was "unprecedented."

The incident also created concerns among victims' families and their counsel about fairness of the trial. They expressed doubts about getting justice in the absence of the media in the courtroom.

Talking to reporters later, PP Wajed Ali Khokon insisted that he asked the journalists to leave the courtroom as per the "court directive".

But Law Minister Anisul Huq said the public prosecutor has no right to say this. "If the court feels, the presiding judge can pass an order to this effect in the open court," he told The Daily Star.


Contacted, Abdul Khaleq, administrative officer of the court, said he was not aware of any order passed by the court prohibiting journalists from attending the proceedings. "Had the court passed any such order, I would have known," he added.

The trial proceedings, previously billed for February 25, had to be deferred to yesterday as key accused Tareque Sayeed Mohammad was not produced before the court. The public prosecutor then said Tareque was undergoing treatment, the

prison authorities did not produce him. The court asked the authorities concerned to make sure that Tareque


Sayeed is brought to the court on February 29, if necessary, by an ambulance.

### Killers of children to be punished

Warns PM at Sangsad, blasts 2 dailies for 'writing against her for 20 years'

Voicing serious concern over the sudden rise in child killings, Prime Minister Sheikh Hasina yesterday hoped court would hand down capital punishment to the perpetrators of such crimes so that no one dares to harm children.

She urged people to be vocal against oppression of children and help law enforcers arrest the oppressors.

The premier made the call in her speech, wrapping up the 9th session of the current parliament with Speaker Shirin Sharmin Chaudhury in the chair.

Hasina, also the leader of the House, slammed the BNP and the Jamaate-Islami for "carrying out terrorist activities" to resist the 2014 national election, and for post-polls violence in 2001.

Labelling the BNP as a militant organisation, she alleged that the BNP and the Jamaat are involved in militant and terrorist activities and resorted SEE PAGE 10 COL 5

## Asia Cup over Provide personal info by March 15

DMP asks Dhaka city dwellers, makes public its 'central database' plan to curb crimes

The Dhaka Metropolitan Police yesterday announced that it had been collecting "identification information" on landlords and tenants since November last year and asked all to provide the information by March 15.

It is part of an effort to create a central database of city dwellers and their service staff and the move is intended to curb crime and create a "sustainable security measure", said Commissioner Asaduzzaman Miah at a press briefing held at the DMP Media Centre.


He asked the city dwellers to fill in certain forms and submit them to their local police station.

Asked why the delay in making the announcement, a police official said they were busy with other programmes and events and that they could not manage the time to hold a press briefing for this earlier.

Referring to recent raids at different city parts, the DMP boss claimed that militant suspects took cover in the city in disguise of tenants and attempted to commit subversive activities.

There were instances in which suspects moved out of their homes safely after committing a crime and moved into a new one.

### SC cautions Fakhrul over comment on judiciary
