some time to find a school place, but "they didn't take my child because of this AIDS fear".

"I protested and nothing happened, even I found it difficult to get any work."

After her case was reported by BBC Sinhala earlier this month, the educational and human rights authorities became involved, and last week one school was ordered to take in the child.

Despite both her and her son holding certificates showing they are not infected, parents immediately began putting pressure on her to remove him, but she refused.

"He went to the class and played with other kids, but then suddenly all the parents came and took their children away," she told the BBC.

His class teacher, who stayed with him at school, said she felt "very sad when the child asked me why all my friends are leaving because of me, and why the police and others are here".

She said even though other children had treated him normally, "I am not sure how the children will react even

when they come back".

The regional education director, Saman Wijesekara, said parents of all 186 pupils had formally asked to stop attending the school.

"We are thinking of having an educational session to parents to solve this issue," he said.

The school head has closed the school for two days but BBC Sinhala reporters say angry parents have been standing at the school gate and protesting to officials and teachers

who enter. Meanwhile officials from the Sri Lanka Human Rights Commission have been to the school and have also

visited the boy's home. Sri Lanka is considered to have a very low prevalence of HIV, the virus

that causes Aids. According to UN figures, in 2014 there were 3,200 adults and 100 children living with HIV, fewer than 0.1%

of the population. But there is also concern about poor awareness of the virus and how it spreads, which leads to stigma and discrimination.

Based on their information, Rab arrested two more traffickers, Amir Hossain and Hasan Khondhoker, from

Jatrabari area in the capital on Saturday night and rescued Shirin from their custody. The next day, Rab arrested three more traffickers, Habib, Milton and Samad, who mainly communicate

with their Indian counterparts from

Benapole bordering areas in Jessore.

Another trafficker, Mamun Mirza, was arrested in Paltan of the capital, and later on the basis of his information, two victims, Sharmin and Riya, were rescued from Keraniganj. Replying to a query, Mufti Mahmud

said they had found the location of Sabina in India and steps were being taken through consultation with Interpol for her return.

The Rab official said the gang had district and upazila level agents who used to lure poor people, mainly females, with the promise of high

salaried jobs abroad. Those who agree to their offers are taken to the capital and kept confined

for days or months. Later, the traffickers in their convenient time send the victims to neighbouring countries in exchange for money.

Rab officials said most of the trafficked females were forced to be sex slaves in foreign land.

A special tribunal in Habiganj yesterday ordered attaching the assets of the accused on the run, including Harris Chowdhury, in the SAMS Kibria murder case.

Judge Atab Ullah passed the order

after yesterday's hearing in the case, Public Prosecutor Sirajul Islam told The Daily Star. Five people, including Kibria, were killed and 70 others injured in a grenade attack on a public meeting held

by Awami League at Baidder Bazar in Sadar upazila on January 27, 2005. On June 2 last year, the case was transferred to Sylhet Speedy Trial Tribunal from the Habiganj Chief Judicial Magistrate's Court for its

On September 13, the court framed charges against BNP leaders Lutfozzaman Babar and Harris Chowdhury and 30 others in the case. Among the 32 accused, 22 including Babar and suspended Sylhet city mayor Ariful Haq Chowdhury were produced before the court on that day.

Eight of the accused are on bail, while 10 others, including Harris, political secretary of the then prime minister Khaleda Zia, have been absconding.
