The authority is yet to start repair work of Sona Masjid Parjatan Motel in Shibganj upazila under Chapainawabganj, three years after men of Jamaat-e-Islami and its student wing Islami Chhatra Shibir badly damaged the motel.

Built by Bangladesh Parjatan Corporation beside the historic Sona Masjid, also near Sona Tk 5 crore, the motel was scheduled to be inaugu-

tional due to lack of repair after the vandalism.

Consequently, tourists and businessmen coming to the area are facing residential problem and the government is deprived of huge

Scared, Tawhidul jumped from the roof and died on the spot, said locals.

The Jamaat-Shibir men, who came from neighbouring villages, also attacked the nearby Solar Power Plant at Pirijpur.

Khairul Islam, contractor of the motel building, said the authority informed the ministry concerned for sanction of fund for repairing the motel but to no effect so far.

Jahidul Islam, deputy commissioner of Chapainawabganj, said he has sent a letter to the chairman of Bangladesh Parjatan Corporation for repairing the motel immediately.

Teacher suspended on sexual harassment charge

The headmaster of Udakhali Government Primary School in Fulchhari upazila of the district has been suspended on charge of sexually harassing a girl student of Class V.

The deputy director of the Primary Education Directorate, Rangpur Division, issued the suspension order against headmaster Aynal Huq yesterday through email message to the Fulchhari upazila education officer. He took the action as per a report sent to him by the district education officer.

Creative method still ineffective

FROM PAGE 16 The officials and even the education minister on many

occasions attributed the overall improvement of education, especially the gradual increase in the pass rates in SSC exams, to the creative method of teaching.

However, the report reveals that teachers of 1,105 out of the institutions surveyed bought question papers from teachers' associations, defying the government order not to purchase question papers.

The government introduced the much-talkedabout "creative question method" to discourage the age-old tradition of learning by heart.

At present, the modern method is being followed to teach all subjects except Bangla 2nd, English 1st and 2nd and mathematics.

"In order to make creative question method successful, collecting question papers from outside should be prohibited completely," DSHE said in the acquiring efficiency, he said. report.

many teachers are yet to adapt to the method, some teachers tend to be restricted to the orthodox method of teaching and learning pro-

cess, an official of DSHE said. "They seek help from guidebooks and notes to prepare questions, which is also a barrier [to the implementation of the method]," added the official who wished not to be named.

Teachers need vast knowledge about the subjects to go well with the modern teaching method but they are reluctant to work hard, he said.

"To prepare questions in creative method, teachers need to be creative first and give classroom lessons creatively and interactively so that students can use their cognitive thinking," noted educationist Prof Siddigur Rahman told The Daily Star.

The number of such creative teachers in Bangladesh is limited, he added. Prof Siddiqur, a former

teacher of the Institute of Education and Research of Dhaka University, found some weaknesses of the training in the method.

The duration of training sessions arranged so far is insignificant and the way teachers have been trained does not help them much in

"Creativity does not have Apart from the fact that any limit, but in Bangladesh we have given a structure to it. What we are following is partial creative."

acknowledged the practice of schools' buying question

The practice existed even before the creative method was introduced, he said by phone, adding that the ministry was taking steps to stop it.

More training sessions will be organised to help teachers, Nahid said.

Many teachers said they found it difficult to prepare questions for lack of reference books and relevant literature.

"The schools do not provide us with any reference book. It is not possible to set questions efficiently after only one training session," said a teacher of Khulna Zila School, seeking anonymity.

He added that the district and upazila education officers did not have any mechanism in place to monitor whether teachers were applying the method.

A teacher from Mymensingh said schools bought questions to cut The cost of composing

questions on computers and printing them is higher than buying question papers. Therefore, many schools in rural areas buy

them, he said. The objective of introducing the method will be achieved only if teachers prepare question papers on their own, according to the

report.

"Necessary steps should be taken so that teachers of every school set questions in creative method," DSHE said suggesting more training of teachers.

conducted within two weeks as the medical board expressed satisfaction with the improvement in his right hand, Samanta Lal Sen, coordinator of the National Institute Burn and Plastic Surgery, told The Daily Star.

For over ten years, Bajandar, 26, has been suffering from epidermodysplasia verruciformis, a rare skin disorder commonly known as the tree man illness, which covers limbs with warts, making them look like a tree branch.

Samanta Lal said it will take at least one year to release Bajandar from the hospital. Prof Abul Kalam, who is

leading the team, said the doctors are aiming to bring usability of Bajandar's hands but the hands may not resemble those of a normal person. "We hope to reach our

goal in stages of procedures for refinement," he added.

With no use of his limbs, Bajandar, believed to be the fourth man in the world with tree man illness, got admitted at the National Institute of Burn and Plastic Surgery on January 30.

Accused

A Habiganj court yesterday granted three-day fresh remand for an accused in the case for killing four school kids at Sundrateki village in Bahubol upazila.

Senior Judicial Magistrate Md Kawsar Alam passed the order when police produced accused Shahed Ali before the court on expiry of his 5-day remand, said advocate Triluk Kanti Chowdhury. A total of six people have so

far been arrested in connection with the gruesome murder of the four school boys.

Of them, Jewel Miah and his younger brother Rubel Miah made confessional statements before the court under Section 164 of the Code of Criminal Procedure. Meanwhile, another

accused, Bachchu Miah, was killed in a gunfight with Rab at Deorgach in Chunarughat of the district early Thursday.

Four schoolboys, who had gone missing from Sundrateki village in Bahubal upazila on February 12, were found buried at the village on February 17.

Housewife set ablaze by mother-in-law dies in Rangpur

A Bogra court yesterday sentenced a man to death for killing wife for dowry in Shibganj upazila of the district in 1997. The death penalty awardee is Nasir

Uddin Khan, 56, son of Abdul Gaffar Khan of Maspara village in the upazila.

Judge Momtaz Begum of Women and Children Repression Prevention Tribunal-2, Bogra, pronounced the verdict. The court also acquitted three other accused as charges brought against them could not be proved. According to the prosecution, the victim,

Away in Rangpur, a housewife, who sustained 50 percent burn injuries after her mother-in-law set her on fire over a trifling matter on Thursday, died on the way to Dhaka Medical College Hospital (DMCH)

The victim is Tahmina Begum, 27, wife of Abdul Mannan of the village.

Victim's family said Mannan and his family members used to torture Tahmina for dowry since her marriage 12 years ago. Quoting locals and victim's family mem-

bers, police said Mannan locked in an altercation with his mother Alema Begum over a family issue on Thursday night.

As Tahmina sided with her husband, Alema, being furious with Tahmina, set her on fire after pouring kerosene on the body. Hearing Tahmina's scream, neighbours rescued her and rushed her to Pirgachha

Upazila Health Complex. She was taken to RMCH the same night as her condition started deteriorating. Dr Md Maruful Islam, head of burn and plastic surgery unit of RMCH, said Tahmina

suffered 50 percent burn injuries. They referred her to the burn and plastic surgery unit of DMCH for better treatment. Md Aminul Islam, officer-in-charge (OC) of Pirgachha Police Station, said

Friday night, accusing Mannan and Alema. Police arrested Mannan from RMCH on

the night, but Alema Begum went into hiding after the incident. "We are trying to arrest Alema," the OC said.
