Uncle, niece killed over 'affair'

A man last night strangled his wife and then stabbed her uncle to death over her alleged affair with the relative in Eyakubnagar area of Chittagong, police claimed.

Md Hridoy first strangled Asma Begum, 25, in their own home and as he was leaving the scene he came across her uncle Maksudur Rahman, 35, at a nearby tea stall, said Officer-in-Charge Md Jasimuddin of Kotwali Police Station.

Hridoy then stabbed Maksud. The two were taken to Chittagong Medical College Hospital around 9:45pm but the doctors there declared them dead on arrival, said Nayek

Pankaj Barua of CMCH police outpost. Maksud and Asma hail from Firingi Bazar of the city.

"Hridoy is on the run and the police were trying to arrest him," said Jasimuddin.

US state dept releases last batch of Clinton emails

The US State Department on Monday made public the final batch of emails taken from a private server which former secretary of state Hillary Clinton controversially used during her time in office.

The email scandal has been seized upon by Clinton's Republican opponents and is among the adverses she is battling in her otherwise very promising campaign to become the 2016 Democratic presi-

dential nominee. State Department spokesman John Kirby said the final batch of roughly 3,800 pages brings the total released to more than 52,000 vetted and in

some cases partially censored pages of official correspondence. Last year, it emerged that Clinton had used a private server and nonin office for secretary of state. Her

official address for all her email while rivals cried foul, suggesting she may have been illegally covering something up.

Clinton protested that none of the mails had been marked "classified" when she sent them. Over recent months, government lawyers have combed through the stack, retroactively investigating whether any mail contained information that should have been classified, and found several that raised ques-

(equivalent to 1 million tons of TNT, or 66 Hiroshima bombs), would be enough to obliterate the asteroid, reducing it to a cloud of gas and liquid droplets, leaving a few small solid fragments no more than 10 metres in diameter.

Importantly, they also found it would be best to destroy the asteroid in a pre-emptive strike, rather than waiting until it was heading straight for Many potentially dangerous aster-

oids pass by the Earth multiple times, in long orbits. Blowing up the asteroid when it was heading away from Earth would reduce the possibility of the fragments hitting us. Astrometry expert Tatiana

Galushina said: "Previously, as a preventive measure, it was proposed to destroy the asteroid on its approach to our planet, but this could lead to catastrophic consequences - a fall to Earth of the majority of the highly radioactive

fragments."

the destruction will fly forward."

"For 10 years after the explosion an insignificant number of fragments will fall to Earth. Their radioactivity during this time will be reduced considerably, and after a few years they will not pose a danger," she said.

Galushina pointed out that using nuclear weapons in space is against the terms of the Outer Space Treaty. However, she believes that in the case of a "real threat to humankind," an exception to the rule would be The Tomsk astronomers are not the

only Russian scientists focusing on this area of research - in January, experts from the Russian space agency took part in a pan-European study which looked at the possibilities of using nuclear weapons to save the Earth from a deadly asteroid strike.

The girl's mother smelt of the pesticide in her daughter's mouth after returning home. The baby was taken to Abhaynagar Upazila Health Complex and later shifted to Khulna Medical College Hospital. She died there on Monday morning, the OC

Police recovered the body and sent it to Jessore Medical College Hospital morgue for an autopsy. The girl was buried yesterday after the autopsy. A case was filed in this connection.

Panchagarh, said Babul Akhter, officerin-charge of Debiganj Police Station. Criminals slit the throat of Jogeswar Dasadhikari, 50, a priest of

the Cognisance Court-2 of

Sri Sri Shonto Gaurio Temple, at Sonapota of Debiganj early on February 21. They fired shots and exploded homemade bombs while fleeing, leaving devotees Gopal Chandra Roy, 35, and

Nirmal Chandra Roy, 40, injured. At night that day, Jogeswar's elder brother Rabindranath Roy filed a murder case with Debiganj Police Station, accusing three unidentified people of the murder. Debiganj police also filed a case under the
