# JMB gives death threat to Panchagarh PP

Jama'atul Mujahideen, Bangladesh (JMB) yesterday issued a death threat through a letter to Aminur Rahman, public prosecutor (PP) of Panchagarh, who has been conducting the case filed for killing of a priest in Debiganj upazila under Panchagarh district on February 21.

The letter, with JMB written at the bottom, threatened to bid Aminur farewell from earth for ever.

Aminur Rahman filed a General Diary (GD) with Panchagarh Police Station the same afternoon. The PP said JMB threatened to kill him as he was conducting the sensational priest killing case.

Contacted, Mominul Islam, officer-incharge (OC) of Panchagarh Police Station, told this correspondent that they will investigate the matter.

Criminals slit the throat of Jogeswar Dasadhikari, 50, a priest of Shri Shri Sonto Gaurio Temple at Debiganj's Sonapota, on February 21. Two devotees were injured as the criminals fired shots and exploded homemade bombs while fleeing.

A day later, police arrested three suspects -- Khalilur Rahman, Jahangir Hossain and Babul Hossain -- and produced them before a court, which sent them on 15 days' remand.


Khalilur, 55, of Bhauaganj village under Debiganj upazila, was sent to jail yesterday.

Based on information gleaned from them, police conducted raids on February 25 and arrested the three 'key suspects, including Alamgir Hossain, 35, son ofz Rafiqul Islam of Kamar Para; Ramzan Ali, 22, son of late Abul Khair of Kilganj Masjid Para; and Hares Ali, 35, son of late Mozammel Huque of Kalirdanga Shothapara village of the same upazila.

Police also seized a Japanese 9mm pistol a US-made pistol of 7.65 bore, three cocktails, five bullets, three magazines, three knives and a blood-stained machete.

Later, they were produced before a court which placed them on 15 days' remand.

The court sent Alamgir Hossain, 35, to jail on Tuesday. He gave a confessional statement under Section 164 at the court regarding his involvement in the priest killing.

According to the case statement, Rubel and Sujon called Sabuj, 23, of the same village on September 9, 2011. They later killed Sabuj by slitting his throat, dumped his body near Mirpur Railway Station and took away his motorbike and cellphone. Sabuj's body was found the following

morning. Victim's uncle Monirul Islam filed a case with Mirpur Police Station, accusing Rubel and Sujon on the day. On September 18, police arrested the two and recovered the bike and cellphone from their possession.

# Four months over, no charge sheet yet

Teachers and students of five schools and colleges formed a human chain at Chourasta Intersection in Chuadanga Sadar upazila yesterday, demanding exemplary punishment to the killers of Shihabuddin, a Class III student of Kutubpur Government Primary School in the upazila.

Addressing a rally at the venue, the speakers demanded that the police administration submit the charge-sheet in the killing case soon.

Shihab, 9, along with his playmates went

to the school playground in the afternoon of October 28, 2015, and remained missing since then. Police recovered his body from a ditch adjacent to his house on October 30.

Police arrested two people-Sultan and Abdul Alim-from the village on November 18. They confessed to their involvement in the killing.

Contacted, Officer-in-Charge Saiful Islam of Sadar Police Station said police could not submit the charge sheet in the case as three investigation officers (IO) were transferred in the last four months.
