Two minor girls were killed and six others, including a baby, injured during a storm in the capital yesterday

The dead are Karishma, 5, of Rampura, and Riamoni, 8, of Dakkhin Keraniganj.

Karishma died when a portion of an under-construction building fell on a tin-shed house in Rampura, said Moniruzzaman, sub-inspector of incident, he added.

# SI suspended for negligence

A sub-inspector has been suspended and action has been recommended against an officer-in-charge for negligence in duty in connection with the murder of four children in Habiganj.

Talking to The Daily Star, Superintendent of Police Joydeb Kumar Bhadra of Habiganj yesterday said SI Ziaur Rahman had been suspended.

The SP added that strict action was recommended against OC (investigation) Abdur Rahman of Bahubal Police

A probe body, led by ASP Shahidul Islam, yesterday submitted its report in which the suspension and punitive actions were recommended, he said.

The district police formed the investigation committee on February 22 to probe the alleged negligence in finding the children, aged between seven and 10, after they had gone missing.

The police recovered their bodies from a ditch in Shundratiki village under Bahubol upazila on February 17, five days after they went missing.

### 'THREAT TO JUDICIARY'

The Supreme Court Bar Association called on the apex court to take legal actions against the two ministers for their comments. The ministers' remarks on a sub

judice matter are a threat to the judiciary, SCBA President Khandker Mahbub Hossain told a press conference at the association auditorium.

He hoped the SC would act in this regard to uphold the image of the judiciary. Replying to a query, Mahbub said

the Appellate Division may initiate contempt of court proceedings against the two ministers. SCBA Secretary AM Mahbub Uddin

Khokon demanded removal of the two ministers, saying they broke their oath of office by violating the constitution through making those comments.

The BNP, meanwhile, termed the ministers' comments "extremely audacious and political hooliganism".

"The way Food Minister Qamrul Islam and Liberation War Affairs Minister AKM Mozammel Haque asked the chief justice to quit is a naked interference in the judiciary. Their comments have once again proved that the one-party Baksal system of 1975 has been revived with its all aggressive

Zayana and Sharlin died there later that day. Shahnawaz, a maintenance engineer at the US embassy in Dhaka, succumbed to his burns a day later.

With Sumaiya's death yesterday, Zarif is the lone survivor of the incident. He had six percent of his body burnt and now he needs skin grafting.
