Nasim calls Khaleda confused leader

Terming BNP Chairperson Khaleda Zia a "confused leader", Awami League leader Mohammad Nasim yesterday said she had ruined her party as well as BNP-led opposition alli-

"She lost to Sheikh Hasina in the area of politics as she had declared that she would not contest in the polls under Sheikh Hasina's administration, but her party is now contesting [in UP polls] with party's electoral symbol 'sheaf of paddy'," he said.

The health minister and AL presidium member was addressing a discussion on "Bangabandhu's March 7 Speech and Our Independence", organised by the Bangladesh National Alliance (BNA) led by former minister and BNP leader Nazmul Huda at Supreme Court Bar Association.

Nasim appreciated Nazmul Huda and others of the alliance who left BNP, saying Huda had done a good job as he left the party.

Civil Aviation and Tourism Minister Rashed Khan Menon said Bangabandhu's March 7 speech was one of the best in the world that gave a clear declaration of war.

Menon lambasted Khaleda as she made controversial remarks on the number of martyrs of the Liberation War. Such remark is only

possible for them who do not believe in independence of Bangladesh and had no relation to the Liberation War, he added. Nazmul Huda, convener

of Trinamool BNP, read out a keynote paper on Bangabandhu's March 7 speech, saying the war was carried out in the name of Bangabandhu Sheikh Mujibur Rahman.

After the brutal attack on the Bangalis on March 26 by the Pakistan Army in 1971, Maj Ziaur Rahman announced the independence of Bangladesh on radio on behalf of Bangabandhu as he was inspired and guided by the speech of Mujib, he added.

Awareness key to ensuring legal right of insolvents

MJF-NLASO discussion on govt legal aid services told with all elected union chairmen and

Speakers yesterday underscored the need for creating awareness about government's legal aid services among insolvent people and victims so that none is deprived of legal assistance, a constitutional right. Pointing out that a huge amount

of government funds returns unused every year, they said the money would be utilised if people were aware of the services that included appointing lawyers, legal counselling, and mediation.

They were addressing a discussion titled "Partnership of Manusher Jonno Foundation in Quality Enhancement of Government Legal Aid Services: Success, Potential and Experience", organised jointly by National Legal Aid Services Organization (NLASO) and Manusher Jonno Foundation (MJF) in the capital's Cirdap auditorium.

Law Minister Anisul Huq said after the Union Parishad elections, the ministry would hold meetings

members to make them aware of the legal aid services. He also underscored the need for

collective initiatives and effective enforcement of law to change people's mindset in filing false cases; otherwise the practice would result in doubling the case backlog in the country. "In many instances, it is seen that

cases are filed to harass. It does not matter what would it result; cases are filed to make one visit the court and instil a fear of imprisonment," he said.

"I want to come out of that bad culture.'

The minister said, "If we can't come out of the evil practice, then the case backlog, which is now 30 lakh, will be 60 lakh. To reduce it to 15 lakh, we must get rid of this practice."

Saying that filing of false cases is punishable by law, he said if the law was enforced more effectively, peo-

ple's mindset would be changed. Registrar General of the Supreme

Court Syed Aminul Islam called upon people not to see legal aid services as a charity.

"Getting legal aid is a constitutional right of the insolvent people, and the government is constitutionally bound to provide the service," he said. He requested legal aid officers in

every district who would mediate disputes at pre-case and post-case

He also urged the government to take necessary steps so that people in jail could talk to their lawyers to get legal aid, which is not practiced currently.

Law professor of Dhaka University Shahnaz Huda said the concept of legal aid should be spread to the grassroots level so that poor, underprivileged people and rape and acid victims could seek

They also unveiled a book "Legal Aid System in Bangladesh and International Context", written by Senior Judicial Magistrate Jasim
