Bangladesh has opened its resident Mission in Addis Ababa, the capital of Ethiopia, on March 1 to usher newer avenues for trade and commerce, and social development.

Hanif Khan, the chargé d'affaires will be conducting the day-to-day business while Ambassador-Designate to Ethiopia M Monirul Islam is expected to join by March 15, said a foreign ministry press release.

Ethiopia is one of the first African countries to recognise Bangladesh soon after its independence. Since then the two countries have supported each others on common and mutual interests and different international forums.

Ethiopia also hosts the headquarters of the African Union, which is of importance from UN peacekeep-

15 Sylhet BCL men hurt in MC College infighting

At least 15 activists of Bangladesh Chhatra League (BCL) were injured, two by bullets, in a factional clash at MC College in Sylhet city yesterday, said police. The two bullet-hit activists, Khairul Alam

Shaheen and Ratan Gupta, were sent to Sylhet MAG Osmani Medical College Hospital. Shaheen was later taken to Dhaka.

Police said the fighting was between the factions of Raihan Chowdhury, general secretary of Sylhet district BCL unit, and Kamrul Islam, joint secretary of the unit.

Witnesses said they used machetes, sticks, iron rods, and shotguns.

A witness and student of the college said the clash was linked to Sunday's incident of an activist of Raihan's faction slapping a senior activist loyal to Kamrul.

It was about establishing supremacy on the campus, said Nizam Uddin, officer-in-charge of Shahporan Police Station.

He said the situation was under their control and reinforcements were sent to prevent further violence.

Abdus Samad, president of Sylhet district BCL, told The Daily Star that the fighting was centred on an altercation over a senior-junior issue.

SC clears way for probing 'graft' by AL MP Bahauddin Nasim

day cleared the way for the Anti Corruption Commission to investigate a corruption case filed against Awami League lawmaker AFM Bahauddin Nasim. The apex court cancelled

a High Court verdict of March 4, 2012 that had scrapped the ACC's move to probe the case, ACC lawyer Syed Mamun Mahbub told The Daily Star.

The SC passed the order after hearing an appeal filed by the ACC challenging the HC verdict, he added.

The ACC filed the case on November 21, 2007, accusing Nasim of amassing wealth worth Tk 1.83 crore without any known source of income and concealing information of wealth worth Tk 17.58 lakh.

PIR MURDER CASE IN CTG

Detective Branch (DB) of Chittagong Metropolitan Police yesterday pressed charge against an alleged activist of banned militant outfit Jama'atul Mujahideen Bangladesh (JMB) in a case filed over killing of a "Pir" (spiritual mentor) and his aide in a shrine in the port city last year.

DB Sub-inspector Santosh Kumar Chakma, also investigation officer (IO) of the case, submitted two charge sheetsone for the killing and another for using explosives--against "JMB activist" Md Sujan alias Babu to the Chittagong Metropolitan Magistrate court, said Assistant Commissioner (Prosecution) Nirmalendu Bikash Chakraborty of Chittagong Metropolitan Police.

"Pir" Rahamat Ullah, popularly known as Lyangta Fakir, 60, for being in the nude most of the time and "Khadem" Abdul Kader, 30, were killed in Lyangta Fakir Mazar at Bangla Bazar on September 4 last year.

After the killing, police quoting locals said a young man entering the shrine around 1:45pm, and later they found the "Pir" and his attendant dead with their throats slit. The criminal exploded a homemade bomb to escape the scene that injured three people, added police. He first slit the throat of Rahamat when people had gone to offer their the Juma prayers, said police. The man killed Kader when he had arrived at the scene with food for Rahamat, locals said.

Detectives arrested five JMB men, including Sujan alias Babu, along with some hand-made grenades and explosives on the ground floor of Hazi Nur Ahmed Tower in Khowajnagar of Azimpur in the city on October 5 last year.

Sujan later confessed to the killing before the court.

'JMB' man indicted Another man implicates Shakhawat in boy killing

A prosecution witness yesterday testified that former Jamaat-e-Islami and BNP lawmaker Shakhawat Hossain shot a boy dead in Jessore's Keshabpur upazila during the Liberation War in 1971.

Kamal Sarder said he learnt about the killing from his uncle Kazi Abdul Aziz.

Kamal, of Chingra village in the upazila, is the ninth prosecution witness in a case against nine Jessore men including Shakhawat and second witness to implicate Shakhawat in the killing of the boy.

Earlier, his uncle Aziz himself testified about the murder as fifth prosecution witness. He said the boy was an informer of freedom fighters.

Aziz also told the International Crimes Tribuanl-1 that he himself was tortured by Shakhawat's aides at the time of the killing. Meanwhile, the eighth prose-

cution witness, Hasan Ali Sheikh, also gave his testimony yesterday, linking four of the accused to the abduction of Miran Sheikh, who had joined the war and used to supply information to the freedom fighters.

Hasan, 91, said he had seen accused Abdul Khaleq, Ibrahim Hossain, Abdul Aziz, and Abdul Aziz (2) taking away Miran from near his home in Bangla month of Ashwin to Chingra Razakar camp.

Earlier, Miran Sheikh, also the sixth prosecution witness, said Shakhawat himself and his accomplices confined and tortured him at

a Razakar camp in Jessore during the war. The four other accused are Mujibur Rahman, Lutfar Morol, Billal Hossain and

Kazi Ohidul Islam.

The nine face five charges. Of them, Shakhawat, Billal and Lutfar are now in jail and have pleaded not guilty. The rest are on the run.

Sixty-three-year-old witness Kamal said a Razakar camp was set up at Chingra Bazar on the 15th of Bangla month of Jaistha and Shakhawat was the commander of the camp.

On the 28th of Ashwin, when he had gone to Chingra Bazar to buy something, he heard gunshots, he said.

Kamal said when he went towards the western side of the bazar, he saw accused Shakhawat, Abdul Aziz (son of Ful Sarder), Abdul Aziz (son of Ahmed Sarder), and Lutfar and others were marching towards the eastern side of the bazar and found the body of a child near the ferryghat besides the bazar.

Three days later, when he went to Chingra Bazar again, his uncle Aziz said Shakhawat killed the boy and Razakars beat him when he refused to hold the boy's hands before Shakhawat shot him. Later his uncle left the body near the

ferryghat, Kamal said. Kamal's uncle also said the name of the victim was Malek and he was from Hijaldanga village.

Accused Shakhawat and Lutfar were produced before the court yesterday. Another accused, Billal, was not produced as he fell sick. Kamal identified Shakhawat but not the other accused.

The two-member tribunal led by Justice Md Shahinur Islam adjourned the proceeding until March 15 after defence counsels completed cross-examinations of the two witnesses.

Dhaka Zoo reclaims grabbed lands

week Bangladesh National Zoo authorities have taken initia-

tives to set up walls at points that were missing boundaries.

Initiative taken to build boundary walls

Addressing a press briefing at the ministry's conference room yesterday, Muhammed Sayedul Hoque, fisheries and livestock minister, said that they have recovered the land after around 52 years.

The minister said National Housing Authority had leased 22 decimal of lands to eight plot owners around 15 to 20 years back, though it was not theirs, while the rest were confiscated by the land grabbers.

"NHA had no right to give the lease... We have asked them to bring documents before the drive but they had failed to do so," he added.

The minister said there were 13,013 feet of boundary walls and rest 5,355 feet had no boundaries for which animals and fishes were unprotected. He said they have already given the order to a construction firm to set up the boundaries. Around 186.63 acres of land belonged to Bangladesh National Zoo and the two additional acres of land, which was still confiscated by land grabbers, will also be recovered, he assured. He said with a budget of Tk 25 crore they will do some internal works like constructing roads, setting up toilets and some other works and take on a project to modernise the zoo soon.

by 10 percent of women.

Six percent of young and eight percent adult women regard technical education "stressful" and perceive it as suitable only for men. About four percent of young girls and two percent of adult females said the quality of technical education is low.

"A careful review of these barriers and appropriate programmatic actions might help in bringing more females to technical education," said the survey.

UCEP is planning to conduct a similar survey at a broader scale in eight districts.

She said the British government has a very close partnership with Bangladesh, a key part of that is their development programmes.


