International Airport, that have security lapses. The department had been pushing for upgraded security arrangements. Air-Vice Marshal M Sanaul Haque said the Caab, working with the UK

team, has been training the manpower here and it would continue for two to three more months. When the training is done and the equipment are bought, the security system would become sustainable, he added. "The UK is 100 percent satisfied

the way we have been working for the security. But, they are still in doubt whether we would be able to make this work in a sustainable manner," he added. To upgrade the security, the Caab

has already formed a 250-member aviation security force comprising people from the Air Force, Armed Police Battalion, and Ansar to ensure the security at Shahjalal International Airport.

Around 150 members have already joined the force after training, Caab officials added.

Appellate Division headed by the chief justice gave the order in a suo moto (of its own) move, before the delivery of the appeal verdict in the war crimes case against Quasem, a Jamaat leader. In the order, the court said the state-

ments of the two ministers on March 5 against the chief justice were "flagrant interference with the administration of justice, questioning the independence of judiciary". Such comments have "undermined

the dignity, prestige and authority and impartiality of the Supreme Court of Bangladesh and the office of the chief justice in the estimation of the public at large," the apex court said. Before passing the order, the chief

justice told the attorney general that the judges were stunned at the "indecent and derogatory statements" by the two ministers. Any written or verbal comments or

other acts lowering the authority of the court or interfering with judicial proceedings or administration of justice are contempt of court. If found guilty, an accused may face fine or jail sentence or both. The fine amount and the jail term are fixed by the court as it deems fit. Qamrul and Mozammel criticised

the chief justice for two days in a row, after the country's top judge expressed dissatisfaction over the "poor performance" of prosecutors and investigators in dealing with war crimes cases. 'A CLEAR SUGGESTION' On Saturday, Qamrul told a discus-

sion, "I am aggrieved by his [the CJ's] comments in the open court." He also alleged the comments of the chief justice had similarities with those

by some political parties opposing the war crimes trial. "He [Quasem] is now in the con-

demned cell, but his money is well active outside the prison.... "I have a clear suggestion ... Let there

be a bench of the Appellate Division, keeping the present chief justice out of the bench, which he now leads, and then let there be a fresh hearing of the appeal. This is my demand in clear terms. There is no other option," he said, and "humbly requested" the chief justice to accept his proposal.

Qamrul also demanded that the attorney general be excluded from the hearing of Quasem's case.

Speaking at the discussion, Mozammel said if the chief justice had indeed made such comments in the open court, he must as well know the remedy. Then on Sunday, Qamrul made

similar criticisms of the CJ, saying Justice Sinha was openly speaking in the language used by the BNP, the Jamaat-e-Islami and their lobbyists in their efforts to undermine the war crimes trial. Going even further, Mozammel said the chief justice should not be delivering the verdict in Quasem's case at all.

In her reaction, Prime Minister Sheikh Hasina said on Monday that it clear that those were not government's statements, but personal views of the two.

QAMRUL TO SEEK TIME

After the SC ruling, Mahbubey Alam told reporters that some individuals and organisations were making statements in a way as if the war crimes trial was taking place because of them, but this notion was not right. The trial of the 1971 perpetrators is

being held as part of the political decision of the government, he said. Talking to journalists about the SC

CONTEMPT, PUNISHMENT

In its verdict in the contempt of court case against the daily Janakantha last year, the SC observed that publication or other acts scandalising or lowering the authority of the court or interfering with judicial proceedings or administration of justice are contempt of court.

It said prejudice to or interference with the due course of any judicial proceeding, interference or obstruction of the administration of justice in any other manner, interference with the court's officers, parties and witnesses, abuse of process of the court and disobedience of an order of the court are among the categories of contempt of court.

In August last year, the apex court sentenced the editor and publisher of the Bangla daily and its executive editor to confinement in the courtroom for over three hours for publishing an article relating to war crimes convict Salauddin Quader Chowdhury (who was executed on November 22). It also fined the two journalists Tk 10,000

Earlier in August 2010, the SC had sentenced Mahmudur Rahman, acting editor of the daily Amar Desh, to six months in jail for running an article headlined "Chamber bench means stay order in favour of the government".

Hackers chose

Yesterday, Finance Minister AMA Muhith said the New York Fed could not evade its responsibilities over the transfer.

Wishing anonymity, a deputy governor of the BB said the New York Fed failed to do due diligence in dealing with the hacking threat.

However, the New York Fed denied that its payment systems were breached, Reuters reported on Monday.

"To date, there is no evidence of any attempt to penetrate Federal Reserve systems in connection with the payments in question, and there is no evidence that any Fed systems were compromised," said its spokesperson Andrea Priest in response to queries about the claim.

In all, the BB has around \$28 billion in foreign currency reserves. Of the sum, nearly a third is in the form of liquid assets with the Federal Reserve Bank in the US and the Bank of England. The rest is invested in bonds and gold.

A portion of the liquid assets are kept in current accounts in either of the central banks of the US or the UK to make loan repayments.

The money that was stolen was kept in a current account with the New York Fed.

At its Motijheel headquarters, the BB has a front office called Forex Reserve & Treasury Department that decides how and where the central bank's reserves will be kept and used. The decisions are sent to the Budget & Account Department, known as back office, also located at the BB office.

from the front office, the back office completes various procedures before making the final payment request through SWIFT, the global provider of

secure financial messaging. More importantly, three individuals officially known as maker, checker and

authoriser work independently before the final payment request is made. Each of the three officials work on separate computers, have passwords and

must retype any order anew to be sent.

Under a normal situation, the payment request cannot be made from any other computer even if the passwords are stolen.

After the hacking, the central bank appointed a cybercrime expert with experience of working with the World Bank. Under his leadership, a forensic expert team has also started investigations.

The team has examined the computers and related equipment and is yet to find any involvement of anyone at the back office.

It is highly likely that Bangladesh's payment system has been hacked, and it was done from outside the country, said a finance ministry official.

The team is now seeing whether the SWIFT system has been hacked, added the official

The BB has recently introduced realtime gross settlement and other modern technologies for quick service delivery -and all these systems use SWIFT.

The forensic investigation team is now looking at how the system was hacked and the money stolen.

Before anything concrete is known, the investigation has to be finished first, said the official. Bangladesh Bank Governor Atiur

Rahman said digital transactions were on the rise throughout the world and cybercrime gangs were taking advantage of the loopholes in technology to launder money. "Bangladesh is not out of bounds of

cyber attacks," he said at a conference in Habiganj on Sunday, adding that Upon receiving the payment order the entire financial sector would have to be more active in risk management. Meanwhile, the BB has succeeded in

recovering the \$20 million that flew into Sri Lanka, due to quick correspondence with a bank in the island nation. Of the rest \$81 million, a big por-

tion has been frozen following talks with two banks in the Philippines.

A BB official said the central bank would be able to recover a big chunk of the money.

This is becoming more problematic due to environmental changes and the increasing frequency of el Niño, in which the Pacific Ocean is warming up for prolonged periods of time.

"The marine creatures get confused and lost as they are dragged away on the surf from their normal habitat and end up in areas where they are unable to survive. Professor Zee added sea animals

face "increased danger with the ongoing contamination of the oceans with oil and other derivatives" spilled by oil tankers. Luckily the ending for Pereira de
