

A long, hard journey

Youth pays for master's by pulling rickshaw

Seventy-year-old day labourer Md Altaf Hossain from Nokathi village in Jhalakathi's Rajapur upazila has seven children, none of whom studied even as far as the Secondary School Certificate except one of his sons, Md Nasiruddin. Economic hardship made education elusive for the family but Nasiruddin, now 24, was determined. Unable to rely on financial support from home for his tertiary studies, Nasiruddin turned to pedal power.

"On the first day I rode rickshaw I was scared of being recognised by college classmates," he recalls, referring to the perceived indignity of the occupation. "I rode until 9 p.m. on that first day and earned Tk. 70. My first two passengers were women.

Even to hire a rickshaw was a challenge. It was after completing his Higher School Certificate equivalent alim exam at a madrasa in 2008 that Nasiruddin moved to Pirojpur town to enrol in Suhrawardi College. He was not well-known. He hadn't driven a rickshaw before. Rickshaw owners were cautious.

It took persistence before one agreed to entrust him with a vehicle. "On the third day I had an accident," he says. Fortunately he escaped serious injury.

He wasn't dissuaded. "After a few hours' morning study I'd set off on rickshaw around 10 a.m.," he says. "I rode until late afternoon which limited study time and besides, it's quite difficult to sit at a desk after rickshaw riding. But it was the only way."

SC commutes death penalty

A JMB operative's death sentence was yesterday commuted to jail until death in a case over the 2005 bomb attack on a Sylhet judge. A four-member bench of

the Appellate Division of the Supreme Court delivered the verdict after hearing an appeal filed by Akhtaruzzaman, a member of the banned militant outfit Jama'atul Mujahideen Bangladesh.

Defence lawyer Delwar Hossain told The Daily Star that the SC commuted the capital punishment of his client, considering that he was only 19 when he committed the crime.

Akhtaruzzaman made the attack on the then Sylhet Divisional Speedy Trial Tribunal judge Biplob Goswami in front of his Kumarpara residence in

US Presidential Nomination Battle

Sanders' hope alive with surprise win

Clinton suffers loss in Michigan but wins big in Mississippi; Trump wins 3 more primaries

Democratic frontrunner Hillary Clinton suffered a surprise loss to challenger Bernie Sanders in a major state primary Tuesday, as billionaire Donald Trump notched a trio of easy victories in the Republican presidential nomination race.

The former secretary of state slumped to defeat in the industrial rust belt state of Michigan, where Sanders snagged 49.9 percent of the vote compared to Clinton's 48.2 percent with almost all precincts already reported.

"This has been a fantastic night in Michigan," Sanders said shortly before the race was called in his favor.

However, Clinton handily defeated her rival in the southern Gulf state of Mississippi, thanks to a strong turnout by African-Americans.

And despite the upset, Clinton received a psychological boost by passing the half-way point in the race to reach the 2,382 delegates needed to win the Democratic nomination.

Nevertheless, even with the delegate math in Clinton's favor, Sanders's strong showing will reinvigorate his campaign, and raised questions about her ability to win key industrial states in the general election, such as Michigan, Ohio and Pennsylvania.

JCD leader killed in Pirojpur

A Jatiyatabadi Chhatra Dal leader was killed early yesterday allegedly by members of the ruling Awami League over a feud centring on the upcoming union parishad polls in Pirojpur.

The victim, Shamsul Haque Chhotto, 28, was organising secretary of the Nazirpur upazila unit of pro-BNP student body Chhatra Dal, reports our correspondent.

Shamsul, a nephew of Touhidul Islam, BNP-nominated chairman aspirant of Sheikh Matia Union under the upazila, came under attack at Raghunathpur around 8:30pm on Tuesday while he along with some of his friends were returning home from an election campaign.

With several stab injuries to the lower part of the body, he was rushed to a local hospital where he died four hours later, said police and family members.

Magical total solar eclipse

A total solar eclipse swept across the vast Indonesian archipelago yesterday, marked by ecstatic sky gazers cheering the spectacle, devout Muslims kneeling in prayer and tribespeople performing rituals.

The moon began to move between the Earth and sun at 6:19 am (2319 GMT Tuesday), and about an hour later a total eclipse became visible in western parts of the country.

The sun then went entirely dark in a broad arc right across the world's biggest archipelago nation, which straddles three time zones, before the eclipse swept out across the Pacific Ocean.



100MW more electricity from India

Bangladesh to give India 10GB internet bandwidth

Indian Prime Minister Narendra Modi is set to inaugurate supply of 100megawatt power to Bangladesh from northeastern Indian state of Tripura's Palatana project on March 23.

The same day Bangladesh Prime Minister Sheikh Hasina is scheduled to provide 10 GB Internet bandwidth to India, Tripura **Power and Communications** Minister Manik Dey told reporters yesterday.

Bangladesh has allowed transit through its land overhead equipment from mainland India to the Palatana power project, a gesture which was highly appreciated by India. The move was reciprocated by India by agreeing to supply power to its neighbour from that plant.

Talking to the reporters in Agartala, capital city of Tripura, Manik Dey said there would not be any formal function to mark the occasion as the entire programme would be held through videoconferencing. After the formal opening

of international gateway of Internet, Tripura would be the third Indian state which is having such a gateway after Mumbai and Chennai. This will help all the northeastern states of India, he added. Indian Telecom Minister

Ravi Shankar Prasad laid the foundation stone of the project in Agartala on July 13, 2015 that aims at strengthening telecom services in the northeastern states.
