# AL rebels still in race in 35 of 50 Patuakhali unions

Nine expelled in Baufal upazila, others to face the same

Awami League (AL) nominated chairman aspirants are facing 52 rebel candidates in 35 out of 50 unions in all the eight upazilas of the district. The polls will be held on March 22. Upazila AL units have

issued show cause notices to the rebel candidates as per party instruction, but they did not respond.

In Baufal upazila, nine rebel candidates were expelled from the party on Thursday for not withdrawing from the election race.

ASM Feroz, president of Baufal upazila unit of AL and also the chief whip of the Jatiya Sangasd (JS), signed the expulsion orders.

The expellees are Md Jahangir Ullah, joint secretary of the upazila unit, Abdus Sattar Dakua, vicepresident of Adabaria union unit, Abdul Haque Sikder,

member of upazila unit, HM Eusuf, vice-president of Baufal town unit, Mizanur Rahman Hiron, vicepresident of Kanakdia union unit, Shafiqul Islam and Md Ruhul Amin, secretary and health affairs secretary of the unit, Md Hafizur Rahman, vice-president of Kachipara union unit, and Asadul Haque Jewel of the

Motaleb Howlader, secretary of Baufal upazila unit of AL, said they had earlier issued show cause notices to the rebel candidates, but they did not reply. They are contesting the election, disobeying party instructions, he added.

BM Shahjahan Bhuiya, secretary of Sadar upazila unit of AL, said they issued show cause notices to all six rebel candidates on March 8, asking them to reply within three days. No one responded to the show cause notices though the upazila unit over the matter.

There are 12 rebel candidates in eight UPs in Galachipa upazila, 13 in nine UPs in Baufal upazila, nine in five UPs in Sadar upazila, three in three UPs in Dumki upazila, six in four UPs in Dashmina upazila, seven in four UPs in Mirzaganj upazila, and two in two UPs in Rangabali upazila, locals and party sources said.

As many as 241 candidates are taking part in the elections in 50 UPs in the district, Nazmul Kabir, district election officer, said.

Contacted, Khan Altaf Hossain alias Shah Mosharraf Hossain, secretary of Patuakhali district unit of AL, also the administrator of Patuakhali district council, said, "We are taking ing the party decision."

### 2 girls saved from early marriage

Two girls were saved from child marriage in Jessore and Bogra districts on Friday.

A schoolgirl was saved from child marriage at Shakharipota village under Benapole Port Police Station in Jessore

Informed that marriage of eighth grader Suraya khatun, 13, daughter of Alauddin of the village, was arranged Sharsha Upazila Nirbahi Officer (UNO) Abdus Salam rushed to the spot and foiled the marriage, reports our Benapole correspondent.

Matchmaker Shabuddin Biswas, 27, bridegroom Liton Biswas, 24, son of Shahjahan Ali of Dhanyokhola village, and bride's mother Shilpi Begum were arrested from the spot.

The three were produced before a mobile court, led by the UNO, which sentenced Shabuddin and Liton to seven days' imprisonment each and fined Shilpi Tk 1,000.

In Bogra, a mobile court sentenced a man to seven days' imprisonment and fined three others Tk 1000 each for arranging marriage of an underage girl in Nandigram upazila of the district the same day, reports our correspondent.

"They claimed it to be a government khas land and

said the work was being done under "One House One Farm" project. As I asked them not to build the structure, they filed a case against me, alleging creating obstacle to government work. They also stopped taking revenue of the land and harassed me by sending police to my house on several occasions," he said.

"As the government officials continued with building the structure on my land, I filed a case with the Joint District Judge's Court in Tangail. The court first issued a show cause notice to them and later issued a temporary injunction. "But they continued the


construction work violating the court order.

"Recently I contacted with the deputy commissioner in Tangail and as per his direction, I submitted all documents of my land to the UNO on March 3 but I am yet to get any result," the freedom fighter said. Contacted, Madhupur

UNO Romendra Nath Biswas yesterday said, "After getting direction from the deputy commissioner, I have asked the local assistant commissioner of land and the surveyor of the local land office to submit their documents. Meanwhile the freedom fighter submitted some documents to me in favour of his claim."

The issue will be resolved as per law after checking all the documents of both sides, he said.

## Nine burnt in B'baria gas cylinder blast

Nine people, including four children, sustained burn injuries when a gas cylinder exploded at a house at Kuttapara village in Sarail upazila of Brahmanbaria district on Friday night.

The injured, Jorina Begum, 30, Kalu Mia, 28, Sheuly Begum, 25, Eklash Mia, 25, Ibrahim Mia, 18, Saima Begum, 10, Taslima Begum, 10, Abdur Rahman,

admitted to Brahmanbaria children, burnt. District Sadar Hospital.

Rahman, Eklash Mia, Ibrahim Mia and Yasin Miah were referred to the burn unit of Dhaka Medical College Hospital, hospital sources said.

Neighbours said the gas cylinder exploded when Sheuly Begum, wife of Russel Mia, tried to light the burner at around 8:30 pm, and the fire soon engulfed the entire house, leaving 8, and Yasin Mia, 8, were nine people, including four

On information, fire Later, Kalu Miah, Abdur fighters rushed to the spot and doused the fire with the help of locals.

M Kabirul Islam, officer of Brahmanbaria Fire Service Station, said preliminary investigation revealed that the fire was caused from leakage of the gas cylinder.

"We think that the kitchen was already full of gas from the cylinder leak and the explosion occurred when Sheuly lighted the stove," he added.
