Heavy vehicles still using risky bridge in Savar

standing on the loads of the flat bed facing the opposite direction of travel, had his head hit by a concrete bar erected at its end. The bar had a sign that forbids heavy vehicles from using the bridge.

As the man screamed for help, the driver pulled over and then drove to the main road probably to take the injured to the nearest hospital.

The incident happened on March 7, just five days after The Daily Star published a photo of the rickety bridge. Its caption said buses and trucks use the bridge every day, ignoring the warning sign and posing risks.

Apparently, nothing has been done to repair the bridge since this correspondent made an earlier visit to the

warning signs on both sides of the bridge may cause further accidents at night as there was no street light. Contacted, Amir Hossain, secretary

of Bhakurta Union Parishad, said local UP Chairman Anwar Hossain and officials of the LGED upazila office took the initiative for erecting the bars on pillars a couple of years ago.

The move aimed at preventing heavy vehicles, which are also over 12feet long, from using the bridge.

Over the last decade, Tk 1 lakh to 2 lakh has been spent every year to have the bridge repaired, he added.

UP Chairman Anwar Hossain claimed that they do repairs of the in Savar. bridge almost every month.

Although there was no assessment of how unsafe the bridge was, LGED's Sharful Anam Khan, Dhaka's divi-

sional executive engineer, said they had replaced four steel plates with stronger ones and some of the nuts and bolts last month.

The LGED planned to continue its regular repairs of the bridge, he said.

Hundreds of CNG-run autorickshaws, human hauliers, minibuses, pick-ups, motorcycles, cars and trucks use the bridge daily, according to locals. UP Chairman Anwar Hossain said

the shipment from at least 40 brick kilns in Bhakurta union depends entirely on the bridge. The 379-feet bridge connects 27

villages of Bhakurta union, with about 30,000 residents, to the upazila town People from Kolatia, Taranagar,

Hazratpur, and Ruhitpur of Keraniganj are also heavily dependent on it.

The Rapid Action Battalion claims to have arrested five members of banned militant outfit Jama'atul Mujahideen Bangladesh (JMB) in a raid at capital's Demra last night.

The arrestees are Hujaifa Akand alias Shaheen alias Siyam, 25, chief of Mymensingh JMB, and operatives Yasin Ali alias Shafique, 31, Mamunur Rashid, 23, Abul Hashem, 32, and Shafiul Islam Khalid, 30, said a Rab press release.

Rezaul Karim, an assistant director of the Rab-10, said a team of the elite force raided a building in Katherpool area around 9:00pm. They had information that some militants had gathered there to carry out subversive activities.

They arrested five JMB men and recovered bomb-making materials along with books provoking extremism in the drive, he said.

The press release claimed that during primary interrogations, the arrestees admitted to planning to carry out attacks and subversive activities in Dhaka and elsewhere.

The children fled because they were afraid of being beaten up by their teachers, he added.

the meeting, the government formed a seven-member steering committee led by the civil aviation minister to upgrade the security system of the airport to international standards.

The committee will hold a review meeting on March 20.

Civil Aviation and Tourism Minister Rashed Khan Menon led the Bangladesh delegation at the meeting while British High Commissioner in Dhaka Alison Blake led the seven-member UK team.

FOREIGN COMPANY FOR SECURITY MANAGEMENT

About the meeting, Menon said the UK team has handed over a list of short-, mid- and long-term requirements they deem necessary for the restructure of the airport's security system and cargo-complex.

The team also recommended some companies that have security related expertise.

After the meeting, Bangladesh officials held another meeting with UK expert John Lovesy and decided to hire a company, the minister said.

"As an outcome of the meeting with Lovesy, if any international expert visits Bangladesh tomorrow [today], we may sign an agreement for quick implementation of the security requirements," Menon told journalists at his temporary office at the airport yesterday afternoon.

A source said the minister instructed the civil aviation secretary to select British company G 4 as preferred by the UK team and make them a phone call to visit Bangladesh by today and sign an agree-

"We hope we will be able to meet all their requirements within the stipulated time," Menon

Asked about the list of existing problems, the minister mentioned shortage of cargo scanning machines, shortage of skilled manpower, and lack of screeners to operate

the scanning machines. He, however, said the UK admitted that 70 percent of their requirements had been fulfilled.

Menon said as per their suggestion, 15 people have already been trained while another 15 were training.

"We have already hired a trainer as suggested by them. It costs us 400 pounds to train each person, but we are not worried about the money," he added.
