

Body of Ctg Udichi leader found hanging in locked room

The body of Sitakunda upazilla unit president of Udichi Shilpigoshtthi in Chittagong, who had allegedly been missing, was found hanging in a locked room yesterday.

Police broke open the door and recovered the body of Dipok Chandra Dey, 61, from an empty tinshed house of an expatriate in Pucca Masjid area, about 17km off his residence, and sent it to Chittagong Medical College morgue. They also detained Tahera Begum, 48, caretaker of the house.

Dipok took several lakh taka from different people of the Masjid area two to three years ago in the name of an insurance company and stopped visiting the area. When the people came to know that he had not deposited the money with the company, they took him to the room, police quoted Tahera as

SC again stays Tangail-4 by-polls

Permits Kader Siddique to appeal; fixes May 3 for next hearing

The Supreme Court yesterday once again stayed the Tangail-4 by-polls that was scheduled to be held on March 20.

The apex court also permitted Krishak Sramik Janata League President Abdul Kader Siddique to move an appeal before it, challenging a High Court verdict that upheld cancellation of his candidacy for the by-polls.

A five-member bench of the Appellate Division headed by Chief Justice Surendra Kumar Sinha fixed May 3 for hearing the appeal.

The apex court passed the order following a leave-to-appeal petition filed by Kader Siddique challenging the HC verdict.

Kader Siddique's lawyer Raghib Rauf Chowdhury told The Daily Star that the SC might decide the polls to the constituency during the May 3 hearing, as it yesterday did not specifically say how long the stay order would remain effective.

Meanwhile, Election Commission's (EC) lawyer Mohammad Yeasin Khan said the by-polls would remain halted till May 3.

On February 4, the HC upheld the EC's decision that had cancelled the candidacy of Kader Siddique, and directed the EC to proceed with the by-polls in accordance with laws.

On February 29, the EC fixed March 20 for holding the by-election.

The EC on September 16 last year issued a notification fixing November 10 for the by-polls to the constituency that fell vacant following the resignation of Awami League lawmaker Abdul Latif Siddique from parliament, and asked aspirants to submit nomination papers by October 11.

As the returning officer on October 13 cancelled Kader Siddique's nomination on loan default charges, he filed separate appeals, first with the EC and then with the HC.

Rejected by both EC and HC, Kader Siddique on February 25 filed a leave-to-appeal petition with the SC, challenging the HC verdict.

JU students, teachers want measures to end hazing

Hold press conference, put out 13-point demand

Teachers and students of Jahangirnagar University (JU) yesterday protested brutal hazing on the campus, following Sunday night's bullying of a fresher who was hospitalised because of excessive mental torture.

Under the banner of Chhatra Shikhhakh Oikya Mancha, they held a press conference at New Arts Faculty building and demanded a series of deterrent steps.

Their 13-point demand includes taking control of the halls from the ruling party student body, forming anti-hazing cells, quick punishment for the bullies, overnight patrolling at dormitories, stopping the "gono room" and "guest room" culture, and holding election to JU Central Student Union (Jucus).

On Monday, the Mancha formed a human chain protesting the bullying, and met with Vice Chancellor Prof Farzana Islam, who said the authorities had already

taken steps to stop it.

Convener of the Mancha, Prof Nasim Akhtar Hossain of the government and politics department said, "We will not tolerate any injustice to freshers."

On Sunday night, Shariful Islam, a first-year student of chemistry, was bullied so much that his blood pressure shot up and he was admitted to the JU medical centre.

A doctor said he fell sick because of mental torture.

The JU syndicate passed a decision in 2009, terming hazing a serious offence and providing for expulsion of the guilty. At least four students have been expelled on the charge since then.

Meanwhile, the authorities of Mir Mosharraf Hossain Hall has sent a letter to the VC, requesting action against the Bangladesh Chhatra League (BCL) activists who had allegedly assaulted the hall provost and drove him out of a "gono room" on Friday.

Earlier on March 7, a judge of another HC bench expressed unwillingness to hear the petition of Tareque Sayeed.

On April 27, 2014, Narayanganj panel mayor Nazrul Islam and his four associates, and senior lawyer Chandan Sarker and his driver were abducted. Their bodies were later found floating in the Shitalakkhya river.

Selina Islam, wife of victim Nazrul, filed a case with Fatullah police on April 28, 2014, and 11 days later, Bijoy Kumar Paul, a relative of Chandan Sarker, filed another case.

In February this year, Tareque filed the petition with the HC praying to it to scrap the trial proceedings against him in the case filed by Bijoy.

infused fear of exams among children," Dulu said.

He said some guardians send their children to coaching centres in order to get good results, but many

teachers force the students to join coaching classes; otherwise they don't give marks in the exam.

Tania, a mother of a class-V student, said her son was forced to attend coaching classes at his school after regular school hours. "It's a huge burden we are putting on his shoulders in the name of the exam. We want its immediate cancellation," she said.

The forum announced to submit a memorandum to the primary and mass education minister today to press home their demand, and form a human chain in front of the press club on March 25.

She directed the authorities concerned to maintain the records of those who are being provided of shelter or houses so that no one could take undue benefits from the government programmes.

Pointing to some cases of selling materials of the houses built under Ashrayan project in the past and taking possession of such houses by the influential persons, Hasina asked the officials concerned so that such malpractice cannot take place again.

She stressed the need for protecting houses through constructing barracks and forming cooperatives to ensure the living of people there.

About the rehabilitation of slum dwellers in the capital, Hasina said rented flats could be built for those people on its outskirts like Kamrangirchar.
