Stop illegal extraction of white clay in Netrakona: HC STAFF CORRESPONDENT

The High Court has ordered the government to immediately stop unauthorised extraction of white clay from three mouzas of Netrokona.

The court also issued a rule upon the authorities concerned to explain in three weeks why unplanned cutting of hills and hillocks and indiscriminate and unauthorised extraction of white clay in Arapara, Panchkahaniya and

Maizpur mouzas under Durgapur upazila should not be declared illegal.

The HC bench of Justice Syed Muhammad Dastagir Husain and Justice AKM Shahidul Huq came up with the order and rule on Monday after hearing a writ petition filed by Bangladesh Environmental Lawyers Association in November last year.

Re-probe boy killing case against Nur

N'ganj court tells DB

A Narayanganj court yesterday ordered detectives to reinvestigate a case filed against Nur Hossain and his five cohorts for killing a schoolboy 10 years ago.

Additional Senior Judicial Magistrate Ashoke Kumar Dutta passed the order after the victim's father filed a noconfidence petition rejecting the investigation report submitted by police clearing Nur Hossain, also the prime accused in seven-murder, from the charges. The victim's family alleged that Nur and his aides alleg-

edly strangled a fifth-grader Tipu Sultan, calling him out of his Siddhirganj house and dumped the body in the Shitalakkhya River on September 26, 2006 after his father Kazi Akhtaruzzaman refused to pay Tk 5 lakh as extortion. Shakhawat Hossain, the counsel for the family, said

Akhtaruzzaman went to Siddhirganj Police Station to file a case but police refused to record it due to the influence of Nur. When Nur Hossain went into hiding in India, the victim's father filed the murder case against six people, including Nur, with a Narayanganj court in May, 2014, added the counsel.

Other accused are Rafiqul Islam Ratan, Aminul, Rostam Ali, Zakir and Sundar Ali Zaman.

But the counsel said Siddhirganj police submitted the final investigation report without talking to the complainant, Akhtaruzzaman.

After hearing his petition yesterday, the court ordered detectives to reinvestigate the case.

The victim's father told journalists yesterday that the mystery of his son's killing would be unveiled, if police grill Nur, taking him on remand.

Victim's mother Asia Begum broke down in tears on the court premises holding a photograph of her son and demanded justice.

HALL MARK SCAM HC clears way for trying GM

The High Court yesterday cleared the way for the lower court to continue trial proceedings against Hall Mark Group General Manager Tusher Ahmed in nine loan-scam cases.

The bench of Justice M Enayetur Rahim and Justice Amir Hossain rejected a writ petition filed by Tusher seeking a halt to the trial proceedings.

The Anti Corruption Commission on October 7, 2013 pressed changes before the lower court against 25 people for swindling over Tk 2,600 crore out of Sonali Bank. The accused include Hall-Mark Chairman Jasmine

Islam, Managing Director Tanvir Mahmud, Tusher Ahmed, the then managing director of Sonali Bank, Humayun Kabir, and a union parishad chairman in Savar who issued fake trade license to the controversial business group. Yesterday, ACC lawyer Khurshid Alam Khan told The

Daily Star that there is no legal bar for the Senior Special Judge's Court of Dhaka to continue trial proceedings of the cases against the accused following the HC verdict. Tusher's lawyer AKM Fakhrul Islam said his client will

move an appeal before the Appellate Division of the Supreme Court against the HC verdict.
