by the private sector, causing sufferings to people, she observed.

She recalled the initiative of the previous BNP-Jamaat government to abolish the BRTC bus service following the suggestion of a donor agency. "But returning to power, we've taken various measurers to strengthen the BRTC.

"If we leave the sector to private owners, they'll hike fares as per their wish and people will suffer. That's why we've given importance to the railway sector and created a separate ministry for it," the PM told the func-

Hasina said the government has been working hard to improve the waterway communications through capital dredging and maintenancedredging of the country's rivers.

The government has taken steps to

improve the communication network with the neighbouring countries as well, she added.

Referring to the nagging traffic congestion in the capital, she said her previous government, after assuming office in 1996, had taken up various projects to ease traffic jams, but unfortunately those were not continued by the successive government.

Shyama Prosad Adhikari, chief engineer of Local Government Engineering Department, made a presentation on the project, which he said was implemented as part of the Strategic Transport Plan for Dhaka.

LGRD Minister Khandker Mosharraf Hossain, Saudi Ambassador to Bangladesh Abdullah HM Al-Mutairi and LGRD Secretary Abdul Malek also spoke on the occasion.

Home Minister Asaduzzaman Khan, Civil Aviation Minister Rashed Khan Menon, mayors of Dhaka north and south city corporations Annisul Haque and Sayeed Khokon were present. Earlier, the premier opened the first

part of the Moghbazar-Mouchak Flyover. She opened the 2.11 km part of the 8.7 km flyover to traffic through unveiling a plaque. The flyover is being built in three parts -- from Holy Family Hospital to

Tejgaon; Kakrail to Rampura; and Mouchak to Bangla Motor -- in an effort to ease traffic congestion in the city's northern and southern parts.

The project, which was scheduled to be completed by December last year, started in 2013 instead of the original schedule of 2011. The PM laid the inauguration stone of the project on February 16, 2013.

The court granted Fakhrul bail around three hours after he landed in jail.

The BNP leader came out of prison around 6:00pm. His wife Rahat Ara received him at the jail gate.

Talking to reporters at the gate, the new BNP secretary general said he would perform his duty with honesty and sincerity.

He thanked BNP Chairperson Khaleda Zia for giving him the charge of secretary general. Later in the evening, he met Khaleda

and greeted her with a bouquet of flower at her Gulshan residence in the capital.

border to be sealed to keep off intruders

Says Indian home boss PTI, Duliajan, Assam

Indian Home Minister Rajnath Singh has said the NDA government will completely seal the Indo-Bangladesh border within a reasonable timeframe to stop illegal immigration from Bangladesh, even as he accused Congress of having failed to check intrusion.

Addressing a series of election rallies in Assam, he also took a dig at Congress Vice-President Rahul Gandhi for accusing the BJP of fomenting riots in Assam and said it was during the Congress rule that maximum number of riots took place, be it the Nellie killings in Assam in 1983 or the anti-Sikh riots in Delhi in 1984.

"The Congress-led governments ignored illegal immigration for years and they did not take any effective step against it. We need a state government in Assam which cooperates with us in curbing illegal immigration. Assam has only 263km of border with Bangladesh. It will be sealed with the active cooperation of the state government," he said.

"Intruders have been continuously entering India since the day Bangladesh was created. Intruders are coming to India through the Indo-Bangladesh border. What is the reason, why didn't you [Congress] stop them? Why didn't you completely seal the Indo-Bangladesh border?" he asked at an election rally in Duliajan.

"We just need some time and we will seal Indo-Bangladesh border completely so that no Bangladeshi intruder can come in," he said.

MOVE TO RAISE MPS' PAY

JS body wants PM, Speaker to step in

A parliamentary body yesterday sought the intervention of the prime minister and the Speaker to increase lawmakers' remuneration and allowances to a "logical level", considering their status and expenditure. In January, the parliamentary

standing committee on law sent back a bill titled "Members of Parliament (Remuneration and Allowances) (Amendment) Bill-2016" to the cabinet division, saying lawmakers' remuneration and allowances should be hiked.

But the cabinet division has not yet made any move in this regard, a member of the committee who was present in yesterday's meeting at the Sangsad Bhaban, told The Daily Star.

Briefing reporters at the JS Media Centre, Suranjit Sengupta, chief of the committee, said they decided to talk to Prime Minister Sheikh Hasina and Speaker Shirin Sharmin Chaudhury to realise the lawmakers' demand for increasing their remuneration and allowances.

Suranjit, also a ruling Awami League lawmaker, however, did not Indo-Bangladesh elaborate on the issue.

Meeting sources told The Daily Star that the committee assigned Chief Whip ASM Feroz to coordinate the process of solving the problem.

In yesterday's meeting, the JS body finalised four bills aimed at doubling the remuneration and privileges for president, prime minister, Speaker and deputy Speaker, ministers, state ministers and deputy ministers, Suranjit In January, besides placing those four

bills, Agriculture Minister Matia Chowdhury, who is in charge of the cabinet division on parliamentary affairs, placed the Members of Parliament (Remuneration and Allowances) (Amendment) Bill-2016 in parliament, proposing almost doubling the remuneration and privileges for the MPs. Meeting sources said according to

the proposed bill, an MP would get around Tk 1.20 lakh per month as remuneration and allowances.

Talking to this correspondent, Chief Whip Feroz said an MP usually spends over Tk 15,000 to 20,000 per day on various purposes, including hospitality and giving donations to people in their constituencies.

inaugurated the flyover by unveiling an inaugural plaque at the Saat Rasta intersection and later spoke as the chief guest at an inaugural ceremony at the Officers' Club. It was she who had inaugurated construction of the flyover in February 2013.

Talking to The Daily Star, Tofail Ahmed, an eminent local government expert, said the incidents of irregularities in the first phase reflected the deterioration of the electoral system in Bangladesh.

"It cannot be changed overnight...So, I think there will be no change in terms of irregularities in the second phase," he said.

Elections to around 621 UPs will be held on April 23 in the third phase and 743 UPs on May 7 in the fourth phase. Some 1,400 more UPs will go to the polls in two other phases till June.
