# Double wings in 5 ministries

According to the PMO orders, two divisions -- Public Security Division and Internal Security Services Division -- will be created at the home ministry. And the education ministry will have three divisions -- one for primary to higher secondary education, one for technical and madrasa education and another for higher education.

Education Minister Nurul Islam Nahid confirmed to The Daily Star that they received an order from the

Sources at the ministry said they have already sent to the PMO the ministry's observations on the order.

Abdus Sobhan Sikder, former secretary at the PMO, told The Daily Star, "This move will not only speed up the pace of work of the civil administration but also help accommodate a big number of officials at different ministries."

Once the divisions start functioning, it would be possible for the ministries to make decisions promptly, which would ultimately benefit people, he

"Every big ministry should have divisions for accelerating the pace of work," added Sobhan.

against 830 posts, 908 joint secretaries against 350 posts and 416 additional secretaries against 120 posts in different ministries, said sources at the public administration ministry. Besides, there are around 250 offi-

divisions if a ministry gives the responsibility for implementing decisions to its departments concerned," he told The Daily Star. The PMO order to the home min-

istry specified the areas of operation of the two divisions under the minis-

Police, Border Guard Bangladesh, Ansar and Village Defence Party, Coast Guard and the International Crimes Tribunal would operate under the Public Security Division.

Department of Immigration and Passports, Jail Department, Fire Services and Civil Defence, Department of Narcotics Control, and National Telecommunications and Monitoring Centre would function under the Internal Security Services Division, said the order.

The two divisions would be headed by two secretaries.

Talking to this correspondent recently, Home Minister Asaduzzaman Khan Kamal said, "The creation of the divisions would accelerate the pace of work of the ministry. The prime minister thinks this is a big ministry and it has a huge workload. So, she gave this order."

On the issue, former IGP Nurul Huda said if a new division is formed, it would help speed up the ministry's pace of work.

"The effectiveness of a new division could be evaluated only after it becomes functional," he said.

However, a top official at the police headquarters said the way the divisions are being formed, it appears that there would be basically no change at the

home ministry.

In her first public comments on the case, Perera, a struggling businesswoman who heads Shalika, told Reuters she expected \$20 million to come from the Japan International Cooperation Agency (JICA) to help fund a power plant and other projects in Sri Lanka. She said she had no direct dealing with JICA, but the deal was arranged by an acquaintance who she met in Sri Lanka but had connections

in Japan. Shalika was set up in October 2014 and says in its registration documents that it constructs low-cost houses and provides other social services.

Reuters was unable to independently confirm Perera's account or to reach the acquaintance she named, via the email and phone numbers she provided.

JICA, a Japanese government agency that provides official development assistance, said it has no ties with Shalika Foundation, including

through any intermediaries. "We have had no exchange with them, and that includes such areas as loans and grants," JICA spokesman

In early February, Perera said her acquaintance, who had been helping rapper.com. her for more than a year to meet investors, told her to expect \$20 million from JICA. Under their agreement, the payment would be split, between her power plant project and a housing project controlled by her acquaintance, she said.

investigation report seen by Reuters last week, Perera told her bank, a Colombo branch of Pan Asia Bank that the company expected to receive \$20

million from a Japanese fund. A Pan Asia Bank official declined to comment, citing the investigation.

Perera said she had not seen the magistrate's court last week. According to the report, bank officials said Perera left instructions with them to transfer \$7.72 million to her own personal account and \$11.12 million to an Police have questioned Perera's account controlled by her acquaintance once the transaction had cleared.

Perera confirmed she had given the instructions to the bank, and said they reflected the money earmarked for the two projects and commissions. The rest was to be used for taxes, she said.

The money was remitted by the Pan Asia Bank to Shalika Foundation's account on February 4, but the bank refused to release the funds as the amount was unusually large and sought further verification, according to last week's police report.

On February 9, Perera was told by her bank that the Bangladesh central bank had asked for the transaction to be reversed, according to the report. CID, BB TEAMS TO VISIT

### PHILIPPINES

The Bangladeshi authorities will visit the Philippines in the coming days as part of their government's probe into the \$81 million funds stolen from the Bangladesh central bank's account. Bangladesh Ambassador to the

Philippines Major General John Gomes said members of the Criminal Investigation Department (CID) are due to coordinate with Philippine authorities on the money-laundering case, reports Filipino news portal "Officials of the CID will coordi-

nate with the BSP [Bangko Sentral ng Pilipinas]. They will start their own investigation on how the money entered the country and who are the people involved," Gomes said.

The Bangladesh envoy made the According to a Sri Lankan police statement after he witnessed the turn-

over of \$4.63 million by casino junket agent Kam Sin "Kim" Wong to the Anti-Money Laundering Council (AMLC) office at the BSP headquarters

in Manila on March 31. Gomes added that officials of Bangladesh Bank are also scheduled to arrive tomorrow.

He said the CID members will head to the AMLC office on Monday and attend the fourth hearing of the Senate Blue Ribbon committee on April 5.

"We are hopeful that the entire amount will be recovered. The return of \$4.63 million from Wong is a step in the right direction," he said, adding that the Bangladesh government would pursue the \$17 million left with Philrem Services Corporation owned by the Bautista family as alleged by Wong.

### Gas blast rocks Paris apartment

A massive gas explosion destroyed the top floors and roof of a residential building in central Paris yesterday, injuring 17 people, rescuers and police said.

The blast near the Jardin de Luxembourg park caused jitters in the French capital, which remains on edge after the Paris attacks in November and the Brussels bombings last month. It was traced to a fire that caused a gas

stove to blow up, sending a thick cloud of smoke into the sky, police said. "People were scared, they thought it

was a bomb," an employee of the nearby Ferrandi culinary institute told AFP. The force of the blast blew out some

of the windows at the prestigious school, a witness said. A fireman was seriously injured in

the blast and another 16 people were also hurt, including 10 firefighters. "I was at home, the windows shook in my building two streets away... We thought it was an attack," said local resi-

dent Sylvie Guillaumin, 51, adding that

these polluting factories within the last deadline, the government yesterday deployed police to prevent raw hide supply to the Hazaribagh tanneries.

Visiting the Savar estate yesterday, this correspondent found that none of the factories has been fully constructed.

Some factory owners have not even completed the piling works for construction. Some others are still setting up hide processing drums and other equipment, which means they will need a month or two more to be ready for operation. Though the CETP has been con-

nected to the industrial units there through pipelines, the plant itself is yet to be ready for waste treatment.

Also, the factories have not yet got gas and water connections. "I applied for the connections two

months ago. But I have not yet got it," said Md Akhtaruzzaman, owner of Ahsan Habib and Brothers.

He was supervising the construction work of his two-storey factory building at ZE-4 plot on the site. "Though I have made significant

progress in the construction, I will need about a couple of months more to relocate my tannery from Hazaribagh," said Akhtaruzzaman. Bangladesh Small and Cottage Industries Corporation (BSCIC), the

government agency that is implementing the tannery estate project, has approved the lay-out plan of 152 industrial units out of the 155 in the Savar site. Of them, construction of 148 units has started, ministry sources said. CETP NOT READY

release thousands of litres of untreated and toxic liquid waste into the Buriganga river every day, posing a serious risk to human and animal health and diminishing the prospects of leather exports. Considering the health and envi-

ronmental hazards, the government in 2003 took up a project to relocate the tanneries to Savar. The tannery estate there was first

scheduled to be completed by

December 2005. The deadline was then extended several times over the years. Thirteen years have gone by but the infrastructural development is yet to

The government plans to initially set up two of the four units of the CETP. Ninety percent work of the two units has been completed but the installation process has been stalled for the last one and a half months and the pipeline network has not been completed either.

"We could not make much progress in construction of the CETP as the Chinese contractor firm did not pro-

vide us proper machineries," Prof Delowar Hossain, designer and consultant of the CETP installation, told The Daily Star yesterday.

"The Chinese company was supposed to provide us stainless steelmade water pumps for carrying waste water. But they were providing us normal pumps. We did not accept those."

The BSCIC would sit with the Chinese firm tomorrow to resolve the issue, said the professor of Bangladesh University of Engineering and Technology.

Once in full operation, the two CETP units would be able to treat 13,000 cubic meters of waste a day.

## BNP losing interest

hopefuls wanted to run for the polls. According to some leaders, the BNP might announce within two to three days that it would not contest the UP polls.

"We've assessed that contesting the local body polls have so far failed to bring any benefit for our party. So why should we take part in the polls to legitimise it?" questioned Emran Saleh Prince, assistant publicity secretary of BNP.

"Our candidates won in some unions, but the losers became disappointed with vote rigging. The ruling Awami League men have been harassing BNP leaders and activists over the polls which would have a negative impact on the party in future elections," added Prince, also a member of the BNP's election monitoring cell.

Meanwhile, leaders of Jatiya Samajtantrik Dal (Ambia-Prodhan), Communist Party of Bangladesh and Workers Party of Bangladesh also said they will discuss electoral violence and irregularities within their parties to decide their next course of action on the UP polls.

AL Joint General Secretary Mahbubul Alam Hanif on Thursday said the second phase of the polls cannot be termed faulty as irregularities took place in only 22 poling stations out of over 6,000.

A total of 19 people were killed and over 200 injured in polls violence dur-

ing the elections to 1,354 unions in the first two phases on March 22 and 31.

Talking to The Daily Star, some BNP leaders said most of the grassroots leaders told the central leaders that they were not interested in contesting the upcoming UP polls as there were "gross irregularities and violence" in the previous elections. Many districtlevel leaders have conveyed similar

opinion to the BNP high ups. Prince said media outlets only report on the polling day's violence, but they are "not aware" of the obstacles created by AL men during electioneering.

Talking to this correspondent, Sharif Nurul Ambia, president of a faction of JSD, said they will hold a meeting soon to make a decision on contesting the UP polls.

Fazle Hossain Badsha, general secretary of Workers Party, a component of the AL-led 14-party grand alliance, said they sought an appointment tomorrow with Chief Election Commissioner Kazi Rakibuddin Ahmad.

"We want to know what actions the Election Commission will take to stop irregularities in the upcoming polls, he added. Elections to 621 unions are slated

for April 23 in the third phase. A total of 743 unions will go to polls on May 7 in the fourth phase and around 1,400 more in two other phases till June.
