Sir Abed gets award from Michigan University

Sir Fazle Hasan Abed, founder and chairperson of Brac, has received the Thomas Francis Jr Medal in Global Public Health award from the



University of Michigan.

Mark Schlissel, president of the university, presented the medal to the development activist at a ceremony at the Ross School of Business on Wednesday, a Brac statement said.

Sir Abed was recognised for his work to ensure a healthier future for people living in poverty worldwide.

The medal, periodically awarded to a global leader whose work addresses the most pressing global health challenges, honours the legacy of the University of Michigan epidemiologist who mentored Dr Jonas Salk in his development of the polio vaccine.

"It is indeed a great honour to receive the Thomas Francis Jr Medal in Global Public Health," said Sir Abed at the award ceremony.

"It gives me tremendous pleasure and I thank the University of Michigan for bestowing this prestigious award on me," he added.

projects like the BRT and Metro Rail, the Bridges Division has suddenly come up with a rather ambitious project to construct four subways. The initial cost of two of them has been set at over \$8.1 billion.

The subway project is not even on the list of next 20 years' revised strategic transport plan.

An official of the road transport ministry said all these projects were taken up without proper study. As a result, they get little or no attention, causing delay in their implementa-

The Bus Rapid Transit (BRT) line-3, part of the Greater Dhaka Sustainable Urban Transport Project, will be jointly funded by the government, the Asian Development Bank, the French Agency for Development (AFD) and the Global Environment Facility.

facilitate movement of 40,000 people between Hazrat Shahjalal International Airport in Dhaka and Gazipur every hour.

Once in operation, the route will

The design and the operation plan were finalised in December last vear.

Ten international companies -mostly from China, Korea and India -- submitted bids for the construction job. The documents were sent to the ADB headquarters in Manila, the capital of the Philippines, for evaluating the companies' eligibility.

The authorities in Dhaka expect to get back the documents with suggestions within two weeks, new Project Director AQM Ekram Ullah said on Wednesday.

"Once we get them [the documents], we will open the financial offers of the bidders," he said.

They will then select an eligible bidder and send the proposal to the cabinet committee on purchase for approval. The process is likely to take a couple of weeks from now.

Once the purchase committee approves the proposal, a work order will be issued to the lowest bidder.

It depends on the ADB and the

purchase committee as to when the construction work will begin, said Afil Uddin, the immediate past project director. "We hope we will be able to start the construction in June."

But the new project chief said that it might not be possible, but that they would begin it "as early as possible".

The project work was supposed to begin in December 2014 and end this year. The revised deadline is

The BRT project will have six flyovers, four and a half kilometres of elevated road, 141 connecting roads, 12km drains, and a new 12lane bridge in Tongi. The flyovers will be built at the airport crossing, Uttara Jasimuddin Road, Kunia, Board Bazar, Vogra, and Chourasta in Gazipur.

Under the plan, the Dhaka Bus Rapid Transit Company Limited, a government entity, will operate 120 articulated buses on the route. The buses will run between the stops every 30 seconds.

The BRT project is expected to improve connectivity between Dhaka and Gazipur and cut down travel time by at least half. There will be direct buses apart from those that will connect all the points between Dhaka and Gazipur. Depending on the services, the travel time will be 40 minutes to an hour, which now takes at least two hours by public transport.

The second phase of the BRT line-3 will stretch from the airport to Jhilmil in Keraniganj. The World Bank has already financed the designing of the proposed 22km stretch.

"The design has already been completed. Now a discussion is going on with the global lender on the funding of the project," said an official of the project.

The government also plans to introduce such fast bus lanes in Manikganj, Gazipur, Narayanganj, Munshiganj and Narsingdi as per the by the cabinet last month.

Downing Street staffers initially said that it was a "private matter" whether or not Cameron had benefited from the fund. It later issued a series of statements denying the prime minister currently benefited from offshore funds, or stood to do so in the future. Though, despite the clarifications, a number of questions still remained.

Labour has condemned the way information about Cameron's financial affairs was revealed with "drip, drip" statements, and the revelations will raise questions about why Cameron did not admit to personally profiting until five days after the Panama Papers were leaked.

But in an interview with ITV News, he insisted that it was a "fundamental misconception" that Blairmore Holdings, set up by his father Ian Cameron the 1980s and run from the Bahamas, was set up to avoid tax. He said his father was being "unfairly written about".

He said that his and Samantha Cameron's profit from the scheme was "subject to all the UK taxes in the normal ways".

Number 10 said Mr and Mrs Cameron bought their holding in April 1997 for £12,497 and sold it in January 2010 for £31,500.
